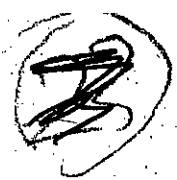



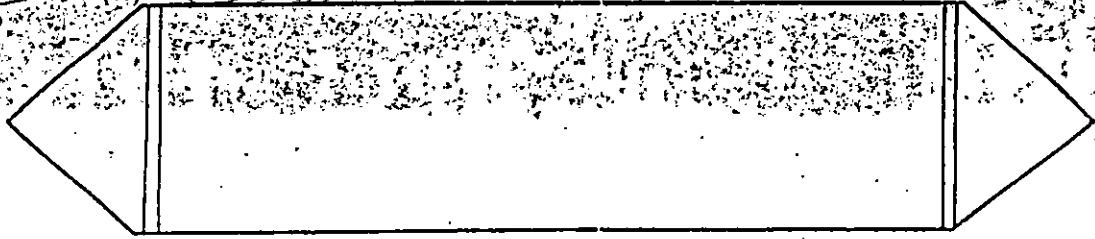

2. That the said contract was extended from time to time. Meanwhile the Government of Khyber Pakhtunkhwa erstwhile NWFP promulgated NWFP Civil Servants (Amendment) Act, 2005. In pursuance of the aforesaid Act, I have been regularized with effect from 23-07-2005.
4. That the Government of Khyber Pakhtunkhwa again amended the section 19 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 vide Khyber Pakhtunkhwa Civil Servants (Amendment) Act, 2013.
5. That after the promulgation of the aforesaid Act, I was under legitimate expectancy that my revised regularization order will be issued with effect from initial date of appointment but in vain, hence I along with other colleagues filed a Writ Petition No 3960-P/2014, 2107-P, 1184-P/2015, 1345-P & 2005-P/2015. In pursuance of which my services are regularized with effect from 01-07-2001 instead of initial date of appointment.

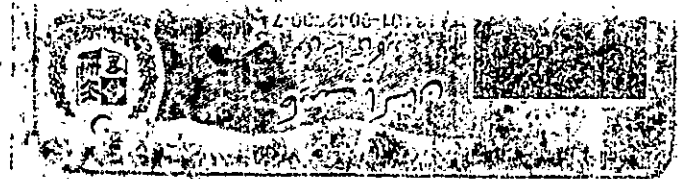

PARAWISE COMMENTS ON BEHALF OF RESPONDENTS

Preliminary Objections:-

1. That the appellant has neither got cause of action nor locus standi.
2. That the appellant has filed the instant appeal just to pressurize the respondents.
3. That the instant appeal is against the prevailing Law and Rules.
4. That the appeal is not maintainable in the present form and also in the present circumstances of the issue.
5. That the appellant has not filed the appeal in proper form and may be dismissed.
6. That the appellant has not come to the Tribunal with clean hands.
7. That the appeal is time barred.
8. That the Honorable Tribunal has no Jurisdiction to adjudicate the matter.

ON FACTS:

1. Correct to the extent that the appellant was appointed as MO BPS-17 on contract basis w.e.f. 27/11/1995.
2. Correct to the extent that the contract appointment of the appellant was extended time to time. Meanwhile the Khyber Pakhtunkhwa Civil Servant (Amended) Act. 2005, came into force. Under the said Act those contract employees were entitled to be regularized who were appointed on or after 01/07/2001.
3. Incorrect, according to Khyber Pakhtunkhwa Civil Servant (Amendment) Act 2005 those contract employees were eligible to be regularized who were appointed during the period from 01/07/2001 till 23/07/2005 while the petitioner was appointed w.e.f. 27/11/1995.

4. Incorrect. The petitioner was appointed on contract basis w.e.f. 25/11/1995 and his service was not falling in the ambit of Khyber Pakhtunkhwa Civil Servant^{Act} 2005.
5. Pertains to record, however the service of the appellant and his colleagues were regularized w.e.f. 23/07/2005 from the date of commencement of the aforesaid Act. The services of Dr. Muhammad Iqbal were regularized from the date of his contractual appointment i.e. 08/07/1998 by the competent authority.
6. In pursuance of Judgment of Peshawar High Court, Peshawar dated 18/11/2008 in Writ Petition No. 1510 of 2007 read with sub section 2 of Khyber Pakhtunkhwa Civil Servant (Amendment) Act 2005 (Khyber Pakhtunkhwa Act NO. IX of 2005) and provision under sub section 4 of section 19 of Khyber Pakhtunkhwa Civil Servant (Amendment) Act 2013 the services of the appellant and his colleagues have been regularized w.e.f. 01/07/2001. The said Act does not allow to regularize the services of the appellant from the date of his contractual appointment i.e. 27/11/1995.
7. Incorrect. The Khyber Pakhtunkhwa Civil Servant (Amendment) Act 2013 does not allow to regularize the service of the appellant and his colleagues from their date of contractual appointment in 1995.
8. Revised regularization of services orders of the petitioner under Khyber Pakhtunkhwa Civil Servant (Amendment) Act 2013 has already been issued w.e.f. 01/07/2001.
9. Incorrect. Vide Judgment dated 20/12/2016, Peshawar High Court, Peshawar has directed to constitute a committee in light of Clauses-5 of Act (ibid). The petitioners were directed to file their Departmental appeal before the said committee to dispose-of the same within one month. In the said Judgment, the Honorable Court has not directed to regularize their service from the dates of contractual appointment.
10. The Departmental appeals have already been sent to the competent authority.

GROUNDS:


- a. The Notification dated 17/10/2017, where under the service of the appellant has been regularized w.e.f. 01/07/2001 is legal and issued by the lawful authority.


- b. The treatment met to the appellant is not against the fundamental rights.
- c. Both the civil servants (Amendment) Act 2005 and Khyber Pakhtunkhwa Civil Servant (Amendment) Act 2013 do not allow the respondents to regularize the service of the appellant from 1st date of contractual appointment i.e. 27/11/1995.
- d. In pursuance of Khyber Pakhtunkhwa Civil Servant (Amendment) Act 2013 the services of the appellant has been regularized w.e.f. 01/07/2001 through revised Notification dated 17/10/2017.
- e. Under Section 2(2) of Khyber Pakhtunkhwa Civil Servant (Amendment) Act 2013 the appellant is entitled to regularization w.e.f. 01/07/2001.
- f. Correct.
- g. The appellant has been treated according to Court order and relevant Act.
- h. No discrimination has been done, the appellant has been treated according to law.
- i. The treatment met to the appellant is according to the Principles of Natural Justice and settled Principles of Administrative law.
- j. Needs no comments.


PRAYER:


Keeping in view of the above, it is prayed that the appeal may kindly be dismissed with cost.






