In the circumstances, where a fresh seniority list stands issued, the appellant may apply departmentally for benefits, if any, accruing to him on the strength of the list. The outcome of his proposed departmental representation would set the course and directions for future proceedings against the respondents including redressal of appellant before this Tribunal, if need be.</p> 

3. Learned District Attorney does not controvert the proposition or the seniority list submitted today.

4. The appeal is, therefore, disposed of in terms of averments made on behalf of the appellant.

Parties are left to bear their respective costs. File be consigned to the record room.



With great veneration, the instant appeal is preferred by the appellant on the following facts and grounds.

Facts:-

- 1:- That the appellant In (seniority list dated 31-12-2013 20-06-2014 from serial no 167 & 140 respectively.
- 2:-That the appellant were also confirmed in the same respective year is mentioned in the seniority list , which stood on 17-02-2010.
- 3:-That when the list "E" was prepared for the purpose of promotion the appellant no 126 were placed junior then others PASI's who were confirmed letter in time from the appellant .
- 4:-That the appellant felling aggrieved from the seniority list stood on 31-12-2013- & 27-06-2014 & 07-01-2015 and appellant also filed departmental appeal but the appellant were not redressed finding no alternative ,this appeal is filed on the following grounds.

GROUND:-

- A:- That the impugned seniority/ promotion list dated 31-12-2013, 27-06-2014 and 07-01-2015 is against the settled law of service promotion and rules(Copy of impugned seniority list is annexed as annexure A)
- B:- That the seniority counted from the date of confirmation and all the appellant were confirmed in the year 2010-while the other PASI's were confirmed in the year of 2011.
- C:-That for the purpose of promotion inter se seniority of ASI will be prepared from their date of confirmation not from their length of service in police department .
- D:-That although all the other juniors PASI's who placed senior then the appellant in the seniority list their service length may be greater then the appellant ,but they were confirmed letter in time from the appellant as ASI.
- E:-That the appellant are wrongly placed in list "E" for the purpose of promotion .
- F:-That no proper procedure and service rules are follow by the police department as well as departmental promotion committee nor in the promotion of Sub- inspector.
- G:-That in the identical situation in other districts like Abbottabad , Bannu etc, the seniority are prepared from the date of confirmation not from their length of service .
- H:-That the appellant filed the departmental appeal along with judgment of writ petition no 875-P/2014 in which the hon,able Majesty has directed to respondent No-1 to dispose of representation of the petitioners expeditiously, but no relief are given to the appellant till date, finding no alternative appellant approached this hon,able service tribunal.(Copy of writ, judgment is annexed as annexure B)
- I:- That during the representation the respondent No-2 has issued a impugned promotion list which is the violation of service rules (copy of impugned list of respondent No 2 dated 07-01-2015 is annexed as annexure C)
- J:-That according to rules 49% of the posts in the rank of ASI's will be PASI's and 51% will be ranker. Distribution will be made according to the allotted quota.

K:-The ASI's which were promoted as Offg: ASI's on the post of PASI's their seniority should be counted from the date on which they were adjusted on their on vacant posts and confirmation may also be made from the date on which they were adjusted as Offg: ASI's on their own vacant post i.e post of ranker according to distribution of posts rules.

L:-That according to police rules a officer which has been promoted as officiating sub inspector SI after the completion of two years officiating period he must confirmed in the rank of SI and will be brought on list F:- but if he is not full filling the criteria for conformation and promotions to next step he must be reverted to substitutive rank of ASI.

M:-That in Kohat Region ,PASIs recruited from 2007 to 2010 have been confirmed from their date of appointment and they have placed in the bottom of seniority list below the rankers confirmed in 2011 .In other regions PASI's were declared senior then ranker in such like matter and they have been promoted as S I's(annexure as annexed D)

N:- That the impugned seniority lists has been prepared on the formula of pick and chose, and the respondent has given false consolation by the office of the respondent No-1 to 3 that soon another DPC meeting is going to be held and the name of appellant shall be consider for promotion on the basis of confirmation till now it transpired to appellant that they have been given false consolation .

O:- That the impugned Seniority Lists and order dated is continuous breach of petitioners right not warranted by law.

That some other grounds may be adduced during the course of arguments with the kind permission of hon,able tribunal.

Prayer:-

On accepting of this appeal , the respondent 1 to 3 are directed to correct the seniority list and the appellant may be placed senior then the other junior promoted PASI's as well as promotion system of Kohat region may kindly be regularized with rules like other region of Khyber PakhtoonKhawa for the end of justice.

Subject: Guidance/Fixation of seniority of PASIs

Memo:

Kindly refer to your letter No. 8514/E dated 18.12.2012 on the above subject.

The present rules are clear regarding confirmation and the basic principle is that anyone appointed or promoted shall be confirmed from the date of his/her appointment or promotion after completion of probation period. Confirmation after termination of probation period will take effect from the date of initial appointment or from the date of regular promotion to that post. After completion of probation period, the authority will confirm, revert or dismiss the civil servant. If the authority failed to revert or dismiss the civil servant, he/she shall be deemed to have been confirmed from the date of his/her appointment or date of his/her regular promotion. These general rules are to be followed irrespective of the fact whether or not anyone loses or gains seniority.

This is one of the reasons that majority of the SIs when not confirmed were never reverted as required by law with the result that posts were kept occupied by those not eligible to occupy such posts.

- 2:-That Para No 2 of Fact is incorrect on the basis that except present appellant rest of the appellant are appointed in the year of 2009 to-2010 .So the question of issuing of due seniority list is based on presumption and mis interpreting the version of the appellant .
- 3:-That Para No-3 of the Fact is correct as discussed above in Para No-1 hence need no comments but rest of the Para denied no proper revised seniority list has ever been issued nor implemented by the respondent..

4:- That Para No-4 of the Fact is correct to the extent that appellant has filed departmental appeal before the respondent in which no earlier decision announced but rest of the Para is denied because the said seniority list issued in violation of guideline of PPO also discussed in Para 1.

Reply to reply of grounds:-

1:-That the Para No-A of the grounds is correct to the extent that fresh seniority list has been issued but rest of the para denied because the respondent above have not prepared the list under the guideline duly issued from PPO office ,but the respondent still violating the rules for the purpose of promotion of the appellant .

2:- That Para No- B,C,D,E,F,G of the grounds of comments is incorrect already discussed above in the leading Para's of facts hence need no deliberation.

3:-That Para No-H of the grounds is correct to the extent that Apex Court Judgment regarding the promotion on the basis of confirmation .Rest of the Para is denied.

The respondents may also be allowed to advance additional ground at the time of hearing of appeal.



Kindly refer to your letter No. E514/E dated 18.12.2012 on the above subject.

The provision rules are clear regarding confirmation and the basic principle is that anyone appointed or promoted shall be confirmed from the date of his/her appointment or promotion after completion of probation period. Confirmation after termination of probation period will take effect from the date of initial appointment or from the date of regular promotion to that post. After completion of probation period, the authority will confirm, revert or dismiss the civil servant. If the authority failed to revert or dismiss the civil servant, he/she shall be deemed to have been confirmed from the date of his/her appointment or date of his/her regular promotion. These general rules are to be followed irrespective of the fact whether or not anyone loses or gains seniority.

This is one of the reasons that majority of the SIs when not confirmed were never reverted as required by law with the result that posts were kept occupied by those not eligible to occupy such posts.
