APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED SENIORITY LIST CIRCULATED ON 01.01.2019 WHEREBY THE CADRES OF HEAD MASTERS AND SUBJECT SPECIALISTS HAVE BEEN MERGED AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS

PRAYER:

That on acceptance of this appeal the respondents may kindly be directed to separate joint seniority list circulated dated 01.01.2019 for the cadres of subject specialist and Head Masters as both are two different and distinct cadres and may further directed the respondents to make separate rules/ Service Structure and promotion ladder including Job Description for Subject Specialists. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R.SHEWETH:

FACTS:

1. That the appellant is Head Master (BPS-17) having qualifying pensionary service with impeccable service record.
2. That the post of Head master exists in the respondent department since British Rule in Hindustan. That the post of Subject Specialist was created in 1987, on the introduction of higher secondary Schools

in the Province without service structure, both these cadres were merged unlawfully in 1992 without any policy or gazetted Notification of the Government. Copy of the letter dated 10.12.2010, notification dated 22.5.1988 and letter dated 20.4.2014 are attached as annexure **A, B and C.**

3. That the respondent#2 issued two notifications on different occasions viz i) Notification No. SO (S)7-34/91 dated 9.05.1994 along with all amendments/alterations thereto till date; and ii) notification No. SOG/S&LD/1-28/2003/Vol-II dated 9.04.2004. Copies whereof are annexed herewith marked **D & E.**
4. That on the basis merging of two different cadres the respondents issued joint seniority list for the cadres of head masters and subject specialists. That some of the senior colleagues of the appellant challenged the same before this august Tribunal in appeal Nos.1411/2011, 1412/2011 and 1413/2011 and as such the said appeals are still pending adjudication before this august Tribunal. Copy of the memo of appeal is attached as annexure **F.**
5. That recently the respondents circulated/issued Seniority List dated 1.1.2019 whereby the seniority of Head Masters and those of Subject Specialists, two distinct cadres for all intents and purposes, was again prepared jointly unlawfully, illegally, without lawful authority/jurisdiction, sans notice, circulation not giving opportunity of hearing and participation to the Head Masters. Copy of seniority list is annexed herewith marked **G.**
6. That appellant feeling aggrieved from the impugned seniority list dated 1.1.2019 filed Departmental appeal before the appellate authority but the same is un-responded till date. Hence the present appeal on the following grounds amongst the others. Copy of the Departmental appeal is attached as annexure **H.**

GROUND:

- A- That the impugned joint seniority list dated 1.1.2019 issued by the respondents is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B- That the entire process of preparing, so-called updating and finalizing the impugned seniority list dated 1.1.2019, as seriously questioned herein, has not been done in accordance with law. It may be seen

that the merging of two distinct cadres is illogical, incorrect, misleading and incompatible with realities.

- C- That it is incumbent upon the respondents to have made rules, separate Service Structure and promotion Ladder including Job Description for Subject Specialists because it is a cadre different from those of Head masters.
- D- That the appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents are clearly violating Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- E- That a new phenomenon having officiously crept through a manipulated notification# SOG/S&LD/1-28/2003/Vol-II dated 09.04.2004 (even not notified in Official Gazette as yet) by insertion of an entry # 1.3 under 1.Teaching Cadre Men's Section (Principals/Vice Principles etc), in column#2 thereof, to the extent of Senior Subject Specialist' and 'and other equivalent posts in the Teaching Cadre' and corresponding entry in column#5, to the extent of "Subject Specialists", would be non-existent, vague, discriminatory, illegal, uncalled for, and bad in law for depriving the rightful-holders in order to accommodate 'blue eyed ones'.
- F- That the so called joint seniority of 'Subject Specialist' and 'Head Master' is illegal and illogical as both are two different and distinct cadres.
- G- That the joint seniority list is against the Civil servant Act, 1973 read with Appointment, promotion and transfer rules, 1989, therefore not tenable and liable to be set aside.
- H- That the joint seniority list dated 1.1.2019 is against Article 38 (e) of the Constitution of Pakistan, 1973.
- I- That the joint seniority list issued on 1.1.2019 contain 3385 subject specialists and Head Masters in which only 600 from cadre of head master and the remaining are subject specialist, thus has the ratio of 1:6 approximately, therefore the cadre of head master has lesser chance of promotion as compare to the young Subject specialist.

J- That the act of the respondents is discriminatory in nature, therefore the same is not tenable and liable to be set aside.

K- That the respondents acted in arbitrary and malafide manner while issuing the impugned joint seniority list dated 1.1.2019.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

APPEAL FOR SEPARATION OF JOINT SENIORITY LIST OF HMs & SSs
AND UPGRADATION OF HMs TO BPS-18.

Memo

Reference your letter no SO(S) /E&SED/4/26/2010/Seniorty list dated 19/10/2010.

I am directed to submit the following comments and suggestions in response to your above cited letter.

COMMENTS

1. The Head Master (HM) cadre already exists since 1947 but the Subject Specialist (SS) cadre was introduced in 1985 on the establishment of Higher Secondary Schools in Khyber Pakhtunkhwa Province just to lessen the burden on colleges for admission to 1st year and 2nd year classes. (Annex-A).
2. HM cadre has proper Service Rules/Structure since its inception, whereas there was want for proper rules regarding SS recruitment/etc till 1994.
3. Service Rules 1994 describes guidelines:

- a. For HMs para-4 (Page-4)
- b. For SSs para-5 (Page-4)
- c. Similarly, para-5 (Sub-para-2) illustrates:

"A person appointed as SS shall not be transferred/posted to any other post except on promotion to higher post in his own cadre." (Annex-B)

4. Additionally, in pursuance of Section-3 of NWFP Civil Servants (Regularization of Services) Act 1988, the provincial government gave clear outlines for SSs' seniority matter as under: (Annex-C)

"The seniority inter-se of the SS, whose services are regularized under this notification within the same service cadre shall be determined on the basis of their continuous officiation in such service; provide that if the date of continuous officiation in the case of two or more SSs is the same, the SS older in age shall rank senior to the younger SS."

5. Although the service rules 1994 are still intact but have not been implemented fully resulting wrong posting of SSs on management/Principals' posts, (Annex-D) instead they might have been promoted as in practice in Higher Education Department of Khyber Pakhtunkhwa Province as under:-

1. Lecturer BPS-17 is promoted as Asstt: Professor (BPS-18).
2. Asstt: Professor is promoted as Associate Professor (BPS-19).

Similarly, the Department of Elementary & Secondary Education upholds its previous view, which was shared with Honourable Secretary in 2002 (Annex-A), and proposes that on the same pattern of Higher Education Dept., promotion structure can be framed for SS cadre as under:

- a) SS-BPS-17 promoted to BPS-18 as SSS.
- b) SSS BPS-18 promoted to BPS-19 as Chief Subject Specialist (CSS).

This practice will be in the best interest of public and Government on the following grounds:

- A. By promoting SSs within their own cadre, the Education Department will be rich with experienced subject-wise specialists just like the lecturers/professors of Higher Education Department; who can be more beneficial teachers for the students than the newly appointed SSs.
 - a. Cost effectiveness factor also prevails here. Saving of millions is possible in terms of quality education by the utilization of least financial resources and mobilizing the senior SSs as an asset irrespective of their grade and growth in their own cadre like the lecturers and professors. No financial implication on Government can occur just like last twenty years. There is no need of time and

again appointments of hundreds of SSs. The Govt. has been bound to fill up such positions with fresh inexperienced candidates, which would have been vacated on experienced SS's promotion to Principal B-18 and B-19. Hence, such novice replacement is/has been not only a big financial loss and imprudent for the Government but also against the Service Rules 1994 Para-5 (Sub-Para-2) (Annex-B)

6. Moreover, both these cadres were merged in 1992 without any Gazette Notification or Order of the Government.
7. Unlike the underlying facts of joint seniority, both these cadres have differences in the following:

- a-b) Job Description and Selection Criteria.
c) Experience/Qualification for Initial Recruitment.
d) Responsibilities

a. According to the EMIS 2009, the approximate number of working HM and SS is as under:-


1) HMs 800.

2) SS 1700.

The greater number of SSs with less experience is compared to HMs with rich experience has blocked promotion for the latter. Which is not only causing heat burning but SS with less experience are being promoted to BPS-18 Principals.

SUGGESTIONS


- 1) HMs and SSs being two different entities, their seniority list may be maintained separate.
- 2) Majority of HMs gets promotion from SET posts after serving for more than 20-25 year. So most of them are at the verge of retirement before promotion to next higher grade. Keeping them merged with the young SSs in joint seniority list, vanishes chances of their promotion completely, which in turn a great loss to Govt. of losing experienced hands (HMs) due to their retirement.
- 3) Both HMs and SSs can get rapid promotions in their respective cadres by separate seniority (which is just and genuine).
- 4) 4-tier formula implemented in 1994 based upon their joint seniority list, needs to be revised in order to place the senior SS (who are either Principals or in Management cadre etc o/a of their promotion) as proposed in the above mentioned para-5 (A & B), in their respective cadre.
- 5) It will, minimize possibility of litigation from either side, save time and energy leading both to the prime cause of nation building, which is possible only by the highly effective qualitative teaching learning process through experienced hands (experienced HMs & seasoned SSs).
- 6) In brief, this step can be in the best interest of the students, the generations to come with cost effectiveness, savings of capital and without any financial requirement.



- ii. Can two different cadres, i.e., 'Head Masters' and 'Subject Specialists' having dissimilar qualifications, different criteria of recruitment, distinct set of duties and job description and altogether different ladder both vertically as well as horizontally be merged?
- iii. Does the post of Senior Subject Specialist exist on the Establishment Schedule, if not, its effect?
- iv. Whether the changes brought in the APT Rules/Method of Recruitment, as questioned in this appeal, have been duly vetted both legally and financially from the L.D and F.D?

F. That such state of affairs, if not plugged at this stage, is aimed at giving a very special edge to Subject Specialists over the different cadre of Head Masters, despite this fact that they (S.Ss) have, under the APT Scheme a distinct cadre from those of Head Masters for all intents and purposes, and certain posts like 'Senior Subject Specialists', are neither borne on the Establishment Schedule/APT Rules/Financial Structure, as also Subject Specialists have no entitlement to promotion as Principals/Vice Principals of High Secondary Schools either through promotion or direct recruitment.

G. That the entry in the notification of 2004 as against post of Head Masters (para # 1.4) in column # 2 thereof, to the extent of "*and other equivalent posts in the Teaching Cadre*" is vague, illegal and incorrect.

Respected Sir,

With due it is stated that I am the employee of your good self Department and is serving as Headmaster (BPS-17) in G GHS Darband, District Mansehra. The Headmaster post exists in education Department since British Rule in India. The post of Subject Specialist (SS) (BPS-17) was created in 1987, on the introduction of Higher Secondary Schools in the Province without Service Structure. Both these cadres were merged unlawfully in 1992 without any policy or Gazette Notification of the Government.

That me and my other colleagues (HMS) were appointed in E&SE Department on the recommendations of Khyber Pakhtunkhwa Public Service Commission in 2019 with (730) SS in the same advertisement of KPSC, under different selection criteria to the later. Similarly, our Job Description is also diversified, as SS Teachers 11th & 12th Grades in Higher Secondary Schools only, whereas HM runs a High School, i.e. purely a managerial post under APT rules.

In the present Seniority List (2019), both HM & SS have been mixed. Its critical analysis compels to highlight that HMs are about 550 only In the seniority list of 3384 officials. Majority belongs to SS community. This larger number of SS in the join Seniority List is the main obstacle in the promotion of HMs. Our (191 HMs and 730 SS appointees of 2019 under KPSC) inclusion in the seniority list will make the situation more grim, leaving least chances of promotion for the HMs.

The Directorate of E&SE Department always favored the HMs based on egal grounds realities. Despite rejection of our appeals by the E&SE Department, we feels injustice regarding promotion.

It is therefore, it is requested that we the HMs may kindly be kept in separate seniority list in the light of above mentioned facts, giving an open way of promotion to the SS in their own cadres please.

Preliminary Objections

1. The appellant has got no cause of action/locus standi.
2. The instant appeal is badly time barred.
3. The appellant has concealed the material facts from this Hon'able Service Tribunal, hence is liable to be dismissed on this score.
4. The appellant has filed the instant appeal with malafide intension just to pressurize the Respondent for gaining illegal service benefits.
5. The present appeal is liable to be dismissed fro mis-joinder & non joinder of necessary parties.
6. The instant appeal is against the prevailing law & rules.
7. The instant appeal is not maintainable in its present form and also in the present circumstances of the issue.

- I. That the appellant has got no cause of action/lous standi to file the instant appeal.*
- II. That the appeal is badly time barred.*
- III. That the appeal is bad for non joinder and misjoinder of necessary and interested parties.*
- IV. That the appeal is not entertainable/maintainable in its present form.*

- V. *That the appellant has not come to this Hon'bel tribunal with clean hands.*
- VI. *That this Hon'ble tribunal has no jurisdiction in the matter in hand.*
- VII. *That the appellant has concealed the material facts from this Hon'ble tribunal.*
- VIII. *That the appellant is stopped by his own conduct to file the present appeal.*
- IX. *That the appellant has filed the present appeal with malafide intention to harass and pressurize not only the replying respondents but the government as well as the department also in order to take undue benefits.*
- X. *That the instant appeal as well as the departmental appeal/representation have been filed in violation of laws/rules due to which the instant appeal is liable to be dismissed.*
- XI. *That the appeal is incompetent and liable to be dismissed because neither the relevant provision of rules, nor the latest seniority list has been challenged.*
- XII. *That in appeal is not entertinable under rule 23 Khyber Pakhtunkhwa service tribunal rules 1974.*

REPLY TO THE FACTS:

1. *Para No. 1 is denied, for want of knowledge, however the service record of the replying respondents is also clear/crystal.*

2. *Most of the contents of this Para pertain to the record, which has not been annexed and as the matter of merger of seniority list of Head masters and subject specialists is concern in this respect it is submitted that the same took place under four tier formula for Promotion to BPS-18 etc and a Joint Seniority list was the demand of the Head Masters and senior Staff Association and on their demand a joint seniority list was provided/prepared, so at that that time the Head Masters took advantage of promotion to BPS-18 as about all the Head Masters of that time were promoted to BPS-18 under that scheme and the subject specialist were deprived of their right of promotion to BPS-18 and the matter of separation of joint seniority list was closed. (Copy of the letters dated 04/10/2002 and 08/01/2003 are annexed as R-I and R-II). And now the appellants (Head Masters) once again want to deprive the subject specialists of their due right of promotion to BPS-18 etc through separation of the said/impugned seniority list. Moreover the department is very much competent to make and alter the rules or to increase or*

decrease the qualification for the posts which cannot be questioned.

3,4,5 & 6. Incorrect, false and misconceived, hence denied. All the notifications, rules, alterations and seniority lists have competently and properly been issued/made by the Government/department keeping in view the requirements of time. The question is why the appellant kept mum for so many years. The appeal of other colleagues of the appellant were once dismissed from this Hon'ble tribunal while some of them have now been remanded back by the August Supreme court to this Hon'ble Tribunal which are still pending before this Hon'ble tribunal.


REPLY TO THE GROUNDS:-

A to K: The contents of these paras of the appeal are incorrect and misconceived, hence denied. Moreover it is submitted that each and everything has been done by the competent authority legally and properly keeping in view the need and requirements of the time and other factors. The seniority was merged under the four tier formula on demand of the head master and senior staff association and the matter of its separation was closed and hundred and thousand employees of the department (mostly the Head Masters) were/have

been promoted on the basis of the same formula and as the Head Master and subject specialists both are belong to teaching cadre, therefore, there is/was no need to describe a separate structure/job description for both and for this reason both the cadre can be united in joint seniority for the purpose of promotion to BPS-18 etc.


It is therefore, humbly prayed that keeping in view the above the appeal of the appellant may kindly be dismissed with costs.



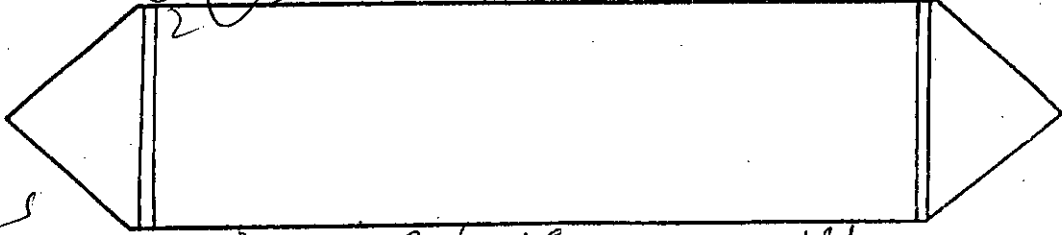
