



Mr. Muhammad Jan, District Attorney for the respondents present.</p> <p>02. Arguments heard and case file perused.</p> <p>03. This appeal is to challenge order dated 08.10.2021, whereby, the appellant was transferred from the post of Superintendent, Govt: City Girls College, Gulbahar Peshawar to Govt: Girls Degree College No.1, Charsadda. On receipt of the appeal the operation of impugned order was suspended vide order sheet dated 08.11.2021 and since then the appellant is enjoying the post from where he was transferred vide impugned order dated 08.10.2021. When confronted with the situation that the appellant had remained posted at the Govt: City Girls College, Gulbahar Peshawar for over and above the normal tenure period of posting, the learned counsel for the appellant did not controvert the situation. Therefore, the factum, that the appellant has spent period more than the normal tenure at the</p>

station from where he was transferred, has rendered this appeal fruitless because the impugned order was challenged only on the ground of premature transfer. Disposed of accordingly. Consign.
