Parawise Comments on Behalf of the Respondent No. 2, 3 and 4

Respectfully shewith

Preliminary objections

1. That the Appellant is not an aggrieved person within the meaning of Section 4 of the Service Tribunal Act, 1974.
2. That the Appellant has no cause of action / locus standi.
3. That the Appellant has not come to this Honorable Tribunal with clean hands.
4. That the Appellant has filed this instant Service Appeal just to pressurize the respondents.
5. The present Service Appeal is liable to be dismissed for non-joinder/mis joinder of necessary parties.
6. That the instant Service Appeal is against the prevailing law and rules.
7. That the Appellant has filed this instant Service Appeal on malafide motives.
8. That the instant Appeal is **badly time barred**.
9. That the instant Service Appeal is not maintainable in the present form, and above in the present circumstances of the issue.
10. That this Honorable Tribunal has got no jurisdiction as the matter in dispute has already been decided by the Honorable PHC Mingora Benc/Darul Qaza Swat twice vide judgment dated 24.09.2018 in Writ Petition No. 577-M/2017 and W.P 1199-M/2018 dated 03.02.2020. Against the said judgment the Appellant also filed Review Petition which was dismissed by the Honorable Court. The Appellant also agitated this issue before the Honorable Apex Court as well as he filed civil suit and then withdrawn the said civil suit. It clearly means that the Appellant is wasting the precious time of this Honorable Tribunal as well as the Government functionaries.
11. That the Appellant has been estopped by his own conduct by **submitting fake and forged documents for his appointment.**
12. That the Appellant has concealed the material facts from this honorable tribunal.

FACTS

1. That the Para No.1 is correct.
2. That the Para No.2 is correct to the extent of withdrawal of the appointment order of the Appellant. In fact, the Appellant submitted DMC of HSSC/FA in which his total obtained marks were shown as 649. After appointment, the said DMC of the Appellant was sent to BISE Swat for verification. The BISE Swat Authorities declared that as per record the marks of the Appellant was written as 649 instead of 449 by mistake. They further requested that the said candidate may be informed to provide original certificate/DMC for further necessary action. Similarly through another letter dated 01.08.2017, the Secretary BISE Swat declared that due to clerical mistake the roll number is written as 241449 HSSC (A) 2001 instead of 241490 HSSC (A) 2001 and further requested to direct the concerned teacher to bring his original certificate to this office for replacement. They further clarified the detail of the Appellant as under:

Similarly, the BA DMC provided by the Appellant was sent to the University of Peshawar which was returned by the Deputy Controller of Examinations University of Peshawar declared as fake and tempered. In fact, the correct marks of the Appellant are 248 and he produced DCM of BA with marks obtained as 284.

Keeping in view the above verifications by the concerned Board and University, the respondent No. 04 withdrawn the appointment order of the Appellant from the date of issue in the interest of public service.

3. That the Para No.3 is incorrect and denied. The Appellant wants to mislead this Honorable Tribunal by concealing the material facts from this Honorable Tribunal. The Appellant has not come to this Honorable Tribunal with clean hands. The respondent department has acted in accordance with the law, rules and policy. The Honorable PHC Mingora Bench/Darul Qaza Swat clearly directed to complete the verification of the DMC of the Appellant within one month and thereafter the DEO Male Swat shall pass appropriate order of the appointment of the Bakht Munir and in case if it is found by the respondents that the DMC of Bakht Munir is fake and withdraws the

order of appointment of Bakht Munir, then he shall consider Zahid Hussain against the said post of PST.

Thus, on the directions of the Honorable Court, the BISE Swat authorities conducted an enquiry through an enquiry committee comprised of assistant controller conduct and assistant secretary certificate. The enquiry committee declared that the actual marks of the Appellant are 449 instead of 649. They further clarified that marks obtained against Urdu as 168 in the photocopy of DMC clearly found tempered as his actual marks in Urdu are 68 only and the marks against Islamait History are 181 as against actual marks 81 only. Resultantly, there found clear tempering in the total marks obtained as 649 instead of the actual marks 449. The enquiry committee further recommended that photocopy of mark sheet (DMC) bearing marks obtained 649 (Six hundred and forty nine) Grade "C" is fake and bogus.

Thus, the respondent department withdrawn the appointment order of the Appellant after full justification and the entire satisfaction. **(FA DMC, BA DMC, & enquiry report annexed as annexure A, B & C)**

4. That the Para No.4 is incorrect and denied. The respondent department has to act in accordance with the law, rule and policy. Verification of candidates/appointees are made officially through official letters. As stated in the foregoing paras both the DMCs of the FA and BA of the Appellant have clearly been declared as fake and bogus by the concerned authorities.

It is pertinent to mention here that the Appellant malifidely submitted photo state of his BA degree where no marks are given. Only division I, e second division has mentioned. As 248 and 284 both marks are in second division. Therefore, when his DMC of 284 marks was sent to University of Peshawar which was returned as forged and fake. Thus, the Appellant malifidely and fraudulently submitted his BA degree for verification to conceal his actual marks.


5. That the Para No. 5 pertains to respondent No. 01 and 05, hence, no comments.
6. That the para No. 6 is correct to the extent of lengthy litigation by the Appellant, the rest of the para is incorrect and denied. The matter has rightly been resolved by the respondent department.
7. That the para No. 7 is incorrect and denied. This Honorable Tribunal has got no jurisdiction as the matter has already been decided by the PHC Mingora Bench/Darul Qaza Swat in so many rounds of litigation as stated in the preliminary objections.
8. That the para No. 8 is incorrect and denied. The Appellant has estopped by his own conduct by submitting forged and fake documents. The Honorable PHC also held that the Appellant has obtained the said documents fraudulently.

9. That the para No. 9 is incorrect and denied. Detail reply of this para has already been given in foregoing paras. Thus, the instant Service Appeal of the Appellant is bereft of any merit, hence, liable to be dismissed.

It is, therefore, very humbly prayed that the instant Service Appeal of the Appellant may be dismissed with cost in favor of the respondents.



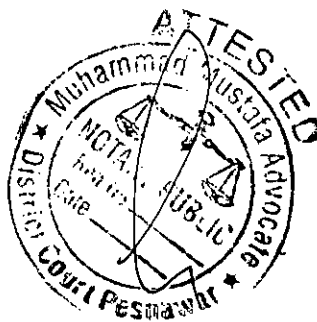

INQUIRY REPORT

INTRODUCTION:

An inquiry committee was constituted vide office order No. 325/PA-Secretary/BISE-Swat dated: 04/10/2018 to probe into the matter regarding Marksheet (Detailed marks certificate /DMC) issued by B.I.S.E Saidu Sharif Swat in respect of Mr. Bakht Muner S/O Mian Jan and give its recommendations.

The inquiry committee comprised the following officers

- Mr. MOHAMMAD ISHAQ (Assistant Controller Conduct)
- Mr. IHSAN ULLAH (Assistant Secretary Certificate)

PROCEDURE

The inquiry committee used the following tools for the purpose of finding out factual position of the case under consideration.

- Perusal of the relevant available record
- Verification of the documents concerned

The committee perused all the concerned record available.

FINDINGS


Consequent upon the procedure adopted by the inquiry committee, the following facts were found.


- i. The one Mr. Bakht Muner S/O Mian Jan appeared in higher secondary school certificate Annual Examination in Art/ Humanities group under Roll No. 241490 in the year 2001, and secured 449 (Four Hundred and forty nine) marks out of the total

- marks 1100 and subsequently was placed in grade "D". The same marks have been shown on page No. 158 of the result gazette of Board of Intermediate & Secondary Education Saidu Sharif Swat (copy annexed at page 1)
- ii. The detailed marks certificate (DMC) issued to the incumbent with marks 449 (Four Hundred and forty nine). Proof attached at page 3, 4.
- iii. There has been found clear tampering in the photocopy of the DMC in marks obtained against Urdu as 168 whereas actual marks obtained the Urdu Subject are 68, and the marks obtained shown against Islamic History (I.H) are 181 as against actual marks obtained which are 81. Resultantly there has been found clear tampering in the total marks obtained as 649 instead of the actual marks 449.
- iv. The copy of DMC with obtained marks 649 (six hundred and forty nine) is not genuine, hence is fake and bogus.

RECOMMENDATIONS

Keeping in view the nature of the case under study the marks obtained as per record of the Board of Intermediate and Secondary Education Saidu Sharif Swat in respect of Mr. Bakht Muner S/O Mian Jan Roll No. 241490 Higher School Certificate Annual Examination 2001(Arts/ Humanities Group) are 449 (four hundred and forty nine) out of 1100, and the grade is "D". The photocopy of marksheet (DMC) for the Roll No. noted above bearing marks obtained 649 (six hundred and forty nine) Grade "C" is fake and bogus.

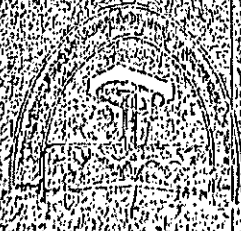
