**APPLICATION FOR RESTRAINING THE RESPONDENTS TO MAKE PROMOTION THE POST OF DFO (BPS-18) ON THE DISPUTED SENIORITY OF SDFO (BPS-17) TILL THE DECISION OF THE APPEAL OF THE APPELLANT.**

**RESPECTFULLY SHEWETH:**

1. That the appellant has filed the instant appeal in this Honorable Tribunal for correction of his seniority position in the final seniority list of SDFO's dated 26.06.2021 according to the merit order assigned by the KP Public Service Commission.
2. That the instant appeal is in arguments stage and fix for today i.e 05.04.2023 before this Honorable Tribunal and now the respondents has illegally revised the seniority of some off the official in lower rank and also wants to revise their seniority in the cadre of SDFO (BPS-17) and wants to promote them to DFO (BPS-18) malafidly, which is evident from the documents attached this application. **(Copy of documents is attached as Annexure-R1)**
3. That as the seniority of SDFO (BPS-17) is disputed before this Honorable Tribunal and as per Supreme Court Judgment that the department should not make promotion on disputed seniority which is subjudice before the Court/Tribunal and if the respondents makes promotion on the disputed seniority of SDFO (BPS-17) which is subjudice before this Honorable Tribunal, then legal complication will arise and the appellant will compel for further litigation.

4. That it will be interest of justice to retrain the respondents to make promotion to DFO (BPS-18) on the disputed seniority of SDFO (BPS-17) till the decision of the instant appeal.

It is therefore most humbly prayed that on the acceptance of this application, the respondents may kindly be restrained to make promotion to the post of DFO (BPS-18) on the disputed seniority of SDFO (BPS-17) till the decision of the appeal of the appellant.

Memo:-

Enclosed please find herewith original application in respect of Mr. Sardar Salih, CDFO presently posted as Divisional Forest Officer Dir Kohistan Forest Division Shorlagat, which is self-explanatory for further necessary action in your office.

Mr. Sardar Salih was inducted into Forest service on 01/10/1990 as Forester. During the DPC meeting held on 19/02/2009, he was not considered for promotion to the post of Deputy Ranger with the remarks that according to date of birth i.e. 20/01/1972, on the analogy that according to service rules for the post of Deputy Ranger in that time notified vide A.Deptt: No. SO(FT-II)/AD/1-405/88/ol-IV, dated 26/03/1993, he was over aged by two years and one month. After non-consideration by the DPC, he presented an appeal before the Administrative Secretary for relaxation of upper age limit by two years and one month which was accordingly granted to him vide notification No. SO(EsII)/Env/1-3/2K8/3950-53, dated 06/04/2009 with the direction to this office for issuance of his promotion order as he was not considered during the DPC meeting held on 19/02/2009 on the basis of upper age limit.

After issuance of notification by the A.Deptt., the then Conservator of Forests Malakand Circle Saidu Shari Swat vide his office order No. 62, dated 15/04/2009 has issued his promotion/appointment order to the post of Deputy Ranger on acting charge basis with one year probation.

By issuance of appointment order to the post of Deputy Ranger on acting charge basis some of his colleagues have filed service appeal bearing No. 1464/2009 in Khyber Pakhtunkhwa Service Tribunal and as per order sheet dated 22/02/2013, previous office order No. 62, dated 15/04/2009 was withdrawn by CF concerned and his case was for the second time placed before the DPC held on 24/05/2013, in which his case was considered for regular promotion and resultantly the CF Malakand West Timergara issued promotion order bearing No. 35, dated 29/05/2013 with immediate effect. The issued order was challenged by Mr. Sardar Salih in Khyber Pakhtunkhwa Service Tribunal through appeal No. 1135/2014 but in the meanwhile the Chief Conservator of Forests Central Southern Forest Region-I Khyber Pakhtunkhwa Peshawar has restored his seniority v.e.f 16/04/2011 instead of 15/04/2009 the date under which his previous promotion was issued on acting charge basis and in which probation of one year was also recorded.

Subject: - INSTRUCTIONS REGARDING PROCESSING OF PROMOTION CASES AND HOLDING OF THE MEETINGS OF DEPARTMENTAL PROMOTION COMMITTEE/ PROVINCIAL SELECTION BOARD.

Dear Sir,

I am directed to refer to the subject noted above and to state that section 210(2) of the Election Act, 2017 provides, inter alia, that Caretaker Government shall not make promotion or major appointments of public officials but may make acting or short term appointments in the public interest. Therefore the Election Commission of Pakistan was approached for necessary guidance as to whether meetings of PSB/DPC can be held or otherwise to consider promotion cases of the officers/officials who are otherwise eligible for promotion. The Commission vide its letter bearing No. F.17(1)/2023-Elec-II dated 11.03.2023 (copy enclosed) has conveyed that the Honorable Commission has been pleased to accede to the request made by the Provincial Government.

2. I am therefore, directed that all the Provincial Government Departments may process the cases accordingly.
