SERVICE APPEAL U/S 4 OF THE KPK SERVICE TRIBUNAL. ACT 1974 AGAINST THE IMPUGNED NOTIFICATION NO. ISSUED BY 30.12.2021 <u>SO(C-I)HE/1-1/2021</u> DATED RESPONDENT NO.1 TO IMPOSE MAJOR PENALTY OF COMPULSORY RETIREMENT FROM SERVICE UNDER THE KPK SERVANT (EFFICIENCY & 14 **OF** RULE 2011 IS ILLEGAL. UNLAWFUL, DISCIPLINE) RULES, MALAFIDE, WITHOUT LAWFUL AUTHORITY, WITHOUT JURISDICTION, ARBITRARY, PERVERSE, CAPRICIOUS, FANCIFUL AND CONSEQUENTLY OF NO LEGAL EFFECT UPON THE RIGHT OF APPELLANT AND AGAINST THE ORDER DATED 25.01.2022 WHEREBY THE REJECTION DEPARTMENTAL APPEAL OF THE APPELLANT WAS **REJECTED WITHOUT SHOWING ANY REASON.**

PRAYER:

ON ACCEPTANCE OF SERVICE APPEAL, THE IMPUGNED NOTIFICATION # SO (C-I)HE/1-1/2021 DATED 30.12.2021 ISSUED BY RESPONDENT NO.1 AND 25.01.2022 MAY KINDLY BE SET ASIDE AND TRANSFER ORDER OF APPELLANT FROM GOVT. DEGREE COLLEGE KTS HARIPUR TO GOVT. DEGREE COLLEGE BALAKOT, MANSEHRA MAY GRACIOUSLY BE CANCELLED BEING PREMATURE. ANY OTHER RELIEF DEEMED FIT AND PROPER IN THE CIRCUMSTANCES OF THE CASE.

Respectfully Sheweth:-

Brief facts giving rise to the present appeal are arrayed as under :-

- That the appellant is the permanent employee of KPK Higher Education Department and presently serving as Associate Professor, (BPS-19) of Physics at Govt. Degree College KTS Haripur.
- 2. That appellant performed his duty with quite honesty through- out his service.
- 3. That the appellant transferred from Govt. Degree College KTS to Balakot Mansehra but the respondent No.3 issued relieving chit 0n 23-09-2021 and applicant on the letter of respondent No.2 again relieved from the college on 30.09.2021 but the relieving chit has not handed over to the applicant .All this caused the appellant to suffer heart attack as mentioned in appeals to Secretary Education and ultimately politically victimized The appellant attended college up to 30.11.2021 to receive the relieving chit, as per order of respondent No.3 the security Guard at gate stopped the appellant and closed the gate and said that" your entry is banned as per order of Respondent No.3. (Copies of relieving chis are annexed a Annexure "A".
 - 4. That appellant submitted an application to respondent No.1 regarding the behavior of respondent No.3. Copy of application is annexed as Annexure "B".
 - 5. That the appellant illegally, unlawfully, against the rules, policy has been transferred whereas the appellant normal tenure has not been completed with malafide intention.
 - 6. That during service a charge sheet was given to the appellant on 17.02.2021 which was received on 19.02.2021 and appellant properly replied to charge

sheet and denied the allegations. Copy of charge sheet and reply is annexed as <u>Annexure "C & C1".</u>

- 7. That in the light of charge sheet an inquiry was conducted on 27.04.2017 which was cancelled and the said inquiry was reconducted on 15.02.2018 in which the appellant provided brief explanation for all the allegations in said charge sheet verbally and written i.e i, ii, iii and iv and stood cleared by the inquiry committee.
- 8. That after three years raising again these allegations leveled against the appellant, whereby the appellant depressed badly and vital proof of evidence to damage my service by a maphia, which was reported to the Secretary Education through several applications and also to chief Secretary. Copies of appeals are annexed as <u>Annexure "D".</u>
- 9. That Khawaja Saqib,Asstt. Director in Directorate told the appellant that the report of reconducted inquiry on 15.02.2018 conducted by Prof.Niaz Muhammad and Prof.Raza Shah at GDC Khanpur was lost by Directorate. Misplaced of this inquiry report was clearly mentioned in application to Secretary Education Dated 26.07.2021. Copy of application is annexed as Annexure "E".
 - 10.That an inquiry was conducted, the applicant has not informed in time, all the correspondence was made through Principal GDC Balakot Mansehra whereas the appellant was serving at GDC KTS, Haripur where respondent No3 has deliberately been withheld the relieving chit.
 - 11.That later on, the appellant had informed by the PS to Secretary Zakat Peshawar through real brother of appellant regarding personel hearing but the PS to Secretary with the connivance of Directorate had not informed date of hearing 14.12.2021 in time due to which the appellant was unable to appear the inquiry committee.
 - 12. That inquiry committee comprising Asghar Ali Secretary population and Prof. Nasrullah Ex-Principal GC Peshawar was constituted to conduct the inquiry into the allegations. But the appellant was not informed about the date of this inquiry in time as reported by him - Anne was "E,".
 - 13. That inquiry committee after having examined the charges, evidence on record submitted his report in which the inquiry committee also mentioned

that an opportunity of personnel hearing to the appellant was given thrice but appellant failed which is absolutely incorrect.

- 14. That on the report of inquiry committee the learned respondent No.1 has illegally, unlawfully and against the rules and regulation been imposed major penalty of compulsory retirement from service by exercising power under Rule 14 of the Khyber Pakhtunkhwa Govt. Servants (Efficiency& Discipline) Rules 2011 vide Notification No.SO (C-1)HE/1-1/2021 Dated 30.12.2021 without giving response to appeal to Chief Secretary dated 23-02-2021 marked to responded No 1 and handed over to respondent No.1 by appellant. The vital proof is the posted letter for personnel hearing by Directorate stamped on 14.12.21 by GPO Haripur showing it reached at post office on 14.12.21 and then received by appellant whereas the date for personal hearing was also fixed on 14.12.21 at 11.AM. Copy of impugned order is attached as annexure-F.
 - 15. That feeling aggrieved from the impugned notification, the appellant submitted departmental appeal for setting aside the impugned notification regarding compulsory retirement carried out proceeding one-sided before Respondent No.1 but in vain. The same was also rejected vide order dated 25.01.2022. copy of departmental appeal and rejection order is attached as annexure-G & H.
 - 16.That feeling aggrieved from the impugned notification regarding compulsory retirement of appellant, the appellant has come to this Honourable Court, assailing the impugned notification dated 30.12.2021 being unwarranted at law and facts, inter-alia on the following grounds many others:-

GROUNDS OF APPEAL:-

- A. That the impugned notification of compulsory retirement illegal, against the law, facts and circumstances of the case, hence not maintainable.
- B. That respondent have not treated appellant in accordance with law, rules and policy on the subject and acted in violations of service rules and unlawfully compulsory retired the appellant from service on the on the basis of one-sided inquiry report which is unjust, unfair, illegal

and hence not sustainable in the eye of law.

C. That no personally hearing chance has been given to appellant and the inquiry committee mentioned in his report that appellant has so called thrice for personal hearing which is incorrect, the appellant has not been informed regarding personal hearing with the connivance of Directorate which has resulted in serious miscarriage of justice, amounting to sheer discrimination on the part of respondents.

- **D.** That the charges leveled against the appellant were never proved in the enquiry, the enquiry officer gave his findings on surmises and conjectures.
- E. That the appellant have never committed any act or omission with bad or malafide intentions which could be termed as misconduct, albeit the appellant was dismissed from the service. Which is violation of reported judgment cited as <u>1997 PLC cs 564</u>.
- F. That the appellant compulsory retired from service on the basis of charges leveled in charge sheet, in which the appellant has been declared innocent which was held at GDC Khanpur wherein provided brief explanation for all these allegations in said charge sheet verbally and written i.e. i, ii, iii and iv and stood cleared but the report was deliberately misplaced by Directorate as told by Khawaja Saquib Asstt. Director to appellant who mentioned this in appeal to Secretary Higher dated 26.07-2021.And reopened the inquiry on the same charges which is against the natural justice and also against the procedure laid down in the Efficiency and Disciplinary rules.
 - G. That no proper regular inquiry was conducted only fact finding inquiry was conducted but the appellant not associated with the inquiry, neither the statement recorded in presence of appellant nor was the chance of cross examination provided to the appellant which is violation of *Rule-10 (b) and Rule 11 (1) of the E&D Rules 2011,* which were totally ignored before imposing punishment which is illegal and against the law, rules and natural justice. The same principle held in the Superior Court judgments cited as 2010 SCMR 1554, 2016 SCMR 108, 2009 PLC (cs) 19, 2008 SCMR 1369, 2009 SCMR 412, 2007 PLC cs 247 and 2008 PLC cs 1107.

- H. That the opportunity of personal hearing and personal defense was not provided to the appellant which was violation of Rule 7(d) in case inquiry was not necessary and 14(5) of the E&D rules 2011 in case where inquiry is necessary. The same principle held in the Superior Court judgments cited as <u>2006 SCMR 1641. Copy of personal hearing documents is attached as annexure-I.</u>
- I. That the respondents have not adopted the procedure without hearing of appellant. One-sided proceeding was initiated with malafide intention, hence the act of respondents caused grave injustice to the appellant, and therefore, the impugned notification for compulsory retirement is liable to be set aside.
- J. That the impugned notification issued by respondent No.1 is illegal, unlawful and against procedures and in contravention of the rules, hence the impugned notification is liable to set aside.
- K. That no other efficacious, speedy or adequate remedy is available to the appellant except the instant appeal.
- L. The valuable rights of the appellant are involved in the matter.
- M. That the appellant seeks leave of this Honourable service Tribunal to agitate additional Grounds at the time of hearing of this Service Appeal.

It is therefore, most humbly requested that the appeal of the appellant may be accepted as prayed for. p_{1}

That he remained irregular/ unpunctual and least interested in performance of his duties. Because of his causal attitude towards performance of his duties, he failed to complete teaching/ practical work properly.

That a preliminary inquiry was conducted by Prof: Abdul Wahab, Ex-Principal, Govt; Post Graduate College, Haripur who in his inquiry report recommended to refer him to medical Board for medical examination to determine as to whether he was fit for duty or otherwise due to his distorted state of mind.

According to Prim, on 25-02-2012, Mr. Nisar, Assistant Prof: of Physics and resident of Staff hostel forcefully entered his room with pistol in hand to make attack of him, but his other colleagues rushed into the room to sive him. Reference your office letter No. 9988/CA-II/Estt: Branch/A-12/Mohd Nisar/Physics dated 10th April, 2017 on the above subject and to state that the said inquiry was conducted on 27th April, 2017 at GDC Khanpur, District Haripur.

Statements of all concerned were recorded and questions put forth to clarify whether the allegations of the Principal GDC Khanpur against Mr. Mohammad Nisar, Associate Professor of Physics at GDC Khanpur were based on facts. Copies of relevant portions of the official documents including register of the classes which Mr. Mohammad Nisar taught were also taken to examine the case.

After in depth study of the case the following facts came out to the surface which are stated/discussed one by one and in conjunction with other facts where necessary.

 In his statement, Mr. Mohammad Nisar, Associate Professor of Physics, has given detailed history of his transfer and stay at GDC Khanpur and alleged that Mr. Liaqat-ur-Rehman, Associate Professor of Pakistan Studies; was directed by the Principal GDC Khanpur to adjust the classes of Mr. Nisar as such to give him tough time. He further added that his second year class was given to another teacher of physics without taking him into confidence/consideration (Annex A).Both the allegations were denied by the Principal GDC Khanpur in his written statement as well as verbally when asked. The Principal GDC Khanpur, on the contrary, asserted that Mr. Nisar handed over his class; of e1st year to the other, teacher of Physics and changed the timings of class period of 3rd year without taking him into confidence (Annex B). Mr. Nisar has a long dist of allegations against the principal and other staff which does not come under the purview of this inquiry because this specific inquiry is against. Wr. Nisar's casual, behavior in taking class periods and practical of this classes; and staying for a short period at the college.

- 2. The alleged Associate professor of Physics has accepted that he had completed the course to this 2nd year class: inrmid Jahuary, 2017 (Annex C) and his class register (Annex D) depicts that he took class periods of 2nd year (III-27th February, 2017 which he had to take till the end of April of the same year it shows that he has not followed the course outline/planning for his 2nd year class. On examining the register of Mr. Nisar for 2nd year students; he has entered attendance of students on those dates for which he had applications to the principal for casual leave [19th November, 2016 (written as November, 2017), 19th January, 2017 and 2nd January, 2017]. The absent days are in addition to these on which the teacher was on casual leave but has entered presence in the class register (Annex Dand Annex E have all the details).
- Statements from some students available on the date of inquiry and those who were telephonically contacted and provided their statements later on clearly show that the said Mr. Mohammad Nisar, Associate Professor of Physics is least interested in teaching and that he dishonours the degree level students, as well (Annex Fand Annex H).
- 4. Mr. Liaqat-ur-Rehman, Associate Professor of Pakistan Studies has categorically denied allegations level against him by Mr. Mohammad Nisar, Associate Professor of Physics (Annex G). This was also denied by two students of B.Sc. (3rd Year), Mr. Ahmad Ali and Mr. Habibullah when asked about the involvement of Mr. Liaqat in instigating students against Mr. Nisar.

5. All the students gave application on 22nd November, 2016 and another student suger application on 9th March, 2017 to the principal (Annex H) about the attitude of Mr. Mohammad Nisar, Associate Professor of Physics about teaching the

course and expulsion of students from class. The principal requested, in writing (Annex I), the said Mr. Nisar to allow the students in his class but to no avail. The principal constituted an inquiry committee (Annex J) to look into the matter of verbal suspension of a student of B.Sc (3rd year) but didn't follow it up and, according to the statement of the student, his two precious months were wasted by the teacher on the pretext that let the inquiry report come and the matter will be decided then (Mr. Ahmad Ali student of 3rd year who also brought his parents to beg pardon of the teacher but he didn't entertain his request). This again is not a teacher's attitude.

6. During the whole period of inquiry Mr. Mohammad Nisar, Associate Professor of Physics talked irrelevant on all questions posed to him which presumably shows his distorted state of mind.

As the situation is alarming and Mr. Mohammad Nisar, Associate Professor of Physics is disinterested both in attending the college and completing his teaching/practical work properly as well as dishonouring his students, the following steps are suggested to remedy the situation at the college.

> Mr. Mohammad Nisar, Associate Professor of Physics presently teaching at GDC Kahnpur, District Haripur may be referred to Medical Board whether he is fit for further teaching and

The principal should keep an eye on what is happening around him in the college and take in time remedial measures so that the situation doesn't deteriorate to such a point.

The Higher Education, Archives and Libraries Department, Government of Khyber Pakhtunkhwa informed vide letter No. SO(C-I /HE/1-780/ 2021/Muhammad Nisar/2700 dated 12.02.2021 (Annex-I) that the Competent Authority had appointed Mr. Asghar Ali, (PCS SG BS 20), Ex Secretary Population Welfare Department, now, Director Staff Training Institute, Peshawar and Professor Nasrullah Khan (BS 20), Ex Principal, Government College, Peshawar, now Chairm in BISE Peshawar to conduct enquiry into the following allegations against Mr. Muham had Nisar, Associate Professor (BS-19) of Physics, Government Akhtar Nawaz Khai (Shaheed) Degree College, Khalabat Township, Haripur that:-

He while posted as Assistant Professor of Physics at Government Degree College Khanpur, Haripur committed the following irregularities: -

- i. That he allegedly handed over class of first year to the other teacher of Physics and changed the timings of class period of Third year without taking him in to confidence.
- ii. That he despite the fact that he was on casual leave on 19.11.2016 and 02.01.2017 yet he entered the attendance of the students on the very dates and thus bluntly violated the rules.
- iii. That his attitude with the students and the staff was hostile/arrogant due to which they had to lodge complaints against him.
- iv. That he remained irregular/unpunctual and least interested in performance of his duties. Because of his casual a titude towards performance of his duties, he failed to complete teaching/practical work properly.
 - That a preliminary inquiry was conducted by Prof. Abdul Wahab, Ex Principal Government Post Graduate College, Haripur who in his inquiry report recommended to refer him to Medical Board for medical examination to determine as to whether he was fit for duty or otherwise due to his distorted state of mind

Enquiry Proceedings

The Higher Education Department has stated in the note for the Chief Secretary 2. that Principal Government Postgraduate College No.1 Abbottabad lodged a complaint against Mr. Muhammad Nisar, Associate Projessor (BS 19) of Physics of his college wherein allegations of irresponsibility and less interest in duties were levelled. A factfinding enquiry was conducted by Prof. Abcul Wahab, Ex Director Higher Education wherein all allegations were proved against the officer. According to the record, the said fact-finding enquiry was conducted at Government Degree College Khanpur, Haripur on 27.04.2017 (Annex-II). The Higher Education Department initiated case of this formal enquiry against the officer on 27.11.2020. The note for Chief Secretary was returned by the Establishment Department with the observation that charges against the officer were deficient and abstract and returned the note to HED on 23.12.2021 to resubmit revised charge sheet. The HED submitted the case with revised charge sheet to Establishment Department on 25.01.2021. Establishment Department submitted the case to the Chief Secretary (Competent Authority) on 02.02.2021. The competent Authority approved the panel of Mr. Asghar Ali, (BS 20, PCS SG) and Professor Nasrullah Khan, BS 20, Higher Education Department on 04.02.2021. The HED issued letter to the Enquiry officers on 12.02.2021 (Annex-I), which was received on 17.02.2021.

3. The Enquiry Committee requested the accused officer on 17.02.2021 to provide reply to charges within 7 days (Annex-III). he Enquiry Committee requested Section Officer (Colleges I), HED to provided copy of fact-finding enquiry report and particulars of the Departmental Representative on 17 02.2021 (Annex-IV). The Section Officer (Colleges I) provided copy of fact-finding enquiry report on 18 02.2021 (Annex-V). The Directorate Higher Education nominated Khawaja Mohammad Saqib, Assistant Director (General) as Departmental Representative on 19.02.2021 (Annex-VI). The accused officer provided reply to the charges on 23.0.2021 (Annex-VII).

Reply of the accused officer to the Charges

4. The accused officer in his reply dated 23.02.2021 (Annex-VII) informed that another fact-finding enquiry was conducted on the same charges on 15.02.2018 in which he was cleared of all charges then why the Department had based this enquiry on older fact-finding enquiry. Raising the same allegations after three years is injustice and cruelty as it depressed him and is evidence to damage his service by a maphia (sic). He wanted to be heard in person.

5. The Departmental Representative was incluested to provide a copy of the second fact finding enquiry along with canactures onducted on 15.02.2018, however, he informed on 20.05.21 that he could not find such an enquiry in the record.

6. The accused officer did not provide charge-wise reply; therefore, he was asked to provide the same vide letter dated 22.03.2021 (Annex-VIII), however, he did not provide reply in spite of the fact that the letter was received by him. He was contacted through mobile number 0349-5777161, provided by the Principal of the Government Degree College Khalabat Township, Haripu, and confirmed by Khwaja Saqib, the departmental representative. He never responded to text message and phone call on this number. He was conveyed the message through Prof: Mohammad Shafi, Principal, Government Akhtar Nawaz degree college, Khalabat Haripur to re-submit reply. After waiting for a long time, it was decided by the Enquiry Committee to afford the accused officer an opportunity of personal hearing is requested by him. Therefore, he was informed through letter dated 08.04.21 (Annex-IX) sent through TCS that his personal hearing was scheduled to be held at 11 am of 12.04.2021 in the office of the Principal, Government College, Peshawar.

7. In order to give a chance of personal hearing to the accused officer and cross examination to the Departmental representative, a meeting was held in the office of the Principal, Government College Peshawar at 11 am on 12.04.2021. Attendance sheet is at Annex-X). The Personal hearing was attended by the following: - ℓ

8. The accused officer did not attend the personal hearing in spite of the fact that he was informed through letter sent through TCS which reached him at 01:23 pm on 09.04.2021, however, he refused to receive it. The letter was received back undelivered (Annex-XI). He was verbally informed about the personal hearing by the Principal of the College on 09.04.21 and a copy of the letter was delivered at his house by Mr. Tariq, Naib Qasid which was received by Mr. Iftikhar, brother of the accused officer on 09.04.2021 for information of the accused officer as informed by the Principal.

9. The Enquiry Committee waited for the accused officer from 11 am up to 12 noon and then decided to complete the enquiry Ex-party.....

Findings

10. The findings on the basis of fact-finding enquiry, reply of the accused officer to the charge sheet and information provided by the departmental representative are as under: -

- i. It has been noted with concern that no justification has been given for initiating formal enquiry on 27.11, 020 on the basis of fact-finding enquiry conducted in 2017; after lapse of a period of three years. The reasons for such a long delay need to be investigated.
- ii. Letter of Principal GDC Khanpur, Haripur addressed to the Director Higher Education dated 27.04.2017 through which he had informed the later about the casual leave and absence from duty does not mention 19.11.2016 as casual leave or absence while 02.11.2017 has been mentioned as absence while charge sheet mentions it as cusual leave (Annex-XII).
- iii. The charges in themselves are of trivial nature and should have been addressed by the Principal of the concerned college at his own level.
 - The departmental representative informed that no fact-finding enquiry against the accused officer conducted in February, 2018 was available on record, as pointed out by the accused officer in his reply, dated 23.02.2021.
 - The attitude of the accused officer during proceedings of this enguiry did not project him as a responsible officer as he did not provide charge-wise reply to the charge sheet and also willfully absented himself from the personal hearing held on 12.04.2021.

The accused officer did not avail the opportunity of providing his version of the charges in writing as well as through personal hearing which render him liable to be proceeded further through this enquiry process.
