

APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED SENIORITY LIST DATED 20.09.2022 WHEREBY THE APPELLANT HAS WRONGLY BEEN PLACED JUNIOR TO THE PRIVATE RESPONDENTS AND THE INACTION OF THE RESPONDENT DEPARTMENT BY NOT DECIDING THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

That on acceptance of this appeal, the respondents may kindly be directed to modify/rectify the seniority list by placing appellant at his due position. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- 1- That the appellant was initially appointed as PTC on the basis of open merit vide order endorsement NO.3097-3167 dated 24-06-1997 through proper selection. Copy of the Appointment Order is attached as Annexure

A.

- 2- That similarly, through another order of the respondent department vide endorsement NO. 3168-3218 dated 24.06.1997 the private respondents NO 4 to 8 were appointed. Copy of the Appointment Order is attached as Annexure **B.**
- 3- That it is astonishing to note that the respondent department promoted juniors to the appellant i.e. Private respondents No.04 and No.05 to the post of CT vide order dated 06-11-2014 and respondent No.06 vide order dated 09-12-2014 but the appellant was ignored. Copies of Promotion Orders dated 6.11.2014 and 09-12-2014 are attached as Annexure **C & D.**
- 4- That surprised by the orders mentioned above the appellant preferred departmental appeal for his promotion and the same was accepted by promoting the appellant vide order dated 10.01.2015. Copy of the Order dated 10-01-2015 is attached as Annexure **E.**
- 5- That the respondent issued seniority list of SCT/CT of District Shangla up to 20.09.2022 in which the appellant is reflected at serial No 127 and the private respondents at serial No. 126 and 125. Copy of Seniority List is attached as annexure **F.**
- 6- That feeling aggrieved from the impugned seniority, the appellant preferred departmental appeal before the respondent department which has not been decided by the respondent till date. Copy of the Departmental Appeal is attached as Annexure **G.**
- 7- That during the pendency of the departmental appeal another seniority list dated 31.12.2022 was issued whereby appellant once again placed Serial No. 116 however the private respondents being juniors to the appellant were placed at senior position i.e. above the appellant. Copy of the Seniority List of 31.12.2022 is attached as Annexure **H.**
- 8- That vide letter dated 01.02.2023 the DEOs of all districts have been intimated that to submit the seniority lists of CT etc. for promotion. Copy of Letter dated 01.02.2023 is attached as Annexure **I.**
- 9- That appellant having no other efficacious remedy but to file the instant appeal on the following grounds amongst the others.

GROUND:

- A- That the impugned action and inaction of the respondent by issuing the impugned seniority and not rectifying the same are against the law, facts, and norms of natural justice.
- B- That the appellant has not been treated in accordance with the laws and rules by the respondent department on the subject noted above

and as such the respondent department violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

- C- That the impugned action of the respondent are in violation of Section 8 of the Civil Servant Act read with Rule 17 of APT rules 1989.
- D- That according to Section 8 of the Civil Servant Act the seniority of an employee shall be reckon from the date of first regular appointment hence keeping in view this principle the impugned seniority is illegal and *vide-ab-initio* and is liable to be rectified.
- E- That it is pertinent to mention that the selection of the appellant was prior then the private respondents and according to Rules 17 of the APT Rules, 1989 the person selected in earlier selection shall rank senior to the person selected in latter selection, thus keeping in view this rule the impugned seniority is against the rules.
- F- That the respondents acted in arbitrary and mala fide manner, therefore, the same is not tenable in the eye of law.
- G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal may kindly be accepted as prayed for.



2. Their services will be liable to termination on one month notice from either side. In case of resignation without notice one month pay will be forfeited in lieu thereof.
