#### PRAYER:

That on acceptance of this appeal the respondents may kindly be directed to fix the pay and inter se seniority of appellant with her colleagues from her first appointment i.e 16/06/2014. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

#### R/SHEWETH: ON FACTS:

Brief facts giving rise to the present appeal are as under:

- **1-** That appellant is serving the respondents department as certified teacher quite efficiently and up to the entire satisfaction of her superiors.
- 2- That initially appellant was appointed as certified teacher through NTS on ad hoc basis in GGMS murdan against vacant post vide order dated 16/06/2014. That in pursuance to the aforementioned order the appellant started her duty quite efficiently and up to the entire satisfaction of her

- 3- That it is pertinent to mention here that the appellant belong to district chitral which is a hard area and the school where the appellant was performing duty was far away from her residence, therefore the appellant requested the respondents several times for her transfer to a nearby school but she was not transferred and consequently she continued her duty at the above mentioned school despite so many challenges.
- That latter on the respondents floated another advertisement in 2016, whereby application were called from eligible candidates for filing of various teaching cadre posts including posts of certified teacher. That appellant also to the post of certified teacher aforementioned reason in para 3 through proper channel by acquiring NOC from respondents. That after going through proper selection process the appellant secured first position and was consequently appointed as certified teacher in GGHS shahnigar vide order dated 15/03/2017 Copies of the NOC and second appointment order are attached as annexure ...... C, D.
- 5- That it is worth mentioning here that there is not a single day break in service of appellant, the appellant was performing her duty at her previous school till issuance of second appointment order.
- 6- That later on notification dated 22/02/2018 was issued whereby the services of all NTS teachers were regularized in light of regularization act (no.1 2018) 2017. That it is pertinent to mention here that the respondents fix pay and seniority of appellant from second appointment order i.e 15/03/2017 and her previous services from 2014 to 2017 was not counted towards pay and seniority. Copy of regularization notification is attached as annexure.
- 7- That feeling aggrieved the appellant filed departmental appeal before the respondents for fixing pay and seniority from her first appointment order with her colleagues who were appointed with her vide order dated 16/06/2014 but the same has not been responded within statutory period of ninety days. Copy of departmental appeal is attached as annexure.
- 8- That feeling aggrieved and having no other remedy the appellant filed the instant appeal on following grounds inter alia.

#### **GROUNDS:**

- A- That the action and inaction of the respondents by not counting the previous service of appellant for pay fixation and seniority is against the law, facts and norms of natural justice.
- B- That the appellant has subsequently been appointed in the same department against the same post and there is not a single day break in her service, furthermore she applied for second time through proper channel, therefore she is entitled for her previous service to be counted towards pay fixation and seniority.
- C- That the appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- D- That the respondents acted in arbitrary and malafide manner by not fixing pay and seniority from her first appointment.
- E- That the ad hoc services of appellant colleagues who were appointed with her vide order dated 16/06/2014 have been counted towards seniority and pay fixation.
- F- That the appellant has been discriminated on the subject noted above and as such the respondents violated the principle of natural justice.
- G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

#### JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENTS NO.1 TO 4.

Respectfully Sheweth, that the respondents submit as under:-

#### Preliminary Objections.

- 1. That the appellant is not aggrieved person with the meaning of Article 199 of the Constitution of the Islamic Republic of Pakistan 1973.
- 2. That the petitioner has got no cause of action / locus standi to file the instant appeal.
- 3. That the appellant has not come to this court with clean hands.
- 4. That the appellant is estopped by his own conduct.
- 5. That the instant petition is not maintainable in the eyes of law in the present circumstances.
- 6. That the instant petition is already badly time barred.
- 7. That the appeal of the appellant is bad for misjoinder and non-joinder of necessary parties.

#### ON FACTS.

- 1. That the Para-I of the appeal pertains to record.
- 2. Para No. 2 is correct that the appellant was initially appointed on 16.06.20214 on contract /School based.
- That the appellant could not be transferred because she was not a regular and contract / School wise based employee. It is clearly mentioned in her First Appointment Order dated 16.06.2014 Para No. 12, that "their Appointment is made on School Based. They will have to serve at the place of posting and their service is not transfer able to any other station. Copy of First Appointment order is annexed as annexure A.
- 4. It is true that the undersigned advertised various categories of vacant posts of teaching cadres during the Year 2016. Being Govt. employee the appellant has been given NOC as permission to appear in the NTS test against the advertised posts.
- 5. Pertains to record.
- In Para No. 17 of the second appointment order of the appellant it has been mentioned that the candidates Serial number 01, 9, 13, 14,20,21,23,27,28,29 & 37 will be reappointed and considered fresh candidates. They will not claim their previous service seniority in future" As the candidate is at serial No. 01. (Copy Of Second Appointment order of the appellant is attached as annexure-B.

  Moreover it is clearly mentioned in the Establishment Code section 17 (Seniority, Sub Section 2 "Seniority In various cadres of civil servants appointed by initial recruitment vis-a-viz those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre" and in sub section 4 it has been stated that, "Inter-se-seniority of civil servants in a certain cadre to which promotion is made from different lower posts, carrying the same pay scale shall be determined from the date of regular appointment / promotion of the civil servants in the lower post". Copy of pages from Esta Code is annexed as annexure, C.
- 7. That no any employee of the Second appointment order has been granted any benefit i.e. Pay / Seniority etc. The departmental appeal which the appellant has attached has not been acknowledged by the Department.
- 8. That Para No. 08 is incorrect. That the instant petition is not maintainable in the eyes of Law.

#### **GROUNDS.**



- a. #### **CHAPTER-2**

#### Section-1

Statutory provision regarding Appointment.

Section 5 of Civil Servants Act, 1973 - Appointment to a civil service of the Province or to a civil post in connection with the affairs of the Province shall be made in the prescribed manner by the Governor or by a person authorised by the Governor in that behalf.

The Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.

#### PART-I GENERAL

- 1. Short title and commencement:- (1) These rules may be called the North-West Frontier Province Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.
  - (2) They shall come into force at once.
- Definitions:-(1) In these rules, unless the context otherwise requires:-
  - (a) "Appointing Authority" in relation to a post, means the persons authorised under rule 4 to make appointment to that post;
  - (b) "Basic Pay Scale" means the Basic Pay Scale for the time being sanctioned by Government, in which a post or a group of posts is placed:
  - (c) "Commission" means the North West Frontier Province Public Service Commission.
  - (d) "Departmental Promotion Committee" means a committee constituted for making selection for promotion or transfer to such posts under a Department, or offices of Government which do not fall within the purview of the Provincial Selection Board.
  - (e) "Departmental Selection Board" means a Board constituted for the purpose of making selection for initial recruitment /appointment to posts under a Department or office of Government in Basic Pay Scale 17 not falling within the purview of the Commission".

Provided that more than one such committee may be constituted for civil servants holding different scales of pay".

(e) "Departmental Selection Committee" means a committee constituted for the purpose of making selection for initial appointment to posts under a department, or office of Government 1{in Basic Pay Scale 17 and below not falling within the purview of the Commission}:

#### **PART-VI**

#### SENIORITY

17. Seniority:-(1) The seniority inter se of civil servants (appointed to a service, cadre or post) shall be determined:-

(a) in the case of persons appointed by initial recruitment, in accordance with the order of merit \*assigned by the Commission or as the case may be, the Departmental Selection Committee;} provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; and

(b) in the case of civil servants appointed otherwise, with reference to the date of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter se seniority as in the lower post.

Explanation. I:- If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher post, it would not adversely effect the interest of his seniors in fixation of his seniority in the higher post.

Explanation. II:- If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incompletion of record or for any other reason not attributing to his fault or demerit.

Explanation. III:- A junior person shall be deemed to have superseded a senior person only if both the junior and the senior persons were considered for the higher post and the junior person was appointed in preference to the senior person.

- (2) Seniority in various cadres of civil servants appointed by initial recruitment vis-a-viz those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.
  - (3)\* In the event of merger/restructuring of the Departments, Attached Departments or Subordinate offices, the inter-se-seniority of the civil servants affected by the merger/ restructuring as aforesaid shall be determined in accordance with the date of their regular appointment to a cadre or post.

(4)) The inter-se-seniority of civil servants in a certain cadre to which promotion is made from different lower posts, carrying the same pay scale shall be determined from the date of regular appointment/promotion of the civil servants in the lower post.

Provided that if the date of regular appointment of two or more civil servants in the lower post is the same, the civil servant older in age, shall be treated senior

18. General Rules:- In all matters not expressly provided for in these rules, civil servants shall be governed by such rules as have been or may hereafter be prescribed by Government and made applicable to them.

TERMS & CONDITIONS.

1 Their services shall be governed by the Khyber Pakthunkhwa civil Servants Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting & Transfer of Teachers, Lecturer, and Instructors & Doctors) Regularity Act, 2011, and such rules & regulations as may be from time to time by the government.

2 Their services shall be considered regular and they shall be eligible for pension / deduction of GP fund in terms of the Khyber Pakhlunkhwa civil Servants Act, 1973 as amended in 2013.

3 They shall possess the same qualitation and exportences required for a regular post.

4 Their services are liable to termination on one months notice from either side, in case of resignation without notice, their one months pay / Allwoances shall be forfieled to the Government.

5 Their regularization shall not effect the promotion quote of existing holders of posts in respective service cadros.

6. The regularization will not be in favor of those, who have not taken over charge or have remained absent from

duty or resigned from service and also not for those who are under disciplinary proceedings.

7 The employees whose services are regularized under the Khyber Pakhtunkhwa employees of the Elementary and Secondary Education (Appointment and Regularization of Services) Act, 2018 (Khyber Pakhtunkhwa Act No. 1 of 2018) or in the process of attaining service at the commencement of The Khyber Pakhtunkhwa Elementary and Secondary Education (Appointment and Regularization of Services) Act, 2018 (Khyber Pakhtunkhwa Act No. 1 of 2018) shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of the Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education (Appointment and Regularization of Services) Act, 2018 (Khyber Pakhtunkhwa Act, No. 1 of 2018), and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.

8 The seniority inter-se of the employees, whose services are regulalized under this Act, within the same service or cadre, shall be determined on the basis of their position in such service or cadre

9 Their seniority shall be determined on the basis of their continues continuous service in the case of two or more employees is the s	heir seniority shall be determined on the basis of their continues service in cadre, provided that if the date Ontinuous service in the case of two or more employees is the same, the employee older in age shall rank
