

PRAYER

ON ACCEPTANCE OF INSTANT SERVICE APPEAL, IMPUNED NOTIFICATION NO.SO (PE) E&SED/2-6/DPC Meeting/2019 Dated Peshawar, the 31.05.2019 MAY GRACIOUSLY BE MODIFIED TO THE EXTENT OF THE APPELLANT AND MAY BE CONSIDERED FROM DUE DATE OF PROMOTION 01-01-2019 AS PER PRINCIPLE OF NATURAL JUSTICE OR

FROM DATE OF DPC MEETING i.e. 17-04-2019 FOR CONSEQUENTIAL BENEFITS OF THE APPELLANT.

Respectfully Sheweth:

Facts:

1. The Appellant completed 10 years of service as SST Science BS-16 in E&SE department of Khyber Pakhtunkhwa on 01-01-2019.
2. That on the completion of 10 years of service on SST BS-16 post, the employ be upgraded to SST BS-17 Personal vide Finance Department Notification No. FD/SO/(FR)10-22/2007 dated the Peshawar, the 26th June, 2008 (Copy of the notification is attached as Annex-i)
3. That the department called for the submission of PERs and other documents from 685 SSTs male including appellant who completed 10 years of service for conducting DPC meeting.
4. That the DPC meeting was held on 17-04-2019 in which 685 SSTs male including the appellant were recommended for up gradation from SST BS-16 to SST BS-17 (Personal).
5. That in the meanwhile, the appellant recommended by Khyber Pakhtunkhwa Public Service Commission was appointed as Headmaster BS-17 at GHS Ganshal Dir (U) Vide order NO.SO(SM)E&SED/3-2/2016/Recruitment of Male 191 HM (BS-17) dated Peshawar, the April 12, 2019 and Corrigendum order issued Vide Order No.SO(SM)E&SED/3-2/2016/Recruitment of Male 191 HM (BS-17) Dated Peshawar the April 18, 2019 (Copy of appointment notification is attached as annex-ii & Corrigendum notification as annex-iii respectively).
6. That meeting for the abovementioned DPC for SST BPS-17 Personal was held on 17-04-2019. Notification for aforementioned DPC was issued Vide

Order NO.SO (PE) E&SED/2-6/DPC Meeting/2019 Dated Peshawar, the 31.05.2019. (Promotion notification is attached as annex-iv).

7. That the appellant submitted departmental appeal on the subject matter to Secretary E&SE Khyber Pakhtunkhwa diary no. 1473 dated 15-11-2022 (copy of the departmental appeal is attached as Annex-v).
8. That Section officer (PE) issued letter to Director E&SE Khyber Pakhtunkhwa on the subject matter vide order NO.SO(PE)/E&SED/2-6/DPC-meeting/2022 (Copy is attached as annex-vi)
9. That on the completion of 90 days on 15-02-2023, the department concerned has neither rejected nor accepted the departmental appeal of the appellant.
10. That the appellant has no other adequate remedy except to file the instant appeal.

Grounds:

- A. That the Appellant completed 10 years of service required for up gradation of SST BS-16 to SST BS-17 (Personal) on 01-01-2019. Therefore, the applicant is eligible for BPS-17 Personal on 01-01-2019 according to the principle of natural justice.
- B. That DPC meeting for the abovementioned promotion was held on 17-04-2019 and the appellant was recommended for up gradation to SST BS-17 personal on 17-04-2019.
- C. That the inordinate delay was made by the competent authority by delaying the promotion notification to 31-05-2019 which was not in the control of the appellant.
- D. That promotion on notional basis is always considered from the date of DPC meeting.
- E. Justice delayed is justice denied. Promotion delayed is promotion denied.

PRAYER:

it is therefore, most humbly prayed that on acceptance of instant service appeal, impugned notification No.SO (PE) E&SED/2-6/DPC meeting/2019 dated Peshawar, the 31.05.2019 may graciously be modified to the extent of the appellant

and may be considered from due date of promotion 01-01-2019 as per principle of natural justice or from date of DPC meeting i.e. 17-04-2019 for consequential benefits of the appellant.

Terms and Conditions:

1. They shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 and the rules made thereunder.
2. Their pay shall be released subject to verification of their academic documents/testimonials from the concerned Board/University by the District Education Officer (Male) concerned.
3. Their services shall be considered regular and they shall be eligible for pension/deduction of GP Fund in terms of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended in 2013.
4. Their services are liable to termination on one month notice from either side. In case of resignation without notice, their one month's pay/allowances shall be forfeited to the Government.
5. They shall be on probation for initial period of one year extendable for further one year as per rules.




