# <u>Para-wise comments on behalf of respondents submit as under:</u> Respectfully Sheweth,

#### **PRELIMINARY OBJECTIONS**

- 1. That the appellant has not approached this Hon'ble Tribunal with clean hands.
- 2. That the appellant has concealed the actual facts from this Hon'ble Tribunal.
- 3. That the appellant has got no cause of action or locus standi to file the instant appeal.
- 4. That the appellant is estopped by his own conduct to file the instant Service Appeal.
- 5. That the appeal is unjustifiable, baseless, false and vexatious and the same is liable to be dismissed with special compensatory cost in favour of respondents.
- 6. That the appeal is bad for miss-joinder and non-joinder of necessary parties.
- 7. That the appeal is barred by law and limitation.

#### **REPLY ON FACTS**

- 1. Para to the extent of enlistment in Police Department pertains to record. While rest of para is incorrect, because every Police Officer is under obligation to perform his duty upto the entire satisfaction of his superiors. Moreover, the perusal of service record of the appellant revealed that due to his lethargic attitude his entire service record is tainted with bad entries (Copy of list of bad entries is attached as Annexure "A").
- 2. Incorrect. The appellant has suppressed/concealed material facts as he was issued charge sheet with statement of allegation vide No. 23/PA dated 27.01.2022 on account of his involvement in case vide FIR No. 89 dated 17.01.2022 u/s 371-A/371-B/109 PPC Police Station City District Mardan and not on the basis of absence and enquiry was entrusted to the then SDPO Rural Mardan (Copies of FIR and Charge Sheet with statement of allegations are annexed as annexure "B & C").
- 3. Incorrect. Para already explained.
- 4. Incorrect. Plea taken by the appellant is not plausible because the appellant while posted as DFC Lower Court Police Station Jabbar was placed under suspension on account of involvement in a case vide FIR No. 89 dated 17.01.2022 u/s 371-A/371-B/109 PPC Police Station City District Mardan. Hence, on basis of aforementioned allegations, the appellant was issued charge sheet with statement of allegations and enquiry was entrusted to SDPO/Rural Mardan. The enquiry officer during the course of enquiry provided full-fledged opportunity to the appellant to produce evidence/grounds in his defense, but he failed. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended the appellant for major punishment. Therefore, the appellant was summoned and



heard in Orderly Room on 08.06.2022 but this time too, the appellant failed to justify his innocence, therefore, he was awarded major punishment of dismissal from service, which does commensurate with the gravity of misconduct of the appellant (Copy of Enquiry papers and dismissal order are annexed as annexure D &E).

- 5. Incorrect. Stance taken by the appellant is totally devoid of merit because he has been properly proceeded against departmentally by issuing him Charge Sheet with Statement of Allegations and Enquiry officer during the course of enquiry provided full-fledged opportunity to the appellant to produce evidence/grounds in his defense, but he failed. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended the appellant for major punishment. Therefore, the appellant was summoned and heard in Orderly Room on 08.06.2022 but this time too, the appellant failed to justify his innocence, therefore, he was awarded major punishment of dismissal from service, which does commensurate with the gravity of misconduct of the appellant.
- 6. Correct to the extent that the appellant preferred departmental appeal which was decided on merit because the appellant was provided full-fledged opportunity of defending himself before the appellate authority but he bitterly failed to produce any cogent reasons in his defense. Therefore, the same was rejected and filed, being devoid of merit (Copy of order is attached as annexure-"F").
- 7. That appeal of the appellant is liable to be dismissed on the following grounds amongst the others.

#### **Reply on Grounds:**

- A. Incorrect. Order passed by the competent authority as well as appellate authority are legal, lawful and according to rules, hence, liable to be maintained.
- B. Incorrect. Stance taken by the appellant is totally devoid of merit because he has been properly proceeded against departmentally by issuing him Charge Sheet with Statement of Allegations on account of involvement in a case vide FIR No. 89 dated 17.01.2022 u/s 371-A/371-B/109 PPC Police Station City District Mardan and enquiry was entrusted to SDPO/Rural Mardan. Enquiry officer during the course of enquiry provided full-fledged opportunity to the appellant to produce evidence/grounds in his defense, but he failed. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended the appellant for major punishment. Therefore, the appellant was summoned and heard in Orderly Room on 08.06.2022 but this time too, the appellant failed to justify his innocence, therefore, he was awarded major punishment of dismissal from service, which does commensurate with the gravity of misconduct of the appellant.
- C. Incorrect. Plea of the appellant is totally ill based because a fulfledged departmental enquiry was conducted during the course of which all legal and codal formalities were fulfilled but the appellant has bitterly failed to produce even a single iota of evidence in his defence.
- D. Incorrect. Para already explained needs no comments.
- E. Incorrect. Stance taken by the appellant is totally devoid of merit because the Enquiry officer during the course of enquiry provided full-fledged opportunity to

the appellant to produce evidence/grounds in his defense, but he failed. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended the appellant for major punishment. Therefore, the appellant was summoned and heard in Orderly Room on 08.06.2022 but this time too, the appellant failed to justify his innocence, therefore, he was awarded major punishment of dismissal from service. Besides, the above, appellant preferred departmental appeal which was decided on merit because the appellant was summoned and heard in orderly room held on 05.08.2022 by provided full-fledged opportunity of defending himself before the appellate authority but he bitterly failed to produce any cogent reasons in his defense. Therefore, the same was rejected and filed, being devoid of merit, which does commensurate with the gravity of misconduct of the appellant.

- F. Incorrect. Para already explained.
- G. Plea taken by the appellant is bereft of any substance because criminal and departmental proceedings are two different entities which can run parallel and the fate of criminal case will have no effects on the departmental proceedings. Besides, release on bail does not mean acquittal from the charges rather the same is released from the custody.
- H. The respondents also seek permission of this honorable tribunal to adduce additional grounds at the time of arguments.

#### **PRAYER:-**

Keeping in view the above facts, it is most humbly prayed that the appeal of the appellant, being badly barred by law and limitation, may kindly be dismissed with costs, please.





WRITTEN DEFENSE / REPLY TO THE CHARGE SHEET CUM STATEMENT OF ALLEGATIONS NO.23/PA DATED: 27-01-2022

#### Respected Sir,

#### The petitioner humbly submits as under:

It is submitted that your honour had issued the subject Charge sheet cum statement of allegations to the petitioner vide your office endorsement No.23/PA dated 27-01-2022 with the following allegations:

"Whereas ,Constable Masroor No.1064,while posted as DFC Lower Court Police Station Jabbar (Now under suspension Police Lines Mardan), has been charged in a case vide FIR No.89 dated 17-01-2022 U/S 371-A/371-B/109 PPC Police Station City Mardan." (Copy of charge sheet is enclosed)

#### **BRIEF FACTS:**

#### The detailed submissions are as follows:

- a. It is submitted that the petitioner has been issued the subject charge sheet vide DPO Mardan Office letter No. 23/PA dated 27-01-2022. That during the course of departmental enquiry, Mr.Ijaz Ali SDPO Rural Mardan has been nominated as Enquiry Officer.
- b. That On receipt of Public Complaint (Copy attached) of Kotchi Abad residents dated 10-01-2022 against the petitioner for allegedly running a brothel House, SI Iftikhar Khan alongwith police officials raided the house of petitioner on 17-01-2022 at 1640 hrs. The Complainant as per version of FIR, noticed a man and a women in compromising position inside the room who on enquiry disclosed their names as Farhan and Mst. Nosheen. On search of another room, one Zakria Shah and Mst Zainab were also found in compromising position. After cursory interrogation, the Local police lodged FIR No.89 dated 17-01-22 u/s 371-A/371-B and 109 PPC PS City Mardan against the petitioner. (FIR is enclosed)
- c. That later on, the petitioner filed a post arrest bail petition in the Honourable Court of ASJ-V ,Said Backhah; Mardan but the same was rejected on 20-01-2022 vide a consolidated order.(Copy of Bail Order is attached)
- d. That the petitioner filed another bail petition before the PHC,Peshawar which was accepted vide Cr.Misc. BA No.217-P dated 04-02-2022 by Justice Rooh-ul-Amin Khan after furnishing bail bonds of 80,000/-Rs along with two sureties.(Copy of PHC Bail order is attached)

#### **GROUNDS OF DEFENSE:**

- e. That It appears from the record of alleged case, that none of the accused has been medically examined in support of the allegations levelled in the FIR due to malfidy intentions.
- f. The complainant has not recovered any incriminating material/articles from the spot /rooms such as any piece of cloth stained with human semen or clothes of petitioners stained with their respective semen.



- g. That the alleged ladies were selling cosmetic items in the streets and were present for earning their livelihood. The other 02 passers by / strangers were enroped for strengthening the prosecution case.
- h. That no Recovery has been made on the spot except levelling of immoral allegations which shows the bias,ill-will and illegal intentions of the prosecution.
- i. That the Urine Test of all arrested ladies came out to be "Negative" after the occurrence which itself is the main proof of his innocence.
- j. That the petitioner has been enroped in the present criminal case owing to personal ventdetta and your Honour is humbly prayed to take appropriate measures against the complainant for bringing bad name to the Police Service.
- k. That the house of petitioner was disgraced by the Local Police for not accompnying Lady constables at the time of raid.
- That the petitioner alongwith other accused have been graced with Post arrest Bail by PHC due to their innocence and baseless criminal case.
- m. That the petitioner had some kind of personal differences with the residents of Kotchi Abad who are the scribers of the complaint. They filed a fake complaint against me before the Local Police for disgracing me and my family honour to satisfy their personal malice alone.
- n. That the complainant of FIR has also personal grudges with the petitioner which has ensued in the present circumstances which is fatal for the prestige of Police deptt.
- o. The question of applicability of S.371-A and 371-B PPC is yet to be establised during the course of trial which is beyond imagination. The role of S.109 PPC has been given to the petitioner only which is entirely baseless and this allegation would be soon turned down during the course of trial.
- p. That there is no evidence to prima fascie connect the petitioner with the commission of offence and all other accused are also bailed out due to lack of evidence.
- q. That the charge sheet cum statement of allegations may very graciously be filed till the final judgment in the a/m criminal case. The petitioner could even never perceive to disgrace the esteemed police service.
- r. That the petitioner has been enrolled in KP Police department in the year 2004. The petitioner has not been dealt with departmental enquiry prior to this which is evident from the shining sevice record.
- s. That the petitioner belongs to a poor family and is happily married with having 05 school going kids along with ailing old age father. Moreover, the whole family entirely depends upon the Police Service of the petitioner.
- t. It is intimated that the petitioner wishes to be "heard in person" by your Honour.

#### PRAYER:

Keeping in view the above facts and circumstances, the charge sheet cum statement of allegations issued against the petitioner may kindly be filed as per a/m facts and circumstances. That the suspension from service order may very graciously be taken till the final judgment in the crimnal case, please.

DISCIPLINARY ACTION AGAINST CONSTABLE MASROOR NO. 1064.

Kindly refer to your office Diary No. 23/PA, dated 27.01.2022.

#### ST. CIEMENT OF ALLEGATIONS:

Whereas, Constable Masroor No. 1064, while posted as DFC Lower Court Ponce Station Jabbar (now under suspension Police Lines Mardan), has been charged in a case vide FIR No. 89 dated 17-01-2022 U/S 371-A/371-B/109 PPC Police Station City Mardan.

#### PROCEEDINGS:

To ascertain the real facts, efforts were made to contact with the alleged Constable but he was in judicial lock-up Mardan wherein he remained for almost 24/25 days. As the alleged Constable Masroor No. 1064 was released on post arrest bail, he was summoned to the office of the undersigned wherein he appeared at the office of the undersigned, copy of Charge Sheet and Statement of Allegation was served upon him and he was given opportunity for his defense. Further he submitted his written statement within due time.

#### STATEMENT OF CONSTABLE MASROOR NO.1064:

#### Heief facts:

He stated that brief facts of matter are (how the incident took place?) that public of Kotchi Abad moved a complaint against him on dated 10-01-2022 regarding running of a brothel house, wherein the local police raided over his house on dated 17-01-2022 at 1640 brs. As per brief of FIR 202 men and 02 women in 02 separate rooms were found in compromising position in the house of Constable Masroor No. 1064, on enquiry their names were known as Farhan with Mst. Nosheen and Zakaria Shah with Mst. Zainab. After cursory interrogation, the local police lodged FIR No. 89 dated 17-01-2022 U/S 371-A/371-B/109 PPC PS City Mardan against him.

Later on he along with other co-accusers filed a post arrest bail petition in thomerable Court of ASJ-V, Said Badshah, Mardan but the same was rejected on dated 20-01-2022. (Copy of court order is attached). After they filed another post arrest bail petition before Pushawar High Court wherein they were granted post arrest bail by Justice Rooh at Amin Khani Elec. (Copy of PHC bail order is attached).

#### Grounds of defense:

This is perfinent to mention here that the alleged Constable has only risen cross points in the case FIR registered against him, which is yet to be clarified during case trials at the concerned court. Which are as under:

- Record of the alleged case reveals that none of the accused was medically examined in support of the allegations leveled in the FIR. (But after in Para "e" he has committed that the medical report of accused ladies was received "Negative").
- (20)
- b) No abusive/incriminating material/articles, any piece of cloth stained with human semen were recovered from the spot.
- c) Regarding the presence of alleged ladies he stated that the alleged ladies were selling cosmetic items in the street and were present at his house for earning livelihood and the alleged men were passer by strangers, they were enroped for strengthening the prosecution case.
- d) No recovery was made on the spot except leveling of immoral allegations which shows the bias, ill-will and illegal intentions of the prosecution.
- e) The urine test of all arrested ladies came out to be "Negative" after the occurrence which itself is main proof of innocence. (This is worth to mention here that this Para crosses the Para "a" of his defense wherein he claimed that no accused was medically examined).
- f) The complainant of FIR SI Iftikhar Ali has personal grudges with him and the current FIR is result of that.
- g) No ladies police official was accompanied while raid conducted over his house, which disgraced his house members.
- h) He along with other accusers has been graced with Post arrest bail by Peshawar High Court due to lack of evidences. (As the post arrest bail of all accusers was previously rejected by worthy Session Court Mardan).
- i) He had some personal differences with the residents of Kotchi Abad wherein the residents of Kotchi Abad moved a fake complaint against him before the local police for disgracing him and his family and satisfying their personal malice alone.
- j) The sections charged in the subject FIR and role given to the alleged Constable is yet to be clarified during case trials.
- k) Further he stated that he has been serving in Police Department since 2004, he is married person, having 05 school going kids and an old father, his whole family relies of on him, as the case is yet to be trailed and his innocence and guilt will be decided by the concerned court and requested the high-ups to file the charge sheet without further proceedings.


#### **FURTHER PROCEEDINGS:**

As the matter is under-trial at court, innocence/guilt and the sections charged in the FIR are yet to be determined/proven by the concerned court. Even though confidential report from In-Charge DSB Mardan regarding involvement of the alleged Constable in the subject activities was obtained wherein it is evident that the alleged Constable Masroor No. 1064 himself and his family members are involved in the subject crime of running a brothel house. (Report is attached for your kind perusal).

Furthermore statement of Basheer Muhammad Inspector/OII PS City Mardan was obtained which also reveals that <u>during investigation proceedings all accusers</u> were found guilty. (Statement of OII and copy of case file is attached).

#### ::NDINGS:





Keeping in view the above facts and circumstances while going through the second placed on file the undersigned is of the view that although the case is under-trial at court and the role given to the alleged Constable Masroor No. 1064 is yet to be determined and however his innocence/guilt is yet to be proven for being charged in the subject FIR but the record placed on file and reports obtained from I/C DSB Mardan, OII PS City and information obtained from local informers reveals that the alleged Constable is involved in the subject hideous crime against society, being a police official his involvement in such crime has brought a bad name to the police department.

Previous record of the alleged Constable Masroor No. 1064 was examined wherein he has 622 days absentees, 01 time dismissal, 36 bad entries and an only good entry.

#### RECOMMENDATION:

In the light of the reports and information from local informers and keeping in view previous record of the alleged Constable, it is therefore recommended that the alleged Constable Masroor No. 1064 may be awarded Major Punishment, if agreed please.

### ORDER ON ENQUIRY OF CONSTABLE MASROOR NO.1064

This order will dispose-off a Departmental Enquiry under Police Rules 1975, initiated against Constable Masroor No.1064, under the allegations that while posted as DFC Lower Court Police Station Jabbar (now under suspension Police Lines Mardan) was placed under suspension vide this office OB No.145 dated 18-01-2022, issued vide order/endorsement No.438-41/OSI dated 19-01-2022 on account of charging in a case vide FIR No.89 dated 17-01-2022 U/S 371-A/371-B/109 PPC Police Station City Mardan.

To ascertain facts, Constable Masroor was proceeded against departmentally through Mr. Ijaz Ali SDPO/Rural Mardan vide this office Statement of Disciplinary Action/Charge Sheet No.23/PA dated 27-01-2022, who (E.O) after fulfillment necessary process, submitted his Finding Report to this office vide his office letter No.678/ST dated 18-04-2022, holding responsible the alleged official of gross misconduct with recommending for major punishment.

#### Final Order

Constable Masroor was heard in O.R on 08-06-2022, during which, he failed to present any plausible reasons in his defence, therefore, awarded him major punishment of dismissal from Mardan Police with immediate effect, in exercise of the power vested in me under Police Rules-1975.

#### ORDER.

This order will dispose-off the departmental appeal preferred by Ex- Constable Masroor No. 1064 of Mardan District Police against the order of District Police Officer, Mardan, whereby he was awarded major punishment of dismissal from service vide OB: No. 1278 dated 09.06.2022. The appellant was proceeded against departmentally on the allegations that he while posted as DFC Lower Court Police Station Jabbar was placed under suspension on account of involvement in a case vide FIR No.89 dated 17-01-2022 U/S 371-A/371-B/109 PPC Police Station City Mardan.

Proper departmental enquiry proceedings were initiated against him. He was issued Charge Sheet alongwith Statement of Allegations and Sub Divisional Police Officer, Rural, Mardan was nominated as Enquiry Officer. The Enquiry Officer after fulfilling codal formalities submitted his findings, wherein he recommended the delinquent Officer for major punishment.

He was heard in Orderly Room by the District Police Officer, Mardan held on 08.06.2022, wherein he failed to satisfy the District Police Officer, Mardan, therefore, he was awarded major punishment of dismissal from service vide OB: No. 1278 dated 09.06.2022.

Feeling aggrieved from the order of District Police Officer, Mardan, the appellant preferred the instant appeal. He was summoned and heard in person in Orderly Room held in this office on 05.08.2022.

From the perusal of the enquiry file and service record of the appellant, it has been found that allegations of misconduct against the appellant have been proved beyond any shadow of doubt. Being a member of disciplined/uniformed force, the involvement of the delinquent Officer in such like ignominious activities of running a brothel has certainly brought a bad name to the entire Police Force in the eyes of the general public. Moreover, the Investigating Officer of the above mentioned case also appeared who stated in a categorical manner regarding the involvement of appellant in such hideous crime against the society. On partisal of previous service record of the appellant, it was noticed that he is habitual absentee prior to this, the appellant was also dismissed from service for his disinterest in the official duties. Hence, the retention of appellant in Police Department will stigmatize the prestige of entire Police Force as instead of fighting crime, he has himself indulged in criminal activities.

Keeping in view the above, I, Yaseen Farooq, PSP Regional Police Officer, Mardan, being the appellate authority, find no substance in the appeal, therefore, the same is rejected and filed, being devoid of merit.
