The appellant humbly submits as under:

Facts


1. That the appellant is resident of Umerzai District Charsadda. (copy of the CNIC is hereby attached as annexure "A").
2. That the appellant was appointed as Anesthesia Assistant on 02/09/1978 on regular base. Copy of the appointment Order is here by attached as annexure "B").
3. The appellant was promoted to the post of chief Anesthesia Technician on 07/07/1987. Copy of the promotion is hereby attached as annexure "C").
4. That the appellant further promoted to the post of chief Anesthesia Technician BPS-16 on 12/05/1991 on acting charge basis, while neglected for regular promotion (Copy of the promotion on acting charge basis order is here by attached as annexure "D").
5. That the appellant is regularly taking salary on pay role like regular.
6. That the appellant was time & again neglected and deprived from promotion to the next cadre, while his other colleagues were regularly promoted.
7. That nothing adverse in the ACR of the appellant.
8. That astonishingly on 20/02/2010 an Order No. 4969-74/ AE VII Dated Peshawar the 20/10/2010, for regularization on BPS-16 is made by the respondent. (copy of the Order No. 4969-74/ AE VII Dated Peshawar the 20/10/2010 is hereby attached as annexure "E").
9. That the appellant were wrongly been kept in BPS-16 for more than 10 years on acting charge basis, while the other colleague of the appellant were regularly promoted.
10. That the appellant was also entitle to consider his promotion on regular basis.
11. That the Other colleague of the appellant Mr. Sher Dil were promoted to the post of Chief Anesthesia Technician BPS-16 on 26/05/1992.
12. That similarly Mr.Tahir Gul were promoted to the post of Chief Anesthesia Technician BPS-16 on 12/08/1998.
13. That till now the appellant was kept on BPS-16 (copy of the seniority list is hereby attached as annexure "F").
14. That the appellant made departmental appeal against the Order No. 4969-74/ AE VII Dated Peshawar the 20/10/2010, for regularization on BPS-16. (Copy of the Departmental appeal is hereby attached as annexure "G").
15. That the respondents made Order on departmental appeal. Which is not a speaking order (copy of the same is hereby attached as annexure "H").

11. That till now the petitioner were kept on BPS-16 (copy of the seniority list is hereby attached as annexure "F").
12. That the petitioner made departmental appeal against the Order No. 4969-74/ AE VII Dated Peshawar the 20/02/2010, for regularization on BPS-16. (Copy of the Departmental appeal is hereby attached as annexure "G").
13. That the respondents made Order on departmental appeal. Which is not a speaking order (copy of the same is hereby attached as annexure "H").
14. That now other colleague (Sher Dil Khan and Tahir gul mentioned above) of the petitioner were promoted to BPS-17 on 21/07/2017 while the petitioner is again neglected. 4. That the petitioner is not treated equitably which is his vested right protected by the Constitution of Islamic Republic of Pakistan 11973.





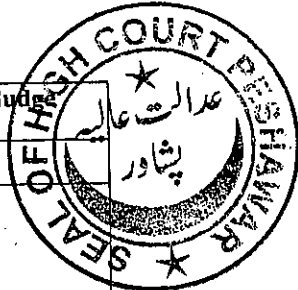
