





In order to resolve the controversy instant appeal is admitted to regular hearing subject to all just exceptions. The appellant is directed to deposit security and process fee within 10 days. 

Appeal u/s 4 of the Khyber Pakhtukhwa Service Tribunal Act, 1974 against the impugned original seniority list issued by the office of respondent No.2 in respect of Primary School Teacher (BS-12) against

which objection dated 17.08.2019 was filed before respondent No.2 i.e. District Education Officer (Male) Bannu vide Diary No.2411 but no response was provided to the appellant, thereafter departmental appeal dated 26.08.2019 Diary No.2554 was filed through proper channel before the respondent No.1 i.e. director E&S Education Khyber Pakhtunkhwa Peshawar, but the same has not been responded despite lapse of statutory period of 90 days, hence presents the instant service appeal within 30 days which is well within time.

---

**Prayer:**

On acceptance of this appeal, the impugned seniority list of Primary School Teachers (BS-12) be prepared in accordance with Section -4 Sub Section-2 of Appointment and Regularization of Services Act, 2017 and in the light of clause-8 of notification dated 07.04.2018 by declaring the appellant senior then Respondents No.3 to 40.

Any other relief which this Hon'ble Tribunal deems appropriate in the circumstances of this service appeal and to whom the appellant found entitled may kindly also be granted.

***Respectfully Sheweth;***

Brief facts giving rise to the instant service appeal are as under:-

- 1) That the appellant was appointed vide order dated 28.03.2016 as Primary School Teacher (PST) in (BS-12) on contract.

**(Copy of appointment order dated 28.03.2016 is attached as Annexure "A").**

- 2) That the appellant's service was regularized vide notification Endst No.2344-3253/AE-I/Estab dated: 07.04.2018 w.e.f his initial appointment by the order passed by respondent No.2. **(Copy of regularization order is attached as Annexure B).**
- 3) That the appellant was regularized in terms of Khyber Pakhtunkhwa Employees of Elementary and Secondary Education Department (appointment and Regularization of Services) Act, 2017. **(Copy of appointment and regularization of services Act, 2017 is attached as Annexure C).**
- 4) That as per Section-4 Sub Section 2 of Act 2017 speaks about "**Determination of Seniority**" which states and the same is reproduced in verbatim for the ready reference of this Honourable Tribunal.,

Section-4 "**Determination of Seniority**" 1.....

"2 The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, Shall be determined on the basis of their continuous service in Cadre:

**Provided that if the date of continuous service in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one"**

- 5) That the appellant preferred his objection petition dated 17.08.2019 before respondent No.2 for correction of seniority list of Primary School Teachers in terms of Section-4 Sub Section-2 of Appointment and Regularization of Services Act, 2017 but the same has not been responded against which departmental appeal dated 26.08.2019 was filed before respondent No.1 to do the needful (Correction) of seniority list in terms of the ibid Act but no response was given to him.

**(Copy of objection petition dated 17.08.2019 and departmental appeal dated 26.08.2019 are attached as Annexure D & E).**

- 6) That as per notification dated 07.04.2018 the services of the appellant got regularized by mentioning the terms and conditions and according to clause-8, it is mentioned that;

**“ Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service in service in case of two or more employees is the same, the employees older in age shall rank senior to the younger one”.**

- 7) That as per seniority list of primary school teachers (BS-12), the appellant is appearing at serial No. 1198 who is senior Respondents No.3 to 40.

**(Copy of seniority list of PST is attached as Annexure-F).**

- 8) That the appellant feeling aggrieved against the seniority list as referred to in Para No.7 being shown Junior to the

employees as mentioned in the above para, hence constrained to file the instant service appeal for correction of seniority list and enlisting the name of the appellant at his due place, on the following amongst other grounds.

**GROUND OF APPEAL:**

- a) That the impugned seniority list is against the law, facts and material available on record.
- b) That as per **Section-4 Sub Section 2 of Appointment and Regularization of Services Act, 2017** the appellant claim is fully justified and entitled to be ranked senior then the Respondents No.3 to 40 because the appellant is senior/older in age in terms of the ibid section.

**It is pertinent to mention that the date of birth of the appellant is 04.12.1981 who is older in age than Respondents No.3 to 40.**


- c) That the notification dated 07.04.2018 through which the appellant got regularized also provides the same rule (**older in age**) vis-à-vis seniority of Primary School Teachers (BS-12) also entitles him to be ranked senior then the employees referred to, in the body of this appeal.
- d) That the respondents failed to apply their independent minds to Section-4 Sub Section-2 of Appointment and Regularization Services Act, 2017 and notification dated 07.04.2018 which provides that an employee who is older in age shall rank senior then employees whom date of continuous service in the case of two or more employees is the same.

- e) That legally speaking, the respondents are bound to prepare a correct seniority list of Primary School Teacher (BS-12) in terms of the ibid act and notification dated 07.04.2018.
- f) That the additional grounds will be raised at the time of arguments with the kind permission of this Hon'ble Tribunal.


Keeping in view, what has been stated above, it is, therefore, humbly prayed that the impugned seniority list of Primary School Teachers (BS-12) be prepared in accordance with Section -4 Sub Section-2 of Appointment and Regularization of Services Act, 2017 and in the light of clause-8 of notification dated 07.04.2018 by declaring the appellant senior then Respondents No.3 to 40.

Any other relief which this Hon'ble Tribunal deems appropriate in the circumstances of this service appeal and to whom the appellant found entitled may kindly also be granted.

**TERMS AND CONDITIONS**

- 1- Their services shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting & Transfer of Teachers, Lecturers, Instructors & Doctors) Regulatory Act, 2011, and such rules and regulations as may be issued from time to time by the government.
- 2- Their services shall be considered regular and they shall be eligible for pension/deduction of GP fund in terms of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended in 2013.
- 3- Their services are liable to termination on one month prior notice from either side. In case of resignation without notice, their one month pay/allowances shall be forfeited to the Government treasure.
- 4- They shall possess the same qualification and experience required for a regular post.
- 5- They shall have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground before commencement of this ACT. The DDO concerned should ensure this condition before the drawal of their pay as regular servants.
- 6- Their regularization shall not affect the promotion quota of existing holders of posts in respective service cadres.
- 7- They shall rank junior to all other employees belonging to the same cadre who are in service on regular basis on the commencement of this Act and shall also rank junior to such other persons if any, who, in pursuance of the recommendation of the Khyber Pakhtunkhwa Public Service Commission made before the commencement of this ACT are to be appointed to the cadre, irrespective of their actual date of appointment.

- 8- Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service in the case of two or more employees is the same, the employees older in age shall rank senior to the younger one.
- 9- Errors and omissions will be acceptable within the specified period.



(f) "project" means,-

- (i) IT/Computer Teachers in Computer Labs Projects in Khyber Pakhtunkhwa (Phase-II);

3. **Regularization of services of employees.**---(1) Notwithstanding anything contained in any other law or rules, the employees, who hold posts till the commencement of this Act, shall be deemed to have been validly appointed on regular basis from the day of the initial appointment; provided that-

- (i) they possess the same qualification and experience required for a regular post;
- (ii) they have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground, before the commencement of this Act; and
- (iii) the service promotion quota of all service cadres shall not be affected.

(2) The services of the employees shall be deemed to have been regularized only on the publication of their names in the official Gazette.

4. **Determination of seniority**---(1) The employees whose services are regularized under this Act or in the process of attaining service at the commencement of this Act, shall rank junior to all other employees belonging to the same Cadre, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the Cadre, irrespective of their actual date of appointment.

(2) The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, shall be determined on the basis of their continuous service in Cadre:

**WHEREAS** it is expedient to provide for the appointment and regularization of the services of certain employees appointed on adhoc or contract basis or appointed in certain projects in the Elementary and Secondary Education Department in the Province of the Khyber Pakhtunkhwa, in the public interest;

It is hereby enacted as follows:

**1. Short title, application and commencement.**—(1) This Act may be called the Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017.

(2) It shall apply to all the employees in the Elementary and Secondary Education Department, as defined in clause (c) of sub-section (1) of section 2 of this Act.

(3) It shall come into force at once and it shall be deemed to have taken effect from the date of the initial appointment of the employees as referred to in clause (c) of sub-section (1) of section 2 of this Act.

**2. Definitions.**—(1) In this Act, unless the context otherwise requires,—

(a) "Commission" means the Khyber Pakhtunkhwa Public Service Commission;

(b) "contract appointment" means appointment of a duly qualified person for a specific period made otherwise than in accordance with the prescribed method of recruitment;

(c) "employees" mean duly qualified persons,—

(i) who are appointed as teachers on adhoc or contract basis by the Government after 2013 through National Testing Service but does not include the teachers engaged on work charge basis or who are paid out of contingencies;

(ii) who are appointed in the projects on contract basis in accordance with the project policy; and

(iii) who are appointed as Junior Clerk in the Elementary and Secondary Education Department by Government after 2013 through National Testing Service.

(d) "Government" means the Government of the Khyber Pakhtunkhwa;

5. **Overriding effect.**--- Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules to the extent of inconsistency to this Act shall cease to have effect.






