Learned counsel for the appellant argued that the appellant is aggrieved of the impugned order dated 14.07.2020 whereby he was awarded the major penalty of dismissal from service w.e.f 02.06.2020 i.e the date of FIR No.397 dated 02.06.2020 registered against him under Section-302/324/34 PPC at Police Station Nowshera Kalan. The appellant got bail out order from the court of 21.12.2020 consequent upon which he submitted departmental appeal against the impugned order, on 23.12.2020. His departmental appeal was however, rejected on 14.01.2021 and similarly his Revision Petition was rejected on 25.06.2021, hence, the instant service appeal was instituted in the Service Tribunal on 14.07.2021. Learned counsel for the appellant further contended that proper procedure has not been followed and no charge sheet/statement of allegations or show cause was issued to the appellant. No opportunity of personal hearing, as per provisions of Police Rules 1975, was given to the appellant. He has been condemned unheard. 

ORDER.

This order will dispose-off the departmental appeal preferred by Ex-Constable Shah Fahad No. 755 of Nowshera District Police against the order of District Police Officer, Nowshera, whereby he was awarded major punishment of dismissal from service vide OB: No. 564 dated 14.07.2020. The appellant was proceeded against departmentally on the allegations that he while posted at Computerized Driving License (CDL) Branch, Police Lines Nowshera was found involved in Case FIR No. 397 dated 02.06.2020 u/s 302/324/34-PPC Police Station Nowshera, Kalan District Nowshera.

Proper departmental enquiry proceedings were initiated against him. He was issued Charge Sheet alongwith Statement of Allegations and Deputy Superintendent of Police Headquarter, Nowshera was nominated as Enquiry Offices The Enquiry Officer after fulfilling codal formalities submitted his findings to District Police Officer, Nowshera, highlighted that the delinquent Officer went into hiding after commission of offence and evading his lawful arrest, therefore, recommended him to ex-parte action.

He was issued Final Show Cause Notice through Mosam Khan s/o Azeem Khan r/o Zaidi Colony, Nowshera Kalan, cousin of FC Shah Fahad, but failed to submit his reply.

. Consequently in the light of recommendations of enquiry Officer, an exparte action was taken against the delinquent Officer and he was awarded major punishment of dismissal from Service with effect from 02.06.2020 vide District Police Officer, Nowshera OB: No. 564 dated 14.07.2020.

Feeling aggrieved from the order of District Police Officer, Nowshera, the appellant preferred the instant appeal. He was summoned and heard in person in Orderly Room held in this office on 12.01.2021.

From the perusal of the enquiry file and service record of the appellant, it has been found that allegations of misconduct against the appellant have been proved beyond any shadow of doubt. Being a member of disciplined/uniformed force, the involvement of the delinquent Officer in such heinous crime brought a bad name for entire Police force in the eyes of general public. During the course of enquiry proceedings, the appellant did not bother to join enquiry proceedings. The retention of appellant in Police Department will stigmatize the prestige of entire Police Force as instead of fighting crime, he has himself indulged in criminal activities. Moreover, the appellant approached this forum at a belated stage without advancing any cogent reason regarding such delay. Hence, order passed by the competent authority does not warrant any interference.

Keeping in view the above, I, Sher Akbar, PSP S.St Regional Police Officer, Mardan, being the appellate authority, find no substance in the appeal. ரிந்துத்திர் the same is rejected and filed, being time barred.

This order is hereby passed to dispose of Revision Petition under Rule 11-A of Khyber Pukhtunkhwa Police Rule-1975 (amended 2014) submitted by Ex-FC Shah Fahad No. 755. The petitioner was dismissed from service by District Police Officer, Nowshera vide OB No. 564, dated 14.07.2020 on the allegations that he while posted at CDL Branch, Police Lines, Nowshera was found involved in case FIR No. 397, dated 02.06.2020 Ws 302/324/34 PPC Police Station Newshera Kalan District Nowshera. His appeal was rejected being time barred by Regional Police Officer, Mardan vide order Endst: No. 228/ES, dated 14.01,2021.1

Meeting of Appellate Board was held on 03.06.2021 wherein petitioner was heard in person. Petitioner contended that he is innocent and he was released on ball on compromise basis by the court of Additional Sessions Judge-I, Nowshera vide judgment dated 21.12.2020.

Perusal of record reveals that the applicant has effected compromise with the complainant which is tantamount to the admission of crime, Moreover, the retention of applicant in Police Department will stigmatize the prestige of entire Police Force as instead of fighting crime, he has himself indulged in crimmal activities. The Board see no ground and reasons for acceptance of his petition, therefore, the Board decided that his petition is hereby rejected.

PRELIMINARY OBJECTIONS: -

- That the appellant has got no cause of action and locus standi to file the instant appeal.
- 2. That the appeal is badly barred by law and limitation.
- 3. That the appellant is estopped by his own conduct to file the instant appeal.
- 4. That the appeal is not maintainable in its present form.
- 5. That the appellant has not come to the Honourable Tribunal with clean hands.
- 6. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.

Reply on Facts: -

- 1. Para pertains to record.
- 2. Each and every Police Officer/Official is under obligation to perform his duty upto the entire satisfaction of his high-ups.
- 3. Incorrect. Appellant was directly charged by complainant (injured) alongwith 02 other accused in a criminal case registered vide FIR No. 397 dated 02-06-2020 u/s 302/324/34 PPC Police Station, Nowshera Kalan. Hence, he was suspended vide OB No. 429 dated 03-06-2020. (Copy of FIR is annexure "A" and order of suspension is annexure "B").
- 4. Mere grant of bail does not mean acquittal from criminal case.
- 5. Incorrect. In order to scrutinize conduct of the appellant, he was issued charge sheet with statement of allegations while DSP Hqrs: was nominated as enquiry officer. During the course of enquiry appellant was contacted time and again but each time his mobile phone was

- found switched off as he was evading his lawful arrest. (Copy of enquiry report is annexure "C").
- 6. Correct to the extent that appellant moved departmental appeal before the appellate authority with a delay of almost 05 months, hence, the same was rejected/filed being badly time barred. (Copy of rejection order of departmental appeal is annexure "D").
- 7. Correct to extent that appellant moved revision petition which was also rejected/filed. (Copy of rejection order of revision petition order is annexure "E").
- 8. That appeal of the appellant is liable to be dismissed inter-alia on the following grounds: -

Reply on GROUNDS

- A. Incorrect. Punishment order dated 14-07-2020 was passed after fulfillment of all legal and codal formalities.
- B. Incorrect. In order to scrutinize conduct of the appellant, enquiry was conducted through DSP Hqrs: Nowshera but during course of enquiry, appellant went into hiding and did not join enquiry proceeding.
- C. Para already explained above.
- D. Incorrect. Appellant had been issued charge sheet and statement of allegation but not only he had gone into hiding but had also turned off his mobile phone. (Copy of charge sheet and statement of allegation is annexure "F").
- E. Incorrect. Appellant was issued Final Show Cause Notice which was received by Mosam Khan s/o Azim Khan r/o Zaidi Colony, Nowshera Kalan, cousin of appellant, but he failed to submit his reply to the same. (Copy of Final Show Cause Notice is annexure "G").
- F. Incorrect. Appellant was provided opportunity to defend himself but he did not join the enquiry proceeding rather went into hiding.
- G. Incorrect. As explained above, appellant was directly charged by the complainant (injured) in the FIR.
- H. Incorrect. Appellant had gone into hiding and avoided appearing before the enquiry officer therefore, plea of the appellant regarding opportunity of cross examination was out of place.
- I. Para already explained above.
- J. Incorrect. Departmental proceedings and criminal proceedings are two different entities which can run parallel and fate of the one cannot effect the other.
- K. The respondents also seek permission of this Honourable Tribunal to advance additional grounds at the time of arguments.

DEPARTMENTAL INQUIRY AGAINST CONSTABLE SHAH FAHAD NO. 755

ALLEGATIONS:

Constable Shah Fahad No. 755, while posted at CDL Branch Nowshera, now under suspension Police Lines, Nowshera reportedly involved in case FIR No. 392 dated 02.06-2020 u/s 302/324/34 PPC PS Kalan, which amounts to grave misconduct on his part and rendered him liable for minor/major punishment under Kyber Pakhtunkhwa police Rules, 1975.

In this regard, the defaulter official was charge sheeted and the undersigned was nominated as Enquiry Officer.

PROCEEDING:

During the course of inquiry, the defaulter official was contacted time and again but his contact no. was found switched off. He is also evading from his lawful arrest.


FINDING:

From the circumstances cited above, it transpired that the defaulter officialalong with his family members went into hiding after commission of offence as well as evading form his lawful arrest.

RECOMMENDATIONS:

Keeping in view the above, he is recommended for ex-parte action against him, please.

ORDER.

This order will dispose-off the departmental appeal preferred by Ex-Constable Shah Fahad No. 755 of Nowshera District Police against the order of District Police Officer, Nowshera, whereby he was awarded major punishment of dismissal from service vide OB: No. 564 dated 14.07.2020. The appellant was proceeded against departmentally on the allegations that he while posted at Computerized Driving License (CDL) Branch, Police Lines Nowshera was found involved in Case FIR No. 397 dated 02.06.2020 u/s 302/324/34-PPC Police Station Nowshera, Kalan District Nowshera.

Proper departmental enquiry proceedings were initiated against him. He was issued Charge Sheet alongwith Statement of Allegations and Deputy Superintendent of Police Headquarter, Nowshera was nominated as Enquiry Officer. The Enquiry Officer after fulfilling codal formalities submitted his findings to District Police Officer, Nowshera, highlighted that the delinquent Officer went into hiding after commission of offence and evading his lawful arrest, therefore, recommended him for ex-parte action.

He was issued Final Show Cause Notice through Mosam Khan s/o Ažeem Khan r/o Zaidi Colony, Nowshera Kalan, cousin of FC Shah Fahad, but failed to submit his reply.

Consequently in the light of recommendations of enquiry Officer, an exparte action was taken against the delinquent Officer and he was awarded major punishment of dismissal from Service with effect from 02.06.2020 vide District Police Officer, Nowshera OE: No. 564 dated 14.07.2020.

the appellant preferred the instant appeal. He was summoned and heard in person in Orderly Room held in this office on 12.01.2021.

From the perusal of the enquiry file and service record of the appellant, it has been found that allegations of misconduct against the appellant have been proved beyond any shadow of doubt. Being a member of disciplined/uniformed force, the involvement of the delinquent Officer in such heinous crime brought a bad name for entire Police force in the eyes of general public. During the course of enquiry proceedings, the appellant did not bother to join enquiry proceedings. The retention of appellant in Police Department will stigmatize the prestige of entire Police Force as instead of fighting crime, he has himself indulged in criminal activities. Moreover, the appellant approached this forum at a belated stage without advancing any cogent reason regarding such delay. Hence, order passed by the competent authority does not warrant any interference.

Keeping in view the above, I, Sher Akbar, PSP S.St Regional Police Officer, Mardan, being the appellate authority, find no substance in the appeal, the same is rejected and filed, being time barred.

This order is hereby passed to dispose of Revision Petition under Rule 11-A of Khyber Pakhtunkhwa Police Rule-1975 (amended 2014) submitted by Ex-FC Shah Fahad No. 755. The petitioner was dismissed from service by District Police Officer, Nowshera vide OB No. 564, dated 14.07.2020 on the aliegations that he while posted at CDL Branch, Police Lines, Nowshera was found involved in case FIR No. 397, dated 02.06.2020 w/s 302/324/34 PPC Police Station Nowshera Kalan District Nowshera. His appeal was rejected being time barred by Regional Police Officer, Mardan vide order Endst: No. 228/ES,

Meeting of Appellate Board was held on 03.06.2021 wherein petitioner was heard in person. dated 14.01.2021. Petitioner contended that he is innocent and he was released on bail on compromise basis by the court of Additional Sessions Judge-I, Nowshera vide judgment dated 21.12.2020.

Perusal of record reveals that the applicant has effected compromise with the complainant which is tantamount to the admission of crime. Moreover, the retention of applicant in Police Department will stigmatize the prestige of entire Police Force as instead of fighting crime, he has himself indulged in criminal activities. The Board see no ground and reasons for acceptance of his petition, therefore, the Board decided that his petition is hereby rejected.
