Mr. Abdul Nasir Khattak, Advocate, for appellant is present.

The learned counsel for appellant contended that the respondents department issued notification regarding amendment in appointment and promotion policy vide notification no. SO(LG-I)2-188 SSRC/2018/981 dated 5th April 2018 which has been further amended through notification No. SO(E)L.G/2-188/SSRC/2019 dated 16th October 2019. Accordingly, 20% promotion to the post of Village Secretary was made from amongst the Naib Qasid and Chowkidar in Village Council at Tehsil level having SSC qualification in Second Division from recognized Board and six month diploma in IT from recognized Board with three years services. Appellant was fully qualified and eligible for promotion however, respondent No. 3 deprived the appellant from his due right and mala-fidely promoted private respondents No. 6 to 9 by means of an invalid order and against seniority rules by compiling a unique type of seniority list which is contrary to the principles and precedent of seniority vide impugned order No. 691/AD LG KK dated 18.02.2020. That clandestinely the orders were kept secret, however, appellant had already assailed the seniority list. Departmental appeal moved for the purpose but the same remained undecided even after the expiry of the statutory period of 90 days hence, the present service appeal.

The point so agitated at the bar needs consideration. The appeal is admitted for regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 26.04.2021 before S.B.



**APPEAL UNDER SECTION -4 OF K.P
SERVICE TRIBUNAL ACT 1974 AGAINST
THE IMPUGNED INCORRECT, ILLEGAL,
INVALID, UNFAIR AND AGAINST RULES,
REGULATION AND AGAINST
PROMOTION POLICY ORDER NO:
691/A-D L.G.KK DATED 18/02/2020
WHEREBY RESPONDENTS NO: 6 TO 9**

HAVE ILLEGALLY, UNLAWFULLY AND UNCONSTITUTIONALLY AND AGAINST GOVERNMENT POLICY BEEN PROMOTED FROM CLASS IV TO THE POST OF VILLAGE COUNCIL SECRETARIES AND APPELLANT HAS ILLEGALLY AND MALAFIDELY BEEN DEPRIVED OF HIS DUE RIGHT OF PROMOTION.

RESPECTFULLY SHEWETH:

The appellant submit as under:-

1. *That appellant was appointed as Class-IV i.e. Chowkidar in the office of AD, LG & RDD Karak and since then, performing his duties to best of his efficiency. (Copy of appointment order is annexed as annexure "A").*
2. *That the appellant has academic qualification of F.A and professional & technical qualification of Diploma in Information Technology. (Copies of Academic Qualification etc are annexed as annexure "B, C & D" respectively).*
3. *That respondent department issued Notification regarding amendment in appointment & promotion policy vide Notification No: SO(LG-I) 2-188 SSRC/2018/981 dated 5th April 2018 which has been further amended by another Notification No: SO(E) L.G/2-188/SSRC/2019*

dated 16th Oct 2019. (Copies of both notifications are annexed as Annexure "E & F" respectively).

4. That as per latest and final notification i.e annexure "E" of the appeal clause (F) (I) it has been laid down that 20% promotion to the post of Village Secretary will be made from amongst the Naib Qasid & Chowkidar in village council / neighborhood council with Seniority at Tehsil Level having (Matric) SSC in 2nd division from recognized board and six months diploma in I.T from recognized board with 3 years service/ experience.
5. That as per these notifications, the appellant is fully qualified and eligible for promotion to the post of secretary VC.
6. That respondent No:3 being well aware of these facts deprived appellant from his due right of promotion and malafidely promoted private respondents 6 to 9 by incorrect, invalid, unfair and against seniority rules, framed a unique type seniority list which is against the principle and precedent of seniority preparation through impugned order No: 691/A.D, LG KK dated 18/02/2020. (Copy of impugned promotion order dated 18/02/2020 annexed as annexure "G")
7. That the respondent No:3 kept the impugned orders very secret from appellant because the

appellant had already raised objection regarding the incorrect and invalid Seniority List. (Copies of Seniority List & Objection Petition is annexed as annexure "H & I" respectively).

8. That after receiving knowledge of the impugned order dated 18/02/2020, the appellant submitted departmental appeal / representation before the appellate authority i.e, respondent No: 2 on 16/03/2020. (Copy of Representation is annexed as annexure "J")
9. That now the statutory period of ninety (90) days has been lapsed, however, respondent No:2 has not responded fate of departmental representation of the appellant nor any information has been communicated to the appellant. So the same may kindly be considered as final order.
10. That now the appellant being aggrieved has no other adequate remedy except to approach this Hon'ble Tribunal for provision of justice, hence the instant service appeal is filed on the following grounds inter-alia:-

GROUNDS:

- A. The impugned promotion order No: 691/A.D, L.G KK issued by the office of respondent No:3 is illegal, void ab-initio and against the

impugned order issued by respondent No:3 is against the Tehsil level Seniority Policy of the Govt/ Department.

- B. That the impugned promotion order has been issued on the basis of wrong, incorrect and policy prepared seniority list, against which the appellant submitted objection through appeal.
- C. That respondent No:3 has misguided the DPC and out of total 12 posts reserved for Promotion Quota amongst Naib Qasids and Chowkidars only four (4) favorite employees have been promoted despite that six (6) were available, that is evident from minutes of the meeting of D.P.C on dated 17/02/2020. (Copy of meeting is attached as annexure "K")
- D. That in case of availability of fully eligible candidate including in seniority list promoting only 4 candidates and keeping 2 posts vacant is clear precedent of nepotism and favoritism and is example of pick & chose policy and personal like and dislike.
- E. That despite of clear cut policy of Tehsil level importing of candidate from another Tehsil and appointing him in foreign Tehsil is violation of Govt Notification i.e. Annexure "E" and policy of the Department.
- F. That promotion of ineligible employee is against rules and policy and notification of the Provincial Government.
- G. That the impugned disputed seniority list and subsequent impugned promotion order both are against the established norms and principles of rules and justice and both are not

sustainable in the eyes of law, rules and statutes.

H. That any other grounds if felt necessary will be agitated during arguments.

It is, therefore, very humbly prayed that on acceptance of the instant service appeal, the impugned promotion order NO: 691/A.D, L.G, KK dated 18/02/2020 issued by respondent No:3 as well as the impugned incorrect and against policy framed seniority list prepared by respondent No 3 may very graciously be declared against the law, rule and Governmental and departmental policy and kindly be declared as ineffective and void ab-initio and respondent No:3 may kindly be directed all 12 posts of VC Secretary reserved under 20 % Quota in accordance with Government Policy after considering the appellant and all other candidates in light of the Government Policy.

- a. That the parawise reply in the captioned Service Appeal is submitted as follows:

ON FACTS:

1. That Para No.1 pertains to record, however, the appellant has now been dismissed from service vide office Order No.312/ADLGKK dated 08.04.2021. (Copy of Order annexed as annexure "A").
2. Para No.2 pertains to academic record of appellant, therefore needs no reply.
3. Para No.3 also pertain to record.

4. Para No.4 also pertains to record, hence needs no reply.
5. Para No.5 is incorrect.
6. Para No.6 is incorrect. Respondents No.6 to 9 have been promoted from the post of Naib Qasid to the post of Village Secretaries well in accordance with law, the promotion, policy and rules.
7. Para No.7 is incorrect. Furthermore, tentative seniority list was prepared and circulated amongst the Naib Qasid/Chowkidar vide order No.577/ADLGKK dated Karak the 06.12.2019 and the receiving signature of appellant was obtained on the back of list ibid at serial No.2, however, no objection thereto was raised by the appellant within the stipulated period of seven days. (Copy of tentative seniority list alongwith office order No.577/ADLGKK dated 06.12.2019 is annexure as "B").
8. Para NO.8 is correct to the extent that appellant had filed a departmental Appeal, however, after considerable delay of about 2/3 months which is badly time barred. (Copy of letter No.720 dated 12.03.2020 is annexed as Annexure "C").

9. Para No.9 is incorrect. As stated above that the departmental Appeal of the appellant was badly time barred, however, in response to the letter No. Director (LG)3-40/compliants/2019/16346 dated Peshawar the 5th March, 2020, Para-wise comments had been submitted vide the letter No.720 dated 12.03.2020.
10. Para No.10 need no reply.

ON GROUNDS:-

- A. Para (A) is incorrect, the promotion order of Naib Qasid to the post of village Secretary was made strictly in accordance with rules/law, policy.
- B. That Para (B) is incorrect
- C. In response to Para (C) it is submitted that the meeting of DPC was held on 17.02.2020 whereby out of six vacant posts 04 posts were filled by promotion whereas rest of the two posts were reserved for the decision of Peshawar High Court Bannu bench at Tehsil Banda Daud Shah. (Copy of working paper No.677 dated 10.02.2020 and minutes of DPC meeting vide No.690/ADLGKK dated Karak the 10.02.2020 are annexed as Annexure "D" & "E").
- D. Para (D) is incorrect.

- E. Para (E) is incorrect. The promotion of Naib Qasid to the post of secretaries VC/NC is made well in accordance with the policy and rules.

That the petitioner is aggrieved by non-observing the 20% by promotion on the basis of seniority-cum-fitness from amongst the Naib Qaisds and Chowkidars to post of village secretary in the village / neighborhood council and as there is no other efficacious and adequate remedy is available to the petitioner hence the instant writ petition before this honourable court on the following grounds:

Grounds

- a. That non observing the 20% promotion amongst the existing / in service Naib Qasid and Chowkidar in LG & RDD by the respondents while issuing 46 number fresh appointment order of village secretary is illegal, unlawful, against the law & facts, therefore, respondents are liable to issue promotion order of petitioner from Naib Qasid to the post of Village Secretary in light of promotion policy mentioned above.
