**PRELIMINARY OBJECTIONS**

- i. The appellant has no cause of action and locus standi.
- ii. That the appeal is bad for non joinder of necessary parties and mis-joinder or un-necessary parties.
- iii. That the appellant has been estopped by his own conduct to file the appeal.
- iv. That the appeal is against the Law/Procedure and not maintainable in its present form.
- v. That the Honorable Tribunal has no jurisdiction to entertain the appeal.
- vi. That the appellant has not come to this honorable service tribunal with clean hands and suppressed the real facts from this Honorable Tribunal.
- vii. That the competent authority has passed the order after fulfillment of all the codal formalities. Hence the appeal is liable to be dismissed without any further proceedings.

**REPLY ON FACTS**

1. Pertains to record.

2. It is incorrect. The seniority list of forest guard as it stood on 31.12.2019 was maintained in accordance with the following rules and judgment.

- i. Forest Guards Service Rules 1962
- ii. Provisions contained in FR-14
- iii. Appointment, Promotion & Transfer Rules 1989 (Rule-17-Seniority)
- iv. Judgment passed by august Supreme Court of Pakistan in CRP, Original Petition No. 89/11, Circulated vide Govt. of Pakistan Cabinet Secretariat Establishment Division Islamabad, endorsed vide Govt. of Khyber Pakhtunkhwa Environment Department Litigation Section letter No. vide this office letter No. 7813-15/E dated 01.04.2014

Furthermore the departmental appeal of the appellant was rejected due to the following reasons:

"Mr. Sajjad Ahmad (appellant) was appointed as Forest Guard in Soka Nullah Watershed Project Abbottabad vide office order No. 48 dated 09.01.1990 and reported arrival in Siran Forest Division on 19.11.1996. Therefore the appellant was placed at serial No. 07 in seniority list according to his date of arrival in this Division.

It is worth mentioning that Soka Nullah Watershed Project Abbottabad was abolished / Defunct and the appellant have no right to claim his lien for the period he served in defunct projects. Furthermore, in this regard Judgment passed by august Supreme Court of Pakistan in CRP, Original Petition No. 89/2011 (2013/SCMR/1752) dated 12.06.2013 that:

***"Any backdated seniority cannot be granted to any absorbed, and his inter se seniority, on absorption in the cadre shall be maintained at the bottom as provide under the Rules regulating the seniority."***

3. It is incorrect. No right of the appellant has been deprived and seniority list was maintained as per rules in vogue, as already enunciated in para "2" above.

**REPLY ON GROUNDS**

A. The seniority list of forest guard as it stood on 31.12.2019 was maintained in accordance with the following rules and judgment. Hence there is no need to revise the seniority list.

B. It is incorrect. The appellant was appointed as Forest Guard in Soka Nullah Watershed Project Abbottabad vide office order No. 48 dated 09.01.1990 and reported arrival in Siran Forest Division on 19.11.1996. Therefore the appellant was placed at serial No. 07 in seniority list according to his date of arrival in this Division. It is worth mentioning that Soka Nullah Watershed Project Abbottabad was abolished/Defunct and the appellant has no right to claim his lien for the period he served in defunct projects as per Judgment passed by august Supreme Court of Pakistan in CRP, Original Petition No. 89/2011 (2013/SCMR/1752) dated 12.06.2013, which is reproduced as under:

***"Any backdated seniority cannot be granted to any absorbed, and his inter se seniority, on absorption in the cadre shall be maintained at the bottom as provide under the Rules regulating the seniority."***

On the other hand the respondent No. 5 & 6 are appointed on 27.7.1988 & 15.07.1990 respectively, in Agror Tanawal Forest Division, which is extant division and the respondent No. 7 was adjusted in Siran Forest Division on 09.09.1996. Therefore the appellant was placed junior than respondent No. 5, 6 & 7 in the light of above quoted judgment.

C. It is incorrect. No violation was done by the respondents as already elaborated in above paras. The appellant is just misleading the Honorable Tribunal by his frivolous, baseless, extravagant and self made story, which has no legal footing in the eye of law & rules in vogue.

D. It is incorrect. The date mentioned in the adjustment/appointment column of seniority list is the date from which service of the appellant was verified in Siran Forest Division and the date mentioned in remarks column is the date of office order No. 43 under which the services of the appellant were regularized in Siran Forest Division.


E. It is incorrect. The respondents No. 5, 6 & 7 are senior than the appellant as per provision contained in the Judgment of Honorable Supreme Court of Pakistan as already mentioned in Para "B". Hence, the appellant has not deprived from his right of promotion.


F. It is not correct. The appellant is just reiterating the same thing by blaming the respondents without any cogent reason/proof as already enunciated in above paras.


G. It is not correct. The previous seniority list was maintained in accordance with fundamental Rules i.e. FR-14 and other seniority rules but later on the respondent No. 02 issued instructions vide his letter No. 7242-44/E dated 28.01.2019 (annexure-E) to maintain seniority list in accordance with the rules quoted in Para "A". Therefore, in compliance with the instructions the respondent NO. 04 maintained seniority as per rules quoted in above mentioned letter.

H. The respondents seek permission to raise additional grounds during arguments.


It is therefore, humbly prayed that the subject appeal being frivolous, illegal and against the law may kindly be dismissed in the interest of justice ~~please~~.

The seniority list corrected by the respondent No: 2 which was circulated dated 31.12.2021 and subsequently final seniority list was circulated dated 31.05.2022. 



**PRELIMINARY OBJECTIONS**

- i. The appellant has no cause of action and locus standi. *to file the present appeal.*
- ii. That the appeal is bad for non joinder of necessary parties and mis-joinder or unnecessary parties.
- iii. That the appellant has been estopped by his own conduct to file the appeal.
- iv. That the appeal is against the Law/Procedure and not maintainable in its present form.
- v. That the Honorable Tribunal has no jurisdiction to entertain the appeal.
- vi. That the appellant has not come to this honorable service tribunal with clean hands and suppressed the real facts from this Honorable Tribunal.
- vii. That the competent authority has passed the order after fulfillment of all the codal formalities. Hence the appeal is liable to be dismissed without any further proceedings.
- viii. *That the appeal is barred by law and limitation.*

1. It is correct. That the Petitioner has filed the service appeal inadvertently against the tentative seniority list of forest guard dated 31.12.2019 and corrected seniority list dated 31.12.2021 as such to seniority list of 31.12.2019 was circulated to all effective strength of forest guards but after lapse of one month no omission / discrepancies received from all forest guards including petitioner. The final seniority list dated 31.05.2022 was circulated to all effective strength of forest guards including petitioner and on the base of same seniority all senior most forest guards including petitioner promoted to the rank of forester against the existing posts vide DFO Siran office order No. 32 dated 19.08.2022 (copy enclosed as Annexure-1, 2, 3 & 4).

2. It is correct. The service appeal heard in Service Tribunal Peshawar and comments reply filed by the respondents, the petitioner admitted that service appeal was not prepared properly accordingly to the fact of the case and also requested for correction of seniority list. The seniority list corrected by the respondent No. 2 which was circulated dated 31.12.2021 and subsequently final seniority list was circulated dated 31.05.2022. On the basis of that seniority the petitioner was promoted to the rank of forester as mentioned in para-1 (Annexure-2 & 3).

3. Incorrect. Upon the corrected seniority list the petitioner resultantly promoted to the rank of Forester (BPS-10) vide DFO Siran office order 32 dated 19.08.2022. The seniority of Forester to be maintain by respondent No. 1 the petitioner needs to prayer of any issue i.e. seniority and top of that consequential benefit before respondent No. 1.

4. It is incorrect. The consequential benefit so far relates to the petitioner has already been granted as explained in para-3.

5. Pertains to court. Needs no comments.

It is therefore humbly prayed that the subject appeal being baseless, illegal and against the law may kindly be dismissed, please.
