JUDGEMENT

FAREEHA PAUL, MEMBER (E): The appellant has impugned the notification dated 27.11.2019 whereby her junior colleagues have been promoted to the post of Principal (BS-18) and she, despite being senior and eligible for promotion, had not been considered for promotion, against which her appeal dated 08.04.2022 was not replied.

2. Learned counsel for the appellant heard and available record gone through.

3. From the perusal of record and arguments presented before the bench, it transpires that the appellant has impugned the promotion notification dated 27.11.2019 through which her junior colleagues were promoted and she had not been considered by the Provincial Selection Board in its meeting held on 23.09.2019. Under the rules, she had to

prefer departmental appeal within thirty days of the communication of the notification dated 27.11.2019, if she was aggrieved, but she did not do so. On 31.05.2020, she stood retired from government service on attaining the age of superannuation. It was on 08.04.2022 that a representation against the decision of PSB was submitted by the appellant to the Director Elementary and Secondary Education, which was not responded. It was noted that the departmental appeal/representation was submitted after lapse of two years and four months, which was badly time barred.

04. It is a well-entrenched legal proposition that when an appeal before departmental authority is barred by time, the appeal before Service Tribunal would be incompetent. In this case reference is made to cases titled "Anwarul Haq Vs. Federation of Pakistan" reported in 1995-SCMR-1505, "Chairman PIAC Vs. Nasim Malik" reported in PLD 1990 SC 951 and "State Bank of Pakistan Vs. Khyber Zaman and others" reported in 2004 SCMR 1426.

05. In the light of above discussion this bench does not find any merit in the instant service appeal and it is, therefore, dismissed in *limine*.

RESPECTFULLY SHEWETH:

1. That the Appellant was initially appointed as Arabic Teacher (BPS-9) on temporary basis at Government Girls Middle School, Dherma Khel, Bannu on 02.03.1985.

(Copy of Appointment Order is annexed herewith marked as 'A')

2. That during the course of her service the Appellant was promoted to the post of S.E.T (BPS-16) and she was allowed graded pay vide decision of Departmental Selection Committee in its meeting held on 04.09.1988.

(Copy of Promotion Order is annexed herewith marked as 'B')

3. That Appellant was again promoted to the post of Head Mistress in BPS-17 vide notification dated 01.03.2008 on regular Basis.

(Copy of Promotion Order dated 01.03.2008 is annexed herewith marked as 'C')

4. That it is pertinent to mention that the Appellant was placed at Serial No.13 in the seniority list of Head Mistresses (BPS-17).

(Copy of Seniority List is annexed herewith marked as 'D')

5. That the Respondent Department sent the names of the eligible Head Mistresses (BPS-17) for consideration for promotion to BPS-18 to the Provincial Selection Board, however, when the notification of the Respondent Department dated 27.11.2019 was issued, Officers Junior to the Appellant were recommended for promotion, while the name of the Appellant was ignored for reasons best known to the Respondents.

6. That the Appellant upon inquiry was told that she was not considered for promotion to BPS-18 as her PERs were not submitted within time. Needless to mention that the Appellant had no control over her PERs being sent late to the

PSB and as such she cannot be punished for the same being sent late by her Reporting Officer.

7. That the Appellant retired from service as Head Mistress BPS-17 on attending the age of superannuation on 31.05.2020.

(Copy of Notification dated 27.05.2021 is annexed herewith marked as 'F')

8. That the act of supersession of the Appellant from promotion to BPS-18 without any valid reason or grounds is illegal, unlawful and without lawful authority.
9. That the Appellant filed a representation for the redressal of her grievance but the same has not been replied to, hence the present appeal on the following amongst other grounds.

(Copy of Departmental Appeal is annexed herewith marked as 'G')

GROUND:

- A. That the Appellant has not been treated in accordance with law. The P.S.B has not followed the Law and Rules governing promotion, thus the secured and guaranteed rights of the Appellant are violated.
- B. That the Appellant was eligible for promotion despite that she was not considered for promotion.
- C. That consideration for promotion is a right under the law especially when the officer is otherwise fit and eligible for promotion.
- D. That the reason provided by the Respondents Department for not considering the Appellant for promotion is absurd and illogical.
- E. That the Appellant had no control over the submission of her PERs.

F. That the name of the Appellant was placed at S. No.13 of the revised seniority list and updated final Seniority List of female officers BPS-17 Elementary and Secondary Education.

G. That the supersession of the Appellant has caused a substantial loss in the pensionary benefits thus the same is a recurring cause of action.

H. That the Appellant seeks permission of this Hon'ble Tribunal to rely on additional grounds at the time of hearing of this appeal.

Prayer:

It is, therefore, most humbly prayed that on acceptance of this appeal the Respondents may kindly be directed to consider the Appellant for promotion to the post of Headmistress (BPS-18).

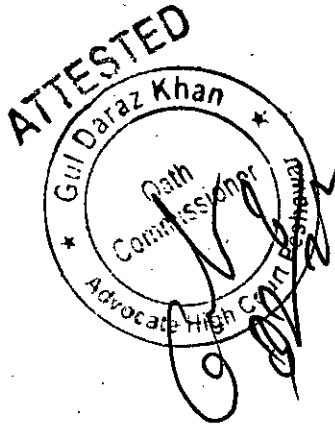





Subject: Representation against the decision of the PSB dated 23.09.2019, whereby the Applicant has been denied promotion to the post of Principal BPS-18.

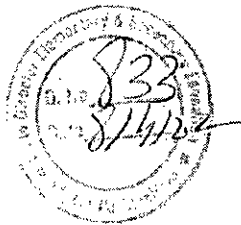
Respected Sir,

I would like to take this opportunity to bring to your kind attention that this Departmental Representation is against the decision of the Provincial Selection Board dated 23.09.2019, whereby the Applicant was not found fit for the promotion to BPS-18. Brief facts leading to filing of this representation are as follow;

1. That the Applicant was initially appointed as Arabic Teacher BPS-9 temporarily at Government Girls Middle School, Dherma Khel, Barinu on 02.03.1985.
2. That in the year 1987 the Applicant was promoted to the post of S.E.T BPS-16 and she was allowed graded pay vide decision of Departmental Selection Committee in its meeting held on 04.09.1988.
3. That the Applicant was promoted to the post of Head Mistress in BPS-17 vide notification dated: 01.03.2008 on regular Basis.
4. That the Applicant was fit and eligible for promotion to the post of Principal BPS-18. However, the Applicant was denied promotion by the Provisional Selection Board in its meeting held on 23.09.2019, whereas other colleagues

of the Applicant were promoted. Needless to mention that junior to the Applicant were also promoted, while her promotion was denied for no fault of her own.
