COMMENTS WRITTEN REPLY ON BEHALF OF RESPONDENTS NO 06 to 35

Respectfully Sheweth,

Written Reply / Comments, on behalf of the Private Respondents No. 06 to 35, are as under:

PRELIMINARY OBJECTIONS:

- I. That, the Appellant has got no locus standi or cause of action to institute titled Appeal.
- II. That, Appellant has challenged the Seniority List of Private Respondents who are performing their duties in BPS-11, while Appellant is still in BPS-09, hence without enlistment of Appellant's name in the Seniority List of BPS-11 in pursuance of Regular Promotion to BPS-11, he cannot challenge the Seniority of the Private Respondents.
- III. That, Appellant has not questioned the issuance of Promotion Order of Private Respondents in his Service Appeal, hence without claiming the right of consideration of promotion to BPS-11, the Appellant is estopped to claim only seniority from the separate cadre Answering Respondents.
- IV. That, earlier Seniority Lists which were issued by the Department from time to time, were never challenged by the Appellant hence claiming seniority from the Answering Respondents in the Impugned Seniority List is not practical for the Appellant.
- V. That, the Appeal of the Appellant does not disclose any cause of action against the Answering as well as Official Respondents hence liable to be dismissed on this score only.
- VI. That, the appellant has not come to this Tribunal with clean hands and has suppressed material facts and record.
- VII. That, the Appeal is not maintainable in present form.

REPLY ON FACTS:

1. Correct to the extent of Appointment of Appellant as well as Private Respondents, however it is clarified that a total of 276 candidates were appointed in one batch for the purpose of which NTS / Screening Test was carried out and candidates were screened out. Previously District Peshawar consists of 92 Union Councils moreover there were approximately 71 old / existing Union Council Secretaries (BPS-07) who were performing duties since 2001, when the posts in question were advertised.

On new delimitation in the year 2013, the 92 UCs were divided into 346 Village Councils / Neighborhood Councils. The old / existing secretaries were adjusted and the remaining posts were filled from the selected candidates. The test was conducted by NTS and the NTS marks were declared as screening vide notification issued on dated 4th September 2015. As, there was a single post of village secretary for each village council hence the merit list was prepared for each council, separately. It merits mentioning here that overall Merit List of all the candidates was not maintained because Appointment of Appellant as well as Answering Respondents was made on Village Council / Neighborhood Council basis.

The process of appointment was completed on the basis of merit of successful candidates from each VC / NC. It is worth to mention here that overall merit list is not practical / workable in the cases where Appointment is made on local / NC / VC basis.

2. Para 2 of the Appeal pertains to record and Rules of the Department hence needs no comments.
3. In response to Para 3 of the Appeal, it is submitted that the Seniority Lists issued by the Department were in accordance with law. If the Appellant felt aggrieved from the issuance of earlier Seniority Lists, he should have challenged the same before the appropriate forum i.e. departmentally or before the Tribunal however as per record no such exercise have been done by the Appellant, copy of the 1st Tentative Seniority List issued on 12.04.2019 is attached as Annexure-A.
4. Para 4 of the Appeal is not correct hence denied in Toto. Since the Final Seniority Lists was not questioned by any one including the Appellant hence on the basis of the said list, the Answering Respondents were promoted to the post of Senior Secretaries of VC / NC in BPS-11. It is further clarified that the issuance of Promotion

Order of Answering Respondents has also not challenged by the Appellant. Needless to mention here that Appellant has not annexed any Application with his Appeal regarding provision of Promotion Orders of the Answering Respondents to him, as alleged by him in his Service Appeal.

5. Correct to the extent of issuance of two different Final Seniority Lists by the Official Respondents however rest of the para regarding submission of Objections / Departmental Appeal is denied, as the same pertains to record and the Department will be in a better position to respond.

OBJECTION ON GROUNDS

- A. Incorrect, hence denied. The Seniority List was prepared in accordance with law & Rules. In whole of the province, the Junior Secretaries were promoted to Senior Secretaries on the same criteria.
- B. Incorrect, the seniority list was prepared in accordance with law & Rules. The merit list was prepared on Village Council / Neighborhood Council basis and not on the basis of whole District as discussed in response to Para-1 of the facts.
- C. Correct, to the extent that in the Tentative Seniority List the Appellant was at 176th position. However after removing the objections / observations, the final seniority list was issued in which the Appellant was relegated to 173rd position and after promotion of 30 Junior Village Secretaries to Senior Village Secretaries, the Appellant was placed on 146th position. The seniority list was not prepared on marks as already discussed in Para 1 of the facts.
- D. Incorrect, all Junior Village Secretaries were promoted to the post of Senior Village Secretaries on the basis of seniority-cum-fitness. The Final Seniority List was issued on 20.01.2020 and again that Seniority List was revised on 16.03.2021 after correction. The Appellant did not file Departmental Appeal against the Seniority List and the Respondent No. 06 to 35 were promoted from Junior Village Secretaries (BPS-09) to Senior Village Secretaries (BPS-11) on 30.07.2021 after completing all the codal formalities, against which no one including the Appellant knocked the door of any forum hence the Promotion Orders of the Answering Respondents and the issuance of Seniority List in pursuance of issuance of Promotion Orders for Senior Village Secretaries (BPS-11) have become final.

- E. Incorrect, since the basic Seniority Lists have not been challenged by the Appellant as per his own analogy hence challenging any subsequent Seniority List is not permissible in the eyes of law moreover the Seniority List dated 19.04.2022 relates to Senior Village Secretaries (BPS-11) which are total 73 in number (including 43 old / existing staff who were working as Secretaries since 2001 & 30 staff were promoted from junior Village Secretaries on dated 30.07.2021. The Answering Respondents from 06 to 35 were promoted from BPS-09 to BPS-11 on previous seniority list dated 20.01.2020 on 16.03.2021 and not on the basis of Seniority List dated 19.04.2022. Against the Seniority List dated 19.04.2022 the Appellant's stance has no legal footings to stand.


- F. Incorrect, the stance of the Appellant is illegal on the Seniority List as discussed in the above Para(s). The Merit List which is attached as Annexure-M, of appeal is fake and bogus. As the subject merit list is not signed by Selection Committee.

Additional grounds, if any will be submitted to the honorable Tribunal at the time of arguments of the appeal.

It is therefore, most humbly prayed that on acceptance of this Para-wise reply, the Appeal being devoid of legal merits may graciously be dismissed with cost.




