Learned counsel for the appellant argued that order dated 18.01.2017 (impugned order) of respondent No.3 whereby appointment order of the appellant as PHC Technician (MP) EPI (BS-12) dated 1908.2016, was withdrawn/cancelled retrospectively for fake/bogus diploma. However, the impugned order was communicated to the appellant on 22.09.2020 during pendency of his writ petition No. 5262-P/2019 filed in Peshawar High Court for release of salary as is evident from Peshawar High Court order dated 22.09.2020. He therefore, submitted departmental appeal on 10.10.2020 which was not responded within the stipulated statutory period, hence, the instant service appeal filed on 02.02.2021. Learned counsel for the appellant further contended that the appellant had been appointed after due process of selection by the Departmental Selection Committee and ACR's on his performance also written during his four years service. He has been condemned unheard and no opportunity of show cause notice given to the appellant by the respondent-department. The ends of justice have not been met and his services have been dispensed with in an arbitrary manner. He requested that the appeal may be allowed and the appellant re-instated in service with all back benefits.




Points raised need consideration. The appeal is admitted to regular hearing, subject to all just and legal objections including limitation. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time or extension of time is not sought, the office shall submit the file with a report of non-compliance. File to come up for arguments on 24.12.2021 before the D.B.

APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE ORDER DATED 18.01.2017 COMMUNICATED TO THE APPELLANT ON 22.09.2020 DURING THE WRIT PETITION NO.5262-P/2019, WHEREBY THE APPOINTMENT ORDER OF THE APPELLANT HAS BEEN CANCELLED/WITHDRAWN AND ALSO FOR RELEASE FOR SALARIES FROM THE DATE OF APPOINTMENT I.E 19.08.2016 TILL 22.09.2020 AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF ETH APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE ORDER DATED 18.01.2017 MAY KINDLY BE SET ASIDE AND THE RESPONDENTS MAY BE DIRECTED TO REINSTATE THE APPELLANT INTO SERVICE WITH ALL BACK AND CONSEQUENTIAL BENEFITS. THE RESPONDENTS MAY KINDLY BE FURTHER DIRECTED TO RELEASE THE

SALARIES OF THE APPELLANT WITH EFFECT FROM 19.08.2016 TILL 22.09.2020 AS DURING THAT PERIOD THE APPELLANT HAS PERFORMED HIS DUTY. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:


1. That some posts of EPI Tech were advertisement, the appellant filed proper application for the said post and after the proper recommendation of the Selection Committee the appellant was appointed as EPI Technician vide order dated 19-08-2016. After appointment the appellant got medical fitness from the DHQ Hospital Charsadda and reported his arrival on 24-08-2016 at BHU Daki as per orders. (Copies of application, appointment order dated 19/08/2016, medical fitness and arrival report are attached as Annexure-A,B,C&D)
2. That since the appointment the appellant was continuously performing his duty upto the satisfaction of his superior and the same is evident from the attendance register and annual reports of the appellant duly signed by the reporting officer and further endorsed by countersigning officer. (Copies of the attendance register and annual reports are attached as Annexure-E&F)
3. That appellant has been continuously performing his duty without any break, but without any reason the salaries of the appellant have not been released. The appellant also submitted various applications to the concerned authorities for release of his salaries, but no action has been taken on his application. (Copy of applications are attached as Annexure-G)
4. That as no action has been taken on his applications for release of his salaries, therefore, the appellant was constrained to file the Writ Petition No. 5262-P/2019 in the Hon'ble Peshawar High Court, Peshawar and during the proceeding of the case, comments were submitted by the respondent department in which the cancellation/withdrawn appointment order dated 18-01-2017 was handed over to the appellant through his counsel on 22-09-2020 and the Hon'ble court dismissed the case of the appellant as withdrawn with remarks the appellant however would be at liberty to challenge the cancellation order before the competent forum if so advised on 22.09.2020. (Copies of the writ petition No. 5262-P/2019,

withdrawn/cancelled on the wrong pretext and as such the order dated 18.01.2017 is liable to be set-aside.


- E. That if the appointment order of the appellant was cancelled on 18.01.201, then why he was not informed in time about his cancellation of his appointment order and allowed him to perform his duty till 22.09.2020 and why his annual reports of 2016, 2017 and 2018 was signed and counter signed by the authorities and if the department took duty from the appellant, the department is bound to pay salaries for that period.
- F. That no inquiry was conducted on diploma of the appellant and the appellant appointment order was withdrawn/cancel, which is violation of law & rules.
- G. That no charge sheet was issued against the appellant before passing the impugned order which is against the Law & Rules.
- H. That even show cause notice has not been issued to the appellant which is violation of rules & norms of justice.
- I. That the appellant has been condemned unheard and has not been treated according to law and rules.
- J. That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.

Consequent upon the recommendation of the Selection Committee in its meeting held on 19-08-2016 under the chairmanship of the undersigned and relaxation in upper age limit to the extent of 01 year 03 months & 02 days being competent authority, Mr. Shahzad Alamgir s/o Yar Jan resident of Vill Karbala PO Mandani, Tehsil Tangi Distt Charsadda is hereby appointed as PHC Technician (MP) for EPI BPS-12 (11140-800-35140) plus usual allowances as admissible to him under the rules at BHU Dhakki against the vacant post on the following terms and conditions.

1. He will remain on probation for a period of one year.
2. His services can be dispensed with/without any notice during the probation period, if his work and conduct found unsatisfactory.
3. He will be entitled to all benefits as admissible under the rules for Government Employees.
4. His appointment will be subject to medical fitness certificate from the Medical Superintendent DHQ Hospital Charsadda.
5. He will be governed by such rules and orders as may be issued by the Govt of Khyber Pakhtunkhwa from time to time for the category of Govt servant to which he belongs.
6. He will not be entitled to claim any TA/DA for medical examination and joining the first appointment.
7. His documents will be verified from the concerned board/university/medical faculty, if the documents found bogus/fake after the verification, his order of appointment will be automatically cancelled besides taking other legal action against him under the rules and by making recovery of pay and allowances.
8. If he wishes to resign from services, he will have to submit resignation in writing one month in advance or forfeit one month's pay in lieu thereof and will continue to serve till the acceptance of his resignation by the competent authority.

If he accepts the above terms & conditions, he should report to I/C BHU Dhakki within 14 days after the receipt of this order failing which the order will be considered cancelled/withdrawn.

THE RESPONDENTS MAY FURTHER PLEASE BE DIRECTED TO RELEASE THE SALARIES OF THE PETITIONER FORTHWITH. ANY OTHER REMEDY DEEMS APPROPRIATE BY THIS COURT MAY ALSO AWARDED IN FAVOR OF PETITIONER.

Brief facts giving rise to present petition are as under:-

1. That the petitioner is the citizen of Pakistan and has every legal and Constitutional right duly protected under the law of the Land.
2. That after the proper recommendation of the Departmental Selection Committee, the petitioner was appointed as EPI Technician/PHC Technician vide order dated 19.08.2016. After appointment, the petitioner got medical fitness from the DHQ Hospital Charsadda and reported his arrival on 24.08.2016 at BHU Daki as per orders. Copies of orders, medical fitness & arrival report are attached as Annexure-A, B & C, respectively.
3. That since the appointment the petitioner has been continuously performing his duty upto the satisfaction of his superior and the same is evident from the Annual Reports of the petitioner duly signed by the Reporting Officer and further endorsed by countersigning officer. Copies of the Annual Report for the years 2016, 2017 & 2018 is attached as Annexure-D.
4. That the petitioner has been continuously performing his duty without any break but without any reason the salaries of the petitioner have not been released though the petitioner submitted various applications to the District Health Officer Charsadda which are totally gone un-responded till date and finally the petitioner filed appeal to the DGHS, who was kind enough to direct the DHO to furnish comments vide memo dated 16.07.2019 but till date no comments, whatsoever, have been furnished by the DHO Charsadda to the worthy DGHS. Copies of appeal to the DHO are attached as Annexure -E, and appeal to DGHS & memo are attached as Annexure-F & G.
5. That as there is no order in black white regarding the stoppage of the salaries of the petitioner nor any kind of order has been passed on the appeals of the petitioner due to which the petitioner unable to approach the KP Service Tribunal due to legal bar of "An order or original or appellate". Therefore the petitioner is constrained to file the instant writ petition under Article-199 of the Constitution of Pakistan for enforcing his fundamental right protected under Article-4, 9 & 11 of Constitution

GROUNDS:

- (95)
- A) That non payment of the salaries to the petitioner despite performing his duty continuously and not taking any action or passing any order on the appeal of the petitioner is against the law, facts, norms of justice and material on record, therefore, the same could not be legally protected.
- B) That as the petitioner has been performing his duty regularly, which is evident from the Annual Report (Annexure-D), but without any salaries which certainly amounts to forced labor and which is prohibited under Article-11 of the Constitution of Islamic Republic of Pakistan therefore such acts and conduct on the part respondents is totally unconstitutional.
- C) That the petitioner despite performing regularly duties but without salary and that too in absence of any order regarding stoppage of salaries, ultimately affects the life of the petitioner and his dependents. Thus due to illegal acts of the respondents the right to live and to be dealt in accordance with law as ensured under Article-4 & 9 of the Constitution are badly affected and amounts to depriving the petitioner and his dependents from life.
- D) That this august Court in similar situation in case reported as 2014 PLC (C.S) Page#330 condemned the stoppage of salaries of the employees and directed the concerned department to release the salaries of the petitioner in that writ petition.
- E) That similarly in an other judgment reported as 2005 PLC (C.S) 886 this Honorable Court held that "appointment of the petitioner was in accordance with the rules and regulation against the regular sanctioned post which was vacant on the day of appointment and the petitioner performing her duties was entitled to full emoluments in her grade and pay scale with all admissible allowances as there was no provision or concept of service without salary under the Law. In such circumstances the performance of petitioner also amounted to forced labor". The said writ petition was allowed and the cost of Rs. 10000/- was imposed upon the respondents.
- F) That this Honorable Court has already decided in similar writ petition No. 2351-P/2017 which was heard on 19.03.2019 and the respondents were directed to release the salaries. Thus the petitioner also deserves same treatment under the principle of equity and equality. Copy of Judgment is attached as Annexure-H
- G) That the petitioner has not been dealt in accordance with law and rules and the inaction and conduct of the respondents is against the Article-2A, 4, 9, 11, 25 & 38 of the Constitution.

- H) That the petitioner seeks permission to advance other grounds and proofs at the time hearing.


It is, therefore, most humbly prayed that on acceptance of this writ petition, the august Court may be pleased to :-





5. That now the appellant wants to file departmental appeal against the order dated 18.01.2017 communicated to the appellant on 22.09.2020 during the proceeding in Writ Petition No. 5262-P/2019 & for release of salary w.e.from appointment order dated 19.08.2016 till 22.09.2020

GROUNDS:-

- A. That the order dated 18.01.2017 and not release the salary of the appellant w.e.from 19.08.2016 till 22.09.2020 are against the law facts, norms of justice & material on record therefore not tenable.
- B. That the appellant has regularly performed his duty from the date of appointment dated 19.08.2016 till 22.09.2020 & under Article-11 of the Constitution of Islamic Republic of Pakistan is legally entitled of salaries for that period.
- C. That the order dated 18.01.2017 it was mentioned that the Diploma of the appellant has declared fake/bogus by Chief Executive Officer Faculty of Paramedical & Allied Health Science Khyber Pakhtunkhwa, Peshawar vide letter dated 12.01.2019 but the appellant has never applied to the post on the Diploma obtained from Faculty of Paramedical & Allied Health Science Khyber Pakhtunkhwa, Peshawar and he applied PHC Technician for EPI on the Diploma obtained from Skill Development Council which shows that the appointment order of the appellant has been withdrawn/cancelled on wrong pretext and as such the order dated 18.01.2017 is liable to be set-aside.
- D. That no inquiry was conducted on the Diploma of the appellant and the appellant appointment order was withdrawn/cancel which is violation of Law & Rules.
- E. That no charge sheet was issued to the appellant before passing the impugned order which is against the Law & Rules.
- F. That even show cause notice was not issued to the appellant which is violation of Rules & norms of justice.






4. Pursuant thereto, petitioner submitted his arrival report and medical report on the same date. Therefore, at this stage, it does not lie in the mouth of

respondents to say that petitioner's appointment was not made by a Competent Authority.
