2. Learned counsel for the appellant and learned District Attorney for the respondents have been heard. The learned counsel for the appellant submitted that though the appellant was promoted on the basis of DPC held on 19.01.2022 vide Notification dated 27.01.2022, yet remaining part of the relief prayed in the appeal was not granted rather the promotion was made with immediate effect. The learned counsel for the appellant referred to page-41 of the appeal, which is said to be the impugned order dated 08.10.2019, which shows that the case of the appellant for promotion was considered in the DPC meeting held on 05.07.2013 but he was deferred due to incomplete ACRs for the period from 11.07.2008 to 31.12.2008, 2009, 2010, 2011 and 2012. Again his case was discussed in the

meeting of the DPC held on 02.07.2015 and was once again deferred from promotion because of incomplete ACRs for the period from 01.01.2011 to 30.07.2011, 14.04.2012 to 31.12.2012, 01.01.2013 to 31.12.2013 and 01.01.2014 to 31.12.2014, however, it was stated in the letter/impugned order that a DPC meeting, regarding promotion of Junior Clerks to the rank of Senior Clerks, will be held shortly wherein the name of the appellant appeared at serial No. 42 of the seniority list of Junior Clerk to be considered for promotion. Therefore, both the learned counsel for the appellant as well as the District Attorney agreed that as the appellant has been promoted, therefore, regarding rest of the relief the matter may be remitted to the Authority for decision in accordance with the relevant law and rules because there was no decision made on the departmental representation and only the matter of promotion of the appellant was deferred twice as is evident from the letter dated 08.10.2019. Order accordingly, the Authority concerned shall decide the matter within 60 days of the receipt of this order. The date of receipt of the order shall be communicated to the Registrar of this court. Similarly the decision taken shall also be communicated to the appellant as well as the Registrar of this Tribunal. Consign.
