



**APPEAL U/S 4 OF THE SERVICE TRIBUNAL ACT,
 1974 AGAINST SENIORITY LIST DATED 28-09-
 2022 OF R. NO. 01 WHEREBY APPELLANT BEING
 SENIOR WAS PLACED BELOW R. NO. 03 TO 11 IN
 VIOLATION OF LAW AND RULES.**

Respectfully Sheweth:

1. That on the recommendation of Departmental Selection Committee, appellant was appointed as Naib Qasid against newly created post in the office of Advocate General, Peshawar. (Copy as annex "A")
2. That on 31-12-2013, in the Final Seniority List the name of appellant was placed at S. No. 43. (Copy as annex "B")
3. That on 31-03-2016, Tentative Seniority List of the various employees of AG office was circulated wherein the name of appellant was placed at S. No. 37. (Copy as annex "C")
4. That in the year 2017, appellant passed SSC examination. (Copy as Annex "D")
5. That on 07-09-2017, other incumbents of the office were promoted to the post of Junior Clerk B-11. (Copy as Annex "E")
6. That on 31-12-2019, Tentative Seniority List of the AG office was circulated wherein name of appellant was placed at S. No. 29. (Copy as Annex "F")
7. That in the rules the post of Junior Clerk was to be filled in having 2nd class Intermediate Certificate or equivalent qualification and speed of 30 words per minute in typing.
 - a. 40% by promotion on the basis of seniority cum fitness from amongst the Daftaris, Naib Qasid and other officials having equivalent posts with two years service as such and having qualification prescribed for initial recruitment and
60 % by initial recruitment. (Copy as annex "G")
8. That on 31-03-2021 common Tentative Seniority List was issued wherein name of appellant was placed at S. No. 17. (Copy as annex "H")
9. That on 27-05-2021, appellant objected the said seniority list on the ground that incumbents at S. No. 06 to 16 were appointed later than him. (Copy as annex "I")

10. That on 31-05-2022, again common Tentative Seniority List was circulated wherein name of appellant was placed at S. No. 15. (Copy as annex "J")
11. That on 28-09-2022, Final Seniority List of the office was circulated wherein the name of appellant was figured at S. No. 15 with date of appointment as 13-10-2012 while of the others the year 2014. (Copy as annex "K")
12. That on 29-09-2022, appellant submitted representation for correction of the seniority list before R. No. 01 but without any response. (Copy as annex "L")
13. That on 05-10-2022, the contested respondents were promoted to the post of Junior Clerk B-11, despite the fact that they were most junior to appellant. (Copy as annex "M")
14. That on 06-10-2022, appellant was issued DMC of FA issued by the Board. (Copy as annex "N")
15. That on 18-10-2022, appellant submitted representation before R. No. 01 for correction of the seniority list but of no avail. (Copy as annex "O")

Hence this appeal, inter alia, on the following grounds:-

GROUNDS:


- a. That in the former seniority lists till 2019, appellant was placed senior to the contesting respondents.
- b. That as and when any change in any seniority list is required by placing senior as junior, notice for the purpose is mandatory to be served upon the aggrieved person by giving reason of the change but in the case in hand, no such notice was ever served upon appellant.

- c. That appellant was agitating issue of seniority since 27-05-2021 but the same was not corrected. In the meanwhile qualifications were enhanced but the same have no adverse effect upon the case of appellant having no retrospective effect.
- d. That in the seniority list dated 31-03-2021 and 31-05-2022, name of appellant was placed at S. No. 17 by showing his entry into service on 13-10-2012, while the same of contesting respondents since S. No. 05 was shown in service 20-11-2012, 16-01-2013, 11-04-2013, 21-05-2014, 17-07-2014, 19-07-2014, 21-07-2014, 22-7-2014 and 04-08-2014. Such dates clearly show that respondents are much junior than appellant.
- e. That seniority under the law, cannot be finalized on the basis of qualification but on 1st entry into service and as is evident from the said dates, appellant entry into service was much earlier than others.
- f. That seniority amongst appellant and contesting respondents was in dispute but the issue was not finally resolved when juniors were promoted to the post of Senior Clerks for no legal reason and as per the judgment of the apex court, no such promotion could be made until and unless seniority position is not resolved.
- g. That R. No. 01 was bent upon to make contesting respondents senior to appellant to promote them by leaving aside senior without any reason, justification and against seniority rules and law.
- h. That neither seniority list dated 28-09-2022 nor promotion dated 05-10-2022 of the respondents is per the mandate of law, so are based on favoritism and malafide.


It is, therefore, most humbly prayed that on acceptance of the appeal, seniority list dated 28-09-2022 be modified / corrected and appellant be placed at S. No. 05 above the name of Ibrahim and below the name of Abdur Rehman, with such other relief as may be deemed proper and just in circumstances of the case.

OFFICE ORDER

On the recommendations of the Departmental Selection Committee, Mr. Usman Ali S/O Ummat Khan is hereby appointed as Naib Qasid (BPS-01) against the newly created vacancy in the office of Advocate General, Khyber Pakhtunkhwa, Peshawar with immediate effect on the following terms and conditions -

1. He will get pay at the minimum of BPS-01, including usual allowances as admissible under the rules. He will be entitled to annual increment as per existing policy
2. He shall be governed by the NWFP Civil Servants Act, 1973 and all the laws applicable to the Civil Servants and Rules made there under.
3. He shall, for all intents and purposes, be a Civil Servant except for purpose of pension and gratuity. In lieu of pension and gratuity, he shall be entitled to receive such amount as would be contributed by him towards Contributory Provident Fund (C.P. Fund) alongwith the contributions made by Government to his account in the said fund, in the prescribed manner.
4. He shall produce Medical Certificate of fitness from the Medical Officer.
5. In case, he wishes to resign at any time 14-days notice will be necessary or in lieu thereof 14-days pay will be forfeited.
6. He has to join duties at his own expenses.
7. If he accepts the post on the above terms and conditions, he may report for duty in the office of Advocate-General, Khyber Pakhtunkhwa, Peshawar within fifteen (15) days of receipt of this offer. In case of failure, this office order will be treated as cancelled.

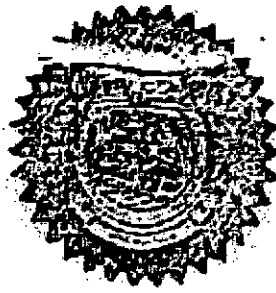



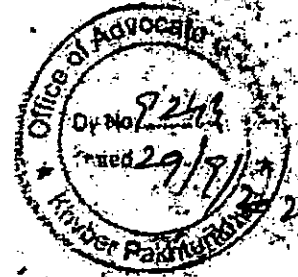
