APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 29.03.2023 WHEREBY THE TRANSFER ORDER OF THE APPELLANT HAS BEEN WITHDRAWN BY THE RESPONDENT AND AGAINST THE ORDER DATED 29.03.2023 WHERE BY THE PRIVATE RESPONDENT HAVE BEEN TRANSFERRED/POSTED AGAINST THE APPELANT POST OF DM BPS-15 AT JATTAN BNDA KARAK IN UTTER VIOLATION OF TRANSFER POSTING POLICY AND AGAINST THE APPELLATE ORDER DATED 07.04.2023 WHEREBY THE DEPARTMENTAL APPEAL OF APPELLANT WAS REJECTED WITHOUT ANY RESON.

PRAYER:

That on acceptance of this appeal the impugned withdrawn order dated 29.03.2023, transfer order dated 29.03.2023 of the private respondent and appellate order dated 7.04.2023 may very kindly be set aside and the respondents may kindly be directed not transfer the appellant from GMS Jattan Banda district Karak. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH: ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- **1**-That the appellant is a law abiding and peaceful citizen serving the respondents department, as DM BPS-15 Quiet efficiently and to the entire satisfaction of their high ups.

- 7-That feeling aggrieved and having no other remedy the appellant filed the instant appeal on the following grounds amongst the others.

GROUNDS:

- A- That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 are against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.
- **B-**That the appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- **C-** That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 has been issued by the respondents in arbitrary and mala fide manner, hence not tenable and liable to be set aside.
- **D**-That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 are based on discrimination, favoritism and nepotism, hence not tenable in the eye of law.
- **E-** That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 are neither been in the best interest of public service nor in exigencies of service, hence not tenable and liable to be set aside.
- **F-** That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 are nothing but to harass the appellant and to accommodate her blue eyed person.
- **G**-That it is important to mentioned here the that the privet respondent was regularized through notification dated 19/12/2022, in which it is mentioned in the condition of the ibid notification that they shall perform duty for at least three years, therefore the impugned transfer order is also violative of the ibid notification. Copy of the notification is attached as annexure.

H-That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 7.04.2023 are violative of Clause-I, IV and XIII of the transfer/posting policy of the Government of Khyber Pakhtunkhwa as the appellant has been

Terms and conditions

- 1. Their services shall be governed by the Khyber Pakhtunkhwa Civil Servant Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regularity Act 2011, and such rules and regulation us may be issued from time to time by Government.
- 2. Their service will be considered regular and they shall be eligible for pension/deduction of GP Fund in terms of Khyber Pakhtunkhwa Civil Servant Act, 1973, as amended in 2013, however, the teachers appointed on or after 07/06/2022 shall deal with section (2)(2) of the Khyber Pakhtunkhwa (Amendment) Act.2022.
- 3. Their services are llable to termination on one-month notice from either side. In case of resignation without notice, their one month pay/allowances shall be forfeited to the Government.
- 4. They shall possess the same qualification and experience required for the subject post on regular basis as specified in section (3) (a) of the Act.
- 5. Their regularization shall not affect the service promotion quota of all service cadres as specified in Section (3) of the Act.
- 6. They shall be entitled for seniority and pay from the date of initial appointment on Adhoc/Contract basis as Specified in Section (30 (d) of the Act.
- 7. They Shall perform duty for at least three years from the date of taking over charge where they were appointed/ posted initially.
- 8. The regularization shall not be in favor of those teachers who have not taken over charge, remained absent from duty and resigned from service.
- 9. The teacher, regularized through this notification, shall be confirmed after successful completion of In- service mandatory training as specified in their Service Rules notified vide notification No SO (PE) 4- 5/SSRC/Meeting/2012/Teaching Cadre/2017 dated 07/03/2017 within two consecutive attempts otherwise their appointment orders shall be considered as withdrawn/cancelled from the date of declaration of result of the second attempt made in the induction program

BOSTING / TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.

All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants

NNIEXURE"].". +

All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.

All contract Government employees appointed against specific posts, can not be posted against any other post.

The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.

While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained

²While making postings/transfers of officers/officials up to BS-17, from settled areas to FATA and vice-versa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.

All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.

Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thaana) of his area/residence is situated.

ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.

To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned officially in Constitution

Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.

i) Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.

ii) Serious and grave personal (humanitarian) grounds.

2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule – IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-
