#### R/SHEWETH: ON FACTS:

## Brief facts giving rise to the present appeal are as under:-

- 1-That the appellant is a law abiding and peaceful citizen serving the respondents department, as DM BPS-15 Quiet efficiently and to the entire satisfaction of their high ups. 2-That through an office order dated 18.03.2023 the appellant was mutually transferred from GHS Gumbati and posted at GMS Gattan Banda District Karak. Copy of the office order dated 18.03.2023 is attached as Annexure ..... 3-That the appellant in response to the said transfer order took over the charge against the said post started performing his duty quite efficiently and up to the entire satisfaction of his superiors. Copies of charge report and attendance sheet are attached Annexure..... 4-That the appellant started performing his duty quite efficiently and up to the entire satisfaction of his superiors against the said post but astonishingly the respondent department issued the impugned order dated 29.03.2023 whereby the transferred order of the appellant was withdrawn. Copy of the impugned order dated 29.03.2023 is attached as Annexure..... 5-That through subsequent impugned office order dated 29.03.2023 the private respondent Bilal Anwar was transfer and posted against the post of DM BPS-15 GMS Jattan Banda District Karak, against the post of appellant. Copy of the Impugned order dated 29.03.2023 is attached as Annexure ..... 6-That Appellant feeling aggrieved from the impugned transfer order dated preferred Departmental appeal before the appellate authority but the same has been rejected through appellate order dated 07.04.2023, without any reason and justification. Copy of the Departmental appeal
- **7-**That feeling aggrieved and having no other remedy the appellant filed the instant appeal on the following grounds amongst the others.

#### **GROUNDS:**

- A-That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 are against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.
- B-That the appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- **C-** That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 has been issued by the respondents in arbitrary and mala fide manner, hence not tenable and liable to be set aside.
- D-That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 are based on discrimination, favoritism and nepotism, hence not tenable in the eye of law.
- **E-** That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 are neither been in the best interest of public service nor in exigencies of service, hence not tenable and liable to be set aside.
- **F-** That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 07.04.2023 are nothing but to harass the appellant and to accommodate her blue eyed person.
- G-That it is important to mentioned here the that the privet respondent was regularized through notification dated 19/12/2022, in which it is mentioned in the condition of the ibid notification that they shall perform duty for at least three years, therefore the impugned transfer order is also violative of the ibid notification. - H-That the impugned withdrawn order dated 29.03.2023, impugned transfer order 29.03.2023 and appellate order dated 7.04.2023 are violative of Clause-I, IV and XIII of the transfer/posting policy of the Government of Khyber Pakhtunkhwa as the appellant has been





#### ROSTING / TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.

- All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
  - ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
  - iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.


    While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained
    - <sup>2</sup>While making postings/transfers of officers/officials up to BS-17, from settled areas to FATA and vice-versa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.
  - vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.

  - ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
  - x) All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.

Para-1(v) regarding months of March and July for posting/transfer and authorities for relaxation of ban deleted vide letter No; SOR-VI (E&AD) 1-4/2008/Vol-¥1, dated 3-6-2008.

Consequently authorities competent under the NWFP Government Rules of Business, 1985, District Government Rules of Business 2001, Posting/Transfer Policy and other rules for the time being in force, allowed to make posting/transfer subject to observance of the policy and rules. 


- While considering posting/transfer proposals all the concerned authorities shall keep xiii) in mind the following:
  - To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned office officials by
    - Tenure on present post shall also be taken into consideration and the posting transfers shall be in the best public interest.











- Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.
  - Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.
  - Serious and grave personal (humanitarian) grounds. ii)

To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule - IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-

- As per Rule 25(2) of the Rules mentioned above the District Coordination Department shall consult the Government if it is proposed to:
  - Transfer the holder of a tenure post before the completion of his tenure or extend the period of his tenure.
  - Require an officer to hold charge of more than one post for a period exceeding two months.
- I am further directed to request that the above noted policy may be strictly observed /implemented.

All concerned are requested to ensure that tenures of the concerned officers/officials are invariably mentioned in summaries submitted to the Competent Authorities for Posting/Transfer. {Authority: Latter No: SOR-VI/E&AD/1-4/2003 dated 24-6-2003}.

It has been decided by the Provincial Government that posting/transfer orders of all the officers up to BS-19 except Heads of Attached Departments irrespective of grades will be notified by the concerned Administrative Departments with prior approval of the Competent Authority obtained on the Summary. The Notifications/orders should be issued as per specimen given below for guidance.

BS-20 and above and Heads of Attached All posting/transfer orders of Departments (HAD) shall be issued by the Establishment Department and the Administrative Departments shall send approved Summaries to E&A Department for issuance of Notifications.
