Counsel for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant while addressing his arguments contended that the appellant was initially appointed as CT (BS-15) on adhoc basis vide appointment order dated 31.05.2014 whose services were regularized from the date of appointment on CT post vide notification endorsement dated 19.03.2018. The appellant, therefore, stood at serial No. 1 of the said notification. On completion of the required length of service (5 years) for promotion to the post of Senior CT (BS-16), the appellant moved a departmental appeal for promotion on 13.03.2020 which was accordingly forwarded to respondent No.3. During pendency of his departmental appeal the appellant also went in writ petition No. 1268-B/2020 dated 14.12.2020 to Peshawar High Court, Bannu Bench. The writ petition was however disposed of on 19.01.2021 with the direction to respondent No.3 "to honour and implement the directions issued by the Director Elementary and Secondary Department Khyber Pakhtunkhwa, Peshawar vide letter No. 4368/F No. promotion CT to SCT Karak dated Peshawar the 12.06.2020 strictly in accordance with law". He further contended that the appellant is aggrieved of the impugned order dated 29.03.2021 when he was declared as ineligible for promotion from CT(BS-15) TO Senior CT(BS-16) whereas during pendency of his departmental appeal a notification promoting 47 CT(male) to the ost of senior (CT (BS-16) was issued on 28.02.2020. The date of regular appointments of the appellant, on regularization, is reckoned from 31.05.2014 i.e being his initial appointment as CT whereas those of the promoted CT is 16.05.2014 stand junior to him. It was further contended that the appellant has been treated discriminatory and the requirements of Section-8, 9 of the Civil Servants Act, 1973 read with Rules-7 of the Khyber Pakhtunkhwa Government Servants (Appointment, Promotion and Transfer) Rules 1989 have not been fulfilled. The impugned order dated 29.03.2021 being violative of the fundamental rights of the appellant is liable to be set aside and due rights of the appellant for promotion to the post of senior CT (BS-16) be allowed from the date his erstwhile juniors were promoted.

Points raised need consideration. The appeal is provisionally admitted to regular hearing, subject to all just and legal objections including limitation. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the fespondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time or extension of time is not sought, the office shall submit the file with a report of non-compliance. File to come up for arguments on 31.01.2022 before the D.B.

Any other remedy which this August Tribunal deems fit that may also be awarded in favor the appellant.

R/SHEWETH: ON FACTS:

Brief facts giving rise to the present case are as under:

- 3- That the respondent No.3 vide notification dated 19.03.2020 held Departmental Promotion Committee wherein the colleagues of the appellant i.e AT,TT,DM,PET's (BPS-15) were given promotion to the post of SAT, STT, SDM and SPET (BPS-16) while the appellant being eligible having five years' service on

- - 6- That the appellant feeling aggrieved and having no other remedy but to file this appeal on the following grounds amongst others.

ON GROUNDS:

- A- That the issuing the impugned appellate order dated 29.03.2021 and Above all, noncompliance of the direction of Honorable High Court Peshawar by the respondents is against law, fact, and norms of natural justice and material on record hence impugned appellate order dated 29.03.2021 is liable to be set aside.
- B- That the appellant has not been treated by the respondents in accordance with law and rule and on the subject noted above as such respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.





Preliminary Objections:-.

- 1. That appellant has got no cause of action and locus standi to file the instant service appeal.
- 2. That the above titled service appeal is wrong, incorrect and against the law & facts
- 3. That the appellant is estopped to file the instant service appeal by his own conduct.
- That the instant service appeal is not maintainable & entertainable in its present form.
- 5. That the appellant has not come to this honourable court / with clean hands and concealed the real facts.
- 6. That the instant service appeal is liable to be dismissed due to mis-joinder & non-joinder of the necessary and proper parties.
- 7. That the instant service appeal is liable to be dismissed in being based by law and limitation.

Factual Objections:-

- 1. Para No. 1 pertains to record.
- 2. Para No. 2 pertains to record.
- 3. Para No. 3 is incorrect and wrong. Further reply of this para is that DPC of other category of teaching posts was held on 11/11/2019 except CT BPS-15 to S.CT BPS-16 as there was no candidate of CT for promotion and so far the case of appellant is concerned he was not entitled under Section-3 of Khyber Paktunkhwa Employees & Secondary Education Department

District Education Offices (Male) Karak 5.

(Appointment & Regularization of Service) Act, 2017. Further it is stated that in Regularization Notification dated 19/03/2018 (Annexure-B) S. No. 7 of Terms & Condition is very much clear.

- 4. Para No. 4 pertains to record, however, it is further stated that in light of order dated 19/01/2021 of Hon'able Peshawar High Court Bannu Bench passed in W.P No. 1268-B of 2020 titled "Muhammad Ijaz V.S Govt: of KPK directed the DEO (Male), Karak to implement the directions of Director E & SED, PEsahwar contained in letter No. 4368/F.No. Promotion CT to SCT Karak dated Peshawar the 12/06/2020, The District Education Officer (Male), Karak issued office order vide No. 29/03/2021 that the appellant was not eligible for promotion from C.T BPS-15 to S.CT BPS-16 in light of Para No. 7 of Khyber Paktunkhwa Employees & Secondary Education Department (Appointment & Regularization of Service) Act, 2017.
- 5. Para No. 5 pertains to record, however, detailed reply was given in Para No. 4.
- 6. Para No. 6 is incorrect and wrong.

Objection on Grounds:-

Theorrect. As per condition No. 7 mentioned in Regularization Notification dated 19/03/2018 the appellant is less eligibility criteria for promotion. Details reply is given in Para- 4 & 5 above.

- F. Incorrect and wrong hence denied. Further stated that the respondent No. 3 (DEO(M), Karak) vide office order dated 19/03/2021 has implemented the order of Hon'able Peshawar High Court dated 19/01/2021 and followed the directions of


