APPEAL U/S 4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE NOTIFICATION NO. SO (PE) 2-6 / DPC MEETING / SST-SS / 2018 DATED 15-03-2018, WHEREBY R. NO. 04 BEING JUNIOR WAS PROMOTED FROM SST BPS-16 TO SUBJECT SPECIALIST BPS-17 AND APPELLANT BEING SENIOR WAS NOT CONSIDERED FOR PROMOTION TO THE SAID POST, AND DEPARTMENTAL APPEAL DATED 26-03-2021 BEFORE THE AUTHORITY WAS NOT HONORED TILL DATE:

Respectfully Sheweth;

1. That the appellant has degree of Master of Science (Pak-Study) at her credit and was eligible for appointment as SST, B-16. (Copy as Annex "A")
2. That certain posts of SST BPS-16 were advertised by department. Appellant applied and qualified the run and recommended by the Public Service Commission and thereafter was appointed by R. No. 03 on 31-12-2011 and was adjusted by R. No. 04 at District Karak on 5-01-2012. (Copy as Annex "B")
3. That the SST BPS-16, being Provincial Cadre, so the respondent department issued Tentative Seniority List stood in the year, 2012 whereby the name of appellant was figured at S. No. 1966 and R. No. 05 at S. No. 2518, meaning thereby that R. No. 05 is most junior to appellant. (Copy as Annex "C")
4. That the department in utter disregard of Law and rules promoted R. No. 05 to the post of subject specialist (SS) BPS-17 vide Notification dated 15-03-18 despite the fact that R. No. 05 is most junior and appellant being senior was not considered, so violated the law and rules.
5. That appellant tried her best to secure the impugned promotion order from the department but was only handed over the posting order dated 13-04-2018, wherein promotion of R. No. 05 has been shown to the post of SS (B-17). (Copy as annex "D")

6. That the respondent department was not providing the relevant record to appellant, so approached KP Regional Information Authority for the needful but no other documents were supplied to appellant in-spite of hectic efforts. (Copy as annex "E")
7. That on 26-03-2021, appellant filed departmental appeals before the authority which met dead response till date. (Copy as Annex "E")

Hence this appeals, inter alia, on the following grounds:

GROUND S:

- a. That the appellant is a hard working teacher and has never given a chance of displeasure to her superior officers.
- b. That appellant being most senior than R. No. 04, so should have been considered on priority basis.
- c. That career progression is the vested right of the appellant according to law and Constitution of Pakistan.
- d. That non consideration of appellant for promotion is a clear out violation of law and rules on the subject.
- e. That the appellant is the most eligible candidate who suffered at the hands of respondents by accommodating blue eyed instead of eligible candidate.

It is, therefore, most humbly prayed that on acceptance of the appeal, the Notification dated 15-03-2018 be set aside to the extent of R. No. 05 and appellant be considered for promotion to the post of Subject Specialist BPS-17 with all Service benefits.

Respectfully Sheweth:-

The Respondents No.1-4 submit as under:-

Preliminary Objections.

- 1 That the Appellant has got no cause of action/locus standi.
- 2 That the instant Service Appeal is badly time barred.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal in the instant service appeal.
- 4 That the instant Service Appeal is based on mala-fide intentions.
- 5 That the Appellant has not come to this Honorable Tribunal with clean hands.
- 6 That the Appellant is not entitled for the relief she has sought from this Honorable Tribunal.
- 7 That the instant Service Appeal is against the prevailing law & rules.
- 8 That the instant Appeal is based on mala fide intentions just to put extra pressure on the Respondents for gaining illegal service benefits.
- 9 That the instant Service Appeal is not maintainable in its present form.
- 10 That the instant Service Appeal is bad for mis-joinder & non-joinder of the necessary parties.

- 11 That the instant Service Appeal is barred by law.
- 12 That the Appellant is not competent to file the instant appeal against the Respondents.
- 13 That the impugned Notification No. SO (PE)2-6/DPC/Meeting/SST-SS/2018 dated 15-03-2018 of the Respondent No. 1 is legally competent & liable to be maintained in favor of the Respondents.
- 14 That no Departmental Appeal against the Notification dated 15-03-2018 has been filed by the appellant to the Respondent Department, hence, got finality under the Law of limitation Act 1908.
- 15 That the Appellant is not entitled for the grant of promotion against the SS B-17 post in the Respondent Department.

ON FACTS.

- 1 That Para-1 is incorrect and denied on the grounds that the Appellant has been found an illegible for promotion against the SS B-17 post, hence, she was not promoted vide the Notification dated 13-04-2018 by the Respondent No.01 under the criteria & rules in field & a copy of the Notification dated 13-04-2018 is **Annexure-A** for ready reference.
- 2 That Para-2 is correct that the Appellant was recommended vide letter dated 31-12-2011 by the KPK PSC against the SST B-16 post & was further adjusted by the Respondent No.4 in District Karak & a copy whereof **Annexure-B** is for ready reference.
- 3 That Para-3 is correct to the extent of notifying the tentative seniority list up to 2012 which was manly for the purpose of perusal of the relevant stack holders & necessary correction & cannot be claimed as a final seniority by the Appellant with regard to her number at 1966 there in & a copy whereof is **Annexure-C** for ready reference.
- 4 That Para-4 is correct in view of the upper seniority position of the Respondent No.4 in the SST Cadre, she was promoted to the post of the SS B-17 in view of her service record & seniority in the final seniority list vide notification dated 15-03-2018 after due process of Law & rules which is legal & liable to be maintained in favor of the replying Respondents & a copy of the Notification under reference dated 15-03-2018 is already attached as **Annexure-A**.

- 5 That Para-5 as incorrect & denied on the grounds that all the stack holder have been informed & communicated in due course of Law regarding the Notification dated 15-03-2018 including the Appellant but in spite of this factual position, the Appellant has approached the information commission Department Government of Khyber Pakhtunkhwa in complaint No. 6287 of 2020 which was disposed of on dated 25-02-2020 with the observation that the Appellant may be obtained the copy of Tentative Seniority list pertaining the SST B-16 (Sc) from the Respondent Department & copy of the order dated 25-02-2020 is **Annexure-D** for ready reference.
- 6 That Para-6 is also incorrect & denied on the grounds that no Departmental that all relevant documents have been provided to all the concerned in due course of Law including the Appellant, hence, her plea is liable to be rejected.

ON GROUNDS.



COMMENTS ON BAHALF OF RESPONDENT NO.05

RESPECTFULLY SHEWETH:

Preliminary Legal Objections:

- i. That No legal right or entitlement of the appellant has been infringed, as such, the instant Appeal is Not maintainable in its present form.
- ii. That the appellant has No locus standi to file the lis in hand hence merit dismissal.
- iii. That this Hon, able Court lack jurisdiction to entertain the instant Appeal on the ground that the respondent No.05 has been promoted according to rules, regulations and on due process of the concern

authorities. So the instant Appeal is liable to be returned to the appellant for filing in right forum i.e. before Peshawar High Court Peshawar having jurisdiction in the matter.

- iv. That the appellant has Not approached this Hon, bale Court with clean hands and on this score alone the instant appeal merits dismissal. The Supreme Court of Pakistan held that:

"Courts have never permitted their judicial powers to be invoked or used for retention of illegal and ill-gotten gains, Nor have the courts ever opted to exercise their powers in aid of injustice or to grant any relief to persons with unclean hands or for protecting the unethical or undeserved benefits---Courts canNot render any help to the applicants who were admitted, the consequent beneficiaries of the unconstitutional, illegal and unethical actions" (2010 PLD 483 SC).

"Constitutional jurisdiction is always discretionary in character. He who seeks equity must come with clean hands reliance upon the judgment of HoNorable Supreme Court of Pakistan. (2010 SCMR 72)

- v. That if the Appeal of the appellant is allowed the answering respondent shall suffer irreparable loss.
- vi. That the Appeal is without any legal force as the grounds of the Appeal does Not disclose any statutory Irregularity/illegality by the respondent No.05 while passing the orders of reinstatement with all back benefits in favor of respondent No.05 therefore, the same merits to be dismissed.
- vii. That the instant appeal moved by the appellant with mala fide intention as the appellant impleaded only the answering respondent No.05 and the appellant committed concealment of fact because there

are other juniors who promoted for the same post but they were Not mentioned Nor impleaded by the appellant.

- viii. The answering respondent No.05 has promoted vide Notification No.SO (PE)2-6 /DPC meeting/SST-SS/2018 dated 15.03.2018 under due process of law, regulation and bylaws of the concern department as the answering respondent No.05 was feeling aggrieved by orders /Notification/ Meetings and process of the concern authority the Respondent No.05 moved departmental appeal and after perusal and fulfillments of all codal formalities by the concern authority the Respondents/Department/Concern Authority issued the promotion list of the answering respondent which based upon merits and there is No any illegality or any other irregularity in it.

PARAWISE COMMENTS ON MERITS

- Para-1** Denied on the basis of lack of knowledge about the eligibility of the appellant for the required cadre.
- Para-2** Incorrect and denied due to lack of knowledge.
- Para-3** Incorrect and denied the answering respondent is Not junior and have/had right eligibility and ability to be promoted for the same post.
- Para-4** Incorrect and denied the answering respondent has been promoted under the relevant laws, regulations and after fulfillment of all legal and codal formalities.
- Para-5** Incorrect and denied as lack of information and interest of the answering respondent No.05.
- Para-6** Incorrect and denied due to lack of kNowledge and interest of the answering respondent No.05.
- Para-7** Incorrect and denied due to lack of kNowledge.

PARAWISE COMMENTS ON GROUNDS:

- a) Not admitted and denied. The details have been given in the above Para's of the comments.
- b) In correct and denied but it has No nexus with the illegal promotion of the answering respondent.
- c) Correct and admitted but the answering respondent is promoted according to the law of land and there is No any illegality and irregularity in the side of promotion of respondent No.05.
- d) Incorrect and denied.
- e) Incorrect being illegal. The answering respondent was the most eligible and deserving candidate for the same promoted cadre.


PRAYER
