**ORDER**

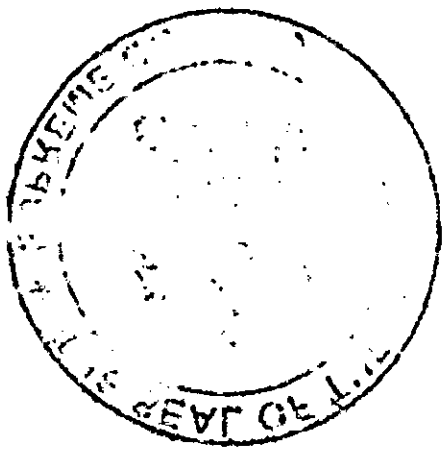
