



Counsel for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant while arguing the instant service appeal of 16 appellants stated in the main appeal of the appellant that he was appointed as Driver on fixed pay in the project MNCH on 29.10.2010. His services were regularized under Section-4 of the Khyber Pakhtunkhwa Employees (Regularization of Services) Act, 2018 vide notification dated 24.05.2019, w.e.f 07.03.2018 i.e from commencement of the Act. Consequent upon his regularization of services, the respondent-department started service book but without entries of previous service. It was on receipt of pay slip for the month of July 2021 when date of entry mentioned as 07.03.2018 instead of 2010. Feeling aggrieved, the appellant submitted departmental appeal on 09.08.2021 however no appellate order was passed on the departmental appeal within the statutory period where-after the service appeal was submitted in the Service Tribunal on 06.12.2021. It was further contended that the appellant is eligible and duly entitled for all back benefits of counting of previous service under Rule-2.3 of the West Pakistan Civil Services Pension Rules 1963 and Article-371(A)(i) of the Civil Services Regularization. Attention of the learned counsel for appellant was drawn to the promulgation of Khyber Pakhtunkhwa Civil Servants Pension Rules, 2021 under which the Khyber Pakhtunkhwa Pension Rules, 1955 have been repealed. On this point, learned counsel for the appellant submitted that it will be properly addressed when arguments on main appeal are to be heard by the D.B.

The appeal is admitted to regular hearing subject to all just legal objections including limitation. The appellant is directed to deposit security and process fee within 10 days. Thereafter notices be issued to respondents for submission of reply/comments. To come up for reply/comments on 31.03.2022 before S.B.



APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 READ WITH ALL ENABLING LAWS & RULES, AGAINST THE INACTION OF THE RESPONDENTS BY NOT COUNTING THE CONTRACT SERVICE OF THE APPELLANT TOWARDS REGULAR SERVICE I.E. w.e.f. INITIAL APPOINTMENT TILL 07-03-2018 FOR THE PURPOSE OF PAY PROTECTION AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL 09-08-2021 OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

That on acceptance of this appeal the respondents may kindly be directed to count the contract service of the appellant towards regular service i.e. w.e.f. initial appointment of the appellants till 07-03-2018 with all back benefits in light of Rule 2.3 of the West Pakistan Civil Services Pension Rules, 1963 and Article 371(A)(i) of the Civil Services Regulations. Any other remedy which this august Service Tribunal deems fit that may also be awarded in favor of the appellant.

Respectfully Sheweth:

FACTS:

Brief facts which give rise to the instant appeal are as under:-

1. That, the appellants are the employee of the respondent Department and were initially appointed by the Respondent No. 4 in a Project introduced by Ministry of Health Islamabad throughout Pakistan namely "Mother Neonatal Child Health"

(MNCH) Program from 2008 to 2010 onward after fulfilling the codal formalities required for the posts.

Copy of the Appointment Orders is attached as ANNEXURE A.

2. That, the appellants after receiving the appointment orders submitted their arrival report and started performing their assigned duties station with all zeal & zest and up to the entire satisfaction of their high ups without any breakage.
3. That, the Government of Khyber Pakhtunkhwa introduced the Khyber Pakhtunkhwa Employees (Regularization of Services) Act 2018 by regularizing employees of various projects working in Khyber Pakhtunkhwa including the project of the appellants i.e. MNCH Program at Serial No. 14 of the Schedule in the ibid Act.
Copy of the Khyber Pakhtunkhwa Employees (Regularization of Services Act) 2018 Act is attached as ANNEXURE B.
4. That, most of the employees working in MNCH Program of Khyber Pakhtunkhwa were regularized after the introduction of the Khyber Pakhtunkhwa Employees (Regularization of Services) Act 2018 but appellants were deprived of their legal right of regularization.
5. That, appellants along with other colleagues of the MNCH Program Khyber Pakhtunkhwa whose services were not regularized in light of Regularization Act of 2018, filed Writ Petition No. 6549-P/2018 before the Honourable Peshawar High Court Peshawar which was decided in favour of the petitioners vide judgment dated 12.03.2019 and in light of the judgment dated 12.03.2019 the services of the appellants were regularized from the date of commencement of the Act i.e. 07.03.2018 vide the Respondent No. 1 notification dated 24.05.2019.
Copy of the Notification dated 24.05.2019 is attached as ANNEXURE C.
6. That with the issuance of the notification dated 24-05-2019 the service books of the appellants were also prepared and maintained by making necessary entries therein in the service books of the appellants and as such the date of entry into Government service entered in the Pay Rolls of the appellants are made as 07-03-2018 and not from the date initial appointments.
Copy of the Service Books & Pay Rolls are attached as ANNEXURE D& E.
7. That in light of the various notifications issued by Finance Division Islamabad as well as by Respondent No. 2 i.e. Finance

Department of Khyber Pakhtunkhwa regarding fixation of Pay/ Pay Protection in case of regularization of contract service without breakage but the fruition of the notifications *ibid* were not extended to the appellant and the appellant are deprived of the benefit by counting their previous service towards Pay, Pension & Promotion.

Copy of the Notifications are attached as ANNEXURE F.

8. That again when the salaries for the month of July 2021 was issued to the appellant the previous service served by the appellant were not counted towards pay, pension & promotion, hence, the appellants preferred Departmental Appeals dated 09-08-2021 before respondent no. 3 for inclusion of previous service in the regular service but till date no response has so far been received after passage of statutory period of 90 days.

Copy of the Departmental Appeals are attached as Annexure G.

9. That the appellant having no other efficacious, adequate and alternate remedy but to approach this Honourable Tribunal on the following grounds amongst others:

GROUND S:

- A- That the inaction of respondents by not counting the previous service of the appellant rendered in the Health Department towards regular service of the in light of Rule 2.3 of the West Pakistan Civil services Pension Rules, 1963 and in light of Article 371 A (i) of the Civil service Regulations is against the law, facts, norms of natural justice and materials on the record hence not tenable and needs interference of this Honourable Tribunal.
- B- That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondents acted in arbitrary and malafide manner by not counting the previous service of the appellant rendered in the Health Department towards regular service in light of Rule 2.3 of the West Pakistan Civil services Pension Rules, 1963 and in light of Article 371 A (i) of the Civil service Regulations is also discriminatory and against the norms of Natural Justice, therefore the same is not tenable in the eye of law.
- D- That under Article 38 (e) of the Constitution of Pakistan, 1973 state is bound to reduce disparity in the income and earning of the individuals including persons in the various services of

Pakistan, therefore in light of the above mentioned Article the appellants are fully entitle for counting of their previous contract service of the appellant rendered in the Health Department.

- E- That there is no breakage in service of appellants from the date of initial appointments till his regular appointment on 07-03-2018 when the Khyber Pakhtunkhwa (Regularization of Services) Act, 2018 was promulgated and the same is also against FR-22 (a) (i).
- F- That in light of Rule-2.3 of the West Pakistan Pension Rules, 1963 the appellant is fully entitle for the counting of his previous service served the Health Department.
- G- That the act of the respondents by not counting the previous contract service of the appellant rendered in the Health Department from the date of initial appointments is also against the notification issued by Finance Division Islamabad and also of the notification issued by Finance Department Khyber Pakhtunkhwa.
- H- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

(Regularization of Services) Act, 2018**

Khyber Pakhtunkhwa Act No. X of 2018

AN ACT to provide for the appointment and regularization of services of certain employees appointed on adhoc basis against civil posts and contract basis against project posts in the Province of Khyber Pakhtunkhwa

2nd Mar 2018

WHEREAS it is expedient to provide for the appointment and regularization of services of certain employees appointed on adhoc basis against civil posts and contract basis against project posts in the Province of Khyber Pakhtunkhwa;

It is hereby enacted as follows:

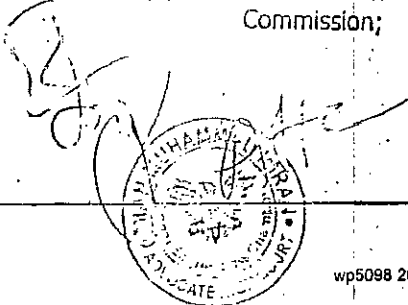
1. Short title, application and commencement. – (1) This Act may be called the Khyber Pakhtunkhwa Employees (Regularization of Services) Act, 2018.

(2) It shall apply to all the employees as defined in clause (e) of subsection (1) of section 2 of this Act.

(3) It shall come into force at once.

2. Definitions. – (1) In this Act, unless the context otherwise requires;

(a) "Commission" means the Khyber Pakhtunkhwa Public Service Commission;

- (b) "contract appointment" means the appointment of a duly qualified person, for a specific period, made against project posts, in a prescribed manner;
- (c) "Departmental Selection Committee" means a Departmental Selection Committee, constituted for the purpose of making selection for initial recruitment to civil post under a Government Department or office of Government;
- (d) "Government" means the Government of Khyber Pakhtunkhwa;
- (e) "employees" mean duly qualified, -
- (i) one hundred and fifty-eight (158) District Specialists of Health Department, who are appointed on adhoc basis against civil posts w.e.f. 4th July, 2017 and holding such civil posts till the commencement of this Act; and
- (ii) persons, who are appointed in the projects on contract basis in accordance with the project policy;
- (f) "Government Department" means a Government Department, as defined in the Khyber Pakhtunkhwa Government Rules of Business, 1985;
- (g) "law or rule" means law or rule, for the time being in force governing the selection and appointment of civil servants;
- (h) "project" means a perpetual nature project, the continuation of which and conversion to regular budget is essential for service delivery duly identified by the Departments and reflected in the Schedule;
- (i) "civil post" means a civil post under Government or in connection with the affairs of Government to be filled in on the recommendation of the Commission;
- (j) "project post" means a post in the project; and
- (k) "Schedule" means a Schedule appended to this Act.
- (2) The expression "adhoc appointment" shall have the same meaning as is assigned to it in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973).

3. Regularization of services of adhoc employees.---

Notwithstanding anything contained in any law or rules, the employees at sub-clause (i) of clause (e) of sub-section (1) of section 2 of this Act, appointed on adhoc basis against civil posts and holding such civil posts till the commencement of this Act, shall be deemed to have been validly appointed on regular basis, from the date of commencement of this Act, subject to verification of their qualifications and other credentials by the concerned Government Department.

4. **Regularization of services of project employees.**--- Notwithstanding anything contained in any law or rules, the employees of sub-clause (ii) of clause (e) of sub-section (1) of section 2 of this Act, appointed on contract basis against project posts and holding such project posts till the commencement of this Act, shall be deemed to have been validly appointed on regular basis from the date of commencement of this Act, subject to verification of their qualifications and other credentials by the concerned Government Department:

Provided that the terms and conditions of services of employees reflected at S. No. 5 of the Schedule shall further be governed under the National Disaster Management Authority Act, 2010 (Act XXIV of 2010) and Regularization made thereunder, and the terms and conditions of services of employees reflected at S. No. 6 & 7 of the Schedule shall be governed under the Khyber Pakhtunkhwa Emergency Rescue Services Act, 2012 (Khyber Pakhtunkhwa Act No. XV of 2012).

5. **General conditions for regularization.**--- For the purpose of regularization of the employees under this Act, the following general conditions shall be observed:

- (i) the service promotion quota of all service cadres shall not be affected;
- (ii) the employees shall possess the same qualification and experience as required for a regular post;
- (iii) the employees have not resigned from their services or terminated from service on account of misconduct, inefficiency or any other grounds before the commencement of this Act; and
- (iv) the service of such employees shall be deemed to have been regularized only on the publication of their names in the Official Gazette.

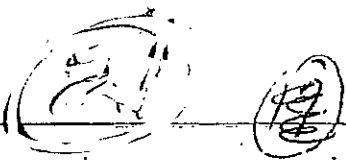
6. **Seniority.** - (1) Except the employees mentioned in the proviso to section 4 of this Act, whose services are to be regulated by their respective laws and rules, all other employees whose services are regularized under this Act or in the process of attaining service at the commencement of this Act, shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission or Departmental Selection Committee, as the case may be, made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.

(2) The seniority inter-se of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officiation in such service or cadre:

Provided that if the date of continuous officiation in the case of two or more employees is the same, the employee older in age shall rank senior to the younger

7. **Removal of difficulties.** – If any difficulty arise in giving effect to any of the provisions of this Act, the Chief Minister may make such order not inconsistent with the provisions of this Act as may appear to it to be necessary for the purpose of removing such difficulty:

Provided that no such powers shall be exercised after the expiry of one year from the coming into force of this Act.

8. **Overriding effect.** – Notwithstanding anything to the contrary contained in any other law or rule for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rule to the extent of inconsistency to this Act shall cease to have effect.

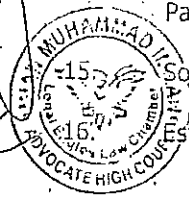
