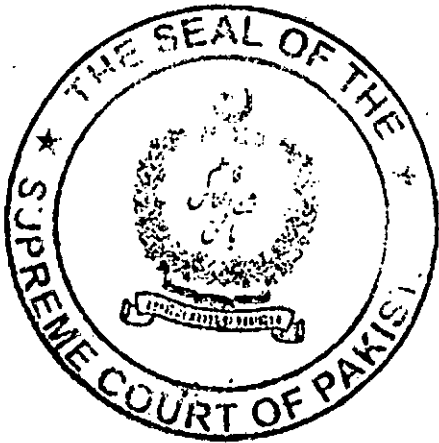
**Syed Mansoor Ali Shah, J.**- This petition is barred by

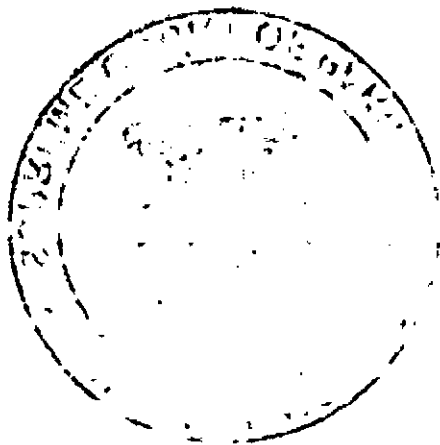
