



Dear Sir.

- 1. I am directed to refer to the subject noted above and to say that in supersession of all policy, instructions issued in this behalf, the competent authority has approved the following Posting/Transfer Policy: -
- All the posting /transfer shall be made strictly in the public interest and shall not be abused/misused to victimize the Government Servant.
- All Government servants are prohibited to exert political, Administrative or ii) any other pressure upon the posting /transfer authorities for seeking posting transfer of their choice and against the public interest.
- All contract Govt: employees appointed against specific posts cannot be (iii) posted against any other post.
- The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas, the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the government.
- Months of March and July are fixed for posting/transfer of the officers/officials excluding the officers in B-19 and above in the Province. Posting/transfer in Education and Health Departments shall be made in March

while the remaining departments shall make posting/transfer in july. There shall be a ban on posting/transfer throughout the year excluding the aforementioned two months due to promotion/retirement/creation of new post/return from long leave/involvement in disciplinary proceedings and adjustment of surplus staff for which specific relaxation shall be obtained from the Chief Minister.

PRELIMINARY OBECTIONS:

- 1) That, the appellant has no cause of action to file the instant appeal.
- 2) That, the instant appeal is badly time barred.
- 3) That, the appellant has filed the instant appeal just to pressurize the respondents.
- 4) That the appellant has not come to the Tribunal with clean hands.
- 5) That the appellant has concealed material facts from Honourable Tribunal.
- 6) That appellant is stopped to file the appeal by his own conduct.
- 7) That upon concealment of facts, no one can claim any relief hence the instant appeal is liable to be dismissed.

ON FACTS:

- 1. Correct to the extent of promotion, however two others PSTs from this school were also promoted, moreover the impugned transfer order was issued Prior to adjustment order of the promote.
- Admitted to extent that the respondent No.4 issued the transfer order of the Respondent No.5 on 16-3-2015 from GGPS Sheikh Baba to GGPS No.1. Tordher.The rest is denied.

- 5. In correct. No political interference was entertained. Policy was observed.
- 6. Merit was followed strictly.
- 7. The other points of law and facts shall be raised / argued if required for the assistance of the tribunal.

It is therefore requested that the transfer order dated 16-3-2015 issued by the respondent No.4 vide which the respondent No.5 was transferred and posted to GGPS No.1 Tordher may be retained and may be declared issued with law full authority and according the policy.
