

D. That the respondents have not considered the policy governing the rules/ regulations under the spouse policy and were illegally ignored by transferring the petitioner against the said policy.

- E. That the said unit is also shot of Medical Officer/ Specialist and the respondent No.4 vide his Medical Superintendent also requested for the said officers/ specialist in this regard which also shows that the order of the respondents is not sound and based on reality.
- F. That acts of the respondents are based on favoritism, nepotism and for ulterior motives and also against the norms of natural justice, hence, needs to be corrected.
- G. That the acts of the respondents are also unreasonable as the petitioner is performing his duty in a specialize field for which he was specialized in his respective field and the order of the respondent is just to spoil the petitioner's specialty, hence, the acts of the respondents are not sustainable according to rules and regulations.
- H. That the petitioner was not treated according to law, which is against the provision/ articles of the Constitution and Law on the subject.

It is, therefore, most humbly prayed, that on acceptance of this writ petition, the order of the respondent dated 23.09.2014 may kindly be declared null and void and be struck down and the petitioner may

kindly be treated according to law as per his specialty in his respective field and the respondents may please be directed as per law and rules and the Constitution.

Any other relief deems fit and appropriate in the circumstances of the case may also be granted to the petitioner if not specifically asked for.

It is, further prayed that during the pendency of this writ petition the order of the respondent dated 23.09.2014 may kindly be suspended till the disposal of the case and respondents may please be directed not to compel or persuade the petitioner to relinquish his charge as MO/ Junior Registrar Gastroenterology Unit, Hayatabad Medical Complex, Peshawar.

MAZHAR ALAM KHAN MIANKHEL, CJ.- The

petitioner Dr. Dilaram Khan being aggrieved of his transfer orders dated 23.09.2014 has filed the instant writ petition for declaring the same as null and void.

2. When the learned counsel for the petitioner was asked that when the KPK Service Tribunal is duly functional and the matter pertaining to the terms and conditions of petitioner was required to have been filed before the Service Tribunal, he was unable to give any plausible explanation for not approaching the proper forum for the redress of the grievance of the petitioner. The Apex Court in its recent judgment passed in CIVIL **REVIEW PETITION NO.193 OF 2013 ETC** dated 05.01.2015 has again laid down that the issue relating to the terms and conditions of service cannot be

entertained by a High Court either in its Constitutional jurisdiction or in its Original Civil jurisdiction or in High Court Appeal, being barred under Article 212 of the Constitution.

3. It appears that the petitioner has chosen a wrong forum just for the purpose of getting a speedy remedy, which was, however, not available to him under the law, therefore, the instant writ petition is hereby dismissed.
