The learned counsel for the appellant submitted that the appellant is President of Young Doctors Association (Southern Region) Khyber Pakhtunkhwa and being an office bearer, he could not be transferred per instructions vide letter dated 07.07.1992 of the S&GAD. He further submitted that the impugned order is unlawful, without NOC as permission of the Chief Secretary was not obtained. He further argued that relation between the appellant as office bearer of the association and the Chief Executive, Group of Teaching Hospital, Bannu, (respondent No. 5) were not cordial and on the maneuvering of the later, the appellant was unlawfully transferred. In this context it was further submitted that though the appellant made departmental appeal dated 06.02.2015 to the Chief Secretary through Secretary, Health Department but the same has not been forwarded to the Chief Secretary. He contended that the transfer is neither in public interest nor on the basis of exigencies of service, which may be set aside.

The appeal was resisted by the learned Government Pleader on the ground that the appellant was a bonafide resident of FATA had served for sufficient long time in Bannu therefore, the question of his tenure does not arise. He further submitted that the grounds of ban on transfer or incompetency of the Secretary to transfer him without permission of Chief Secretary vide the impugned order have not been taken in the departmental appeal/memo: of appeal, therefore, the same cannot be appreciated by Tribunal. He

also submitted that the transfer has been made on administrative ground and the same is protected on the principles laid down in 2005-SCMR-442. He requested that the appeal may be dismissed.

6. After perusal of the record and hearing pro & contra arguments, it was found that the appellant remained as office bearer who has alleged in the appeal that in order to pressurize the appellant to withdraw from a Writ Petition 以为[ju] [Per 医大线性分析器 學問題 pending against respondent No.5, the impugned transfer was maneuvered. During the course of arguments, it was also strongly agitated that departmental appeal of the appellant dated 06.02.2015 was not forwarded to the Chief Secretary with malafide. Since departmental appeal of the appellant has not been decided, therefore, we direct that his departmental appeal be placed before the Chief Secretary to be decided as soon as possible but not later than a month of the receipt of this judgment by the respondents. The appeal is disposed off accordingly. The restrain/stay order, if any, granted by this Tribunal shall stand vacated. Parties are left to bear their own costs. File be consigned to the record room.

SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION DATED 23.01.2015 WHEREBY APPELLANT WAS TRANSFERRED FROM DHQ HOSPITAL, BANNU AND HIS SERVICES WERE PLACED AT THE DISPOSAL OF DIRECTOR HEALTH SERVICES FATA AGAINST WHICH APPELLANT PREFERRED A DEPARTMENTAL REPRESENTATION ON 06.02.2015 BUT THE SAME WAS NOT DISPOSED OF WITHIN THE STATUTORY PERIOD OF 90 DAYS.

PRAYER:

On acceptance of the instant appeal, the impugned Notification dated 23.01.2015 to the extent of the appellant may graciously be set aside and the salaries of the appellant be also released.

Respectfully Sheweth,

Facts giving rise to the present appeal are as under:-

- 1. That appellant was appointed as Medical Officer on the recommendations of the Khyber Pakhtunkhwa Public Service Commission on 08.02.2005 and was posted at Civil Hospital Kalaya, Orakzai Agency. He was then transferred to DHQ Hospital, Bannu on 03-6-2005.
- 2. That the appellant performed his duties well and was appointed as DMS (Accident & Emergency) at DHQ Teaching Hospital Bannu by the Respondent No.4 on 07.06.2011. Later on, the appellant was directed by the Respondent No. 4 on political basis to perform his duties under the MS KGN, Bannu vide order dated 13.06.2013 (Annex:-A) while drawing pay against his original post under the Respondent No. 5.
- President of Young Doctors Association (Southern Region)
 Khyber Pakhtunkhwa for two years vide Notification dated 01.01.2014 (Annex:-B) and as such he has to bring the collective service problems of the Doctors serving in Southern Region KP into the notice of the concerned authorities with earnest request for redressal of the collective service problems. In this way some personal misunderstanding developed in between the appellant and Dr. Muhammad Jehangir Khan, the incumbent of the office of the Respondent No.4 in resolution of the collective service problems of the Doctors serving in the

Group of Teaching Hospitals Bannu:

- 4. That since the Respondent No.5 was holding the office of the Chief Executive unauthorizedly in utter violation of the Rules, therefore, a writ of quo warranto was instituted in the Hon'ble Peshawar High Court, Bannu Bench requiring Respondent No.5 to explain under what authority of law he is holding such office. Respondent No.5 was accordingly summoned by the Hon'ble Court and now the proceedings are underway but due to the writ petition Respondent No.5 has started victimizing the appellant by using his political and administrative influence and thus succeeded in procuring the impugned Notification dated 23.01.2015 (*Annex:-C*) whereby the appellant was illegally transferred and his services placed at the disposal of the Director Health Services FATA. However, the order was suspended by the Hon'ble Court vide order dated 11.02.2015 (*Annex:-D*).
- 5. That subsequently, on the direction of the Hon'ble Peshawar High Court, Bannu Bench, the appellant filed a separate Writ Petition No.124-B/2015 (*Annex*:-E) challenging the impugned transfer order but the same was subsequently dismissed vide order dated 12.03.2015 (*Annex*:-F) on the ground of jurisdiction.
- 6. That being aggrieved of the impugned Notification ibid, appellant preferred a departmental Representation (Annex:-G) to the appellate authority on 06.02.2015 but the same was not disposed of within the statutory period of 90 days, hence this appeal inter-alia on the following grounds:-

Grounds:

- A. That Respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973 and unlawfully issued the impugned Notification, which is unjust, unfair and hence not sustainable in the eye of law.
- B. That as per instructions issued by the Provincial Government as contained in the letter dated 07.07.1992 (*Annex:-H*), the office bearers of the Service Associations shall not be transferred during the period they bear office as such. Thus the impugned Notification is violative of the instructions of the Provincial Government inas much as the same was issued during the office bearer-ship of the appellant as President of the Association.
- C. That the impugned Notification is neither in the public interest nor in exigency of service but the same is the result of political and administrative pressure, hence the same is also violative of the Posting/Transfer Policy (*Annex:-I*) issued by the Provincial Government.
- D. That the impugned Notification has been procured malafide by the Respondent No.5 in order to pressurize the appellant to withdraw from the Writ Petition pending before the Hon'ble Peshawar High Court, Bannu Bench and as such the same is the result of arbitrary exercise of power which is against the ethics of good governance.
- E. That although the appellant is holding FATA (North Waziristan Agency) domicile but is permanently based at Bannu a long with his family owning house for the last more than 50 years, therefore, his transfer to FATA is highly prejudicial, illegal,

therefore not tenable under the law. It is also a fact that during the current Operation against the militants at the North Waziristan Agency, the inhabitants are IDPs and temporarily are residing at Bannu.

F. That appellant would like to offer some other grounds during the course of arguments.

It is, therefore, humbly prayed that the instant appeal may graciously be accepted as prayed for above.

Any other relief as deemed appropriate in the circumstances of case not specifically asked for, may also be granted to appellant.



That in the meanwhile the Petitioner was elected unopposed as President of Young Doctors Association (Southern Region) Khyber Pakhtunkhwa for a two years term of 2014–15, duly notified to all concerned by Dr. Alamgiur Khan, President YDA (KP) vide Notification dated 01-1-2014 and as such the Petitioner has to bring the collective service problems of the Doctors serving in Southern region KP into the notice of the concerned authorities with earnest request for redress of the collective service problems. In this way some personal misunderstanding developed inbetween the Petitioner and the Respondent No. 4 in resolution of the collective service problems of the

Doctors serving in the Group of Teaching Hospitals Bannu so much so that the Petitioner has to file on 15-12-2014 a writ of quo warranto bearing W.P. No. 507–B/2014 in this Hon'ble Court against the Respondent No. 4 for his removal from the office of the Chief Executive Group of Teaching Hospitals Bannu.

Copies of the Petitioner's Notification as President YDA and Memo of WP No. 507–B/2014 are filed herewith and marked as Annex "D/1&2", respectively.

4. Moreover, the Petitioner is an elected President of the Service Association of Young Doctors in Southern Region of Khyber Pakhtunkhwa for 2014–15, therefore, the impugned transfer of the Petitioner out of Bannu flagrantly violates the Provincial Govt's policy circulated by the Services & General Administration Department (Govt of KP) vide letter No. SO–IV(S&GAD)B(167)/92–Vol.VII dated 07-7-1992, which prohibits the transfer of an office bearer of a service association during the tenure of his office.

Copy of the Govt of KP (S&GAD)'s letter dated 07-7-1992 is filed as Annex "F".

7. That although the Petitioner has preferred his appeal/ representation dated 06-2-2015 to the Respondent No.1 through proper channel but because of the fact that on one hand the Respondents are pressing hard for implementation of the impugned order and on the other hand the Petitioner has to wait compulsorily for a period of Ninety (90) days; U/S: 4(a) of the KP Service Tribunal Act–1974; prior to approaching the learned KP Service Tribunal for suspension of the impugned order till disposal of the representation and as such the Petitioner is left without remedy during the interim period of compulsory wait. In these circumstances the Petitioner has to approach this Hon'ble Court for grant of interim remedy during the statutory period of compulsory wait, for, it is established principle of law that when there is no remedy, the writ is available.

9. That in the above circumstances the Petitioner is compelled to beseech before this Hon'ble High Court for suspension of the impugned illegal transfer order of the Petitioner, under Article: 199(1)(a&c) of the Constitution of Pakistan–1973; amongst others; on the following grounds;-

GROUNDS.

- That the Petitioner has no other alternate and efficacious remedy (A). for getting suspension of the impugned illegal and malicious transfer order because on one hand the Petitioner has to wait per force for the statutory period of 90 days (prescribed U/S: 4(a) of the KP Service Tribunal-1974) prior to approaching the learned KP Service Tribunal for grant of interim relief against the impugned transfer order, while on the other hand the Respondents are bent upon implementing the impugned transfer order immediately for restraining the Petitioner from prosecuting the writ of Quo Warranto against the Respondent No. 4 at Bannu. Therefore, in such like situation this writ petition is maintainable in view of the case law reported as 2008 SCMR 948(a) as relied upon by the Hon'ble Lahore High Court in a case law reported as 2009 PLE(C.S) 44 coupled with the well established principles of law that "no one can be left without remedy" even for interim period and that "when there is no remedy the writ is available".
- (B) That the Petitioner is entitled to be dealt with strictly in accordance with law and equally protected under the law; as is guaranteed to him under Articles: 4, 25 & 27 of the Constitution of Pakistan–1973 but the impugned transfer order has been issued otherwise than in accordance with the relevant law/transfer policy of the Provincial Govt having the force of law, for, in the instant case 08 to 10 Doctors with longer tenure at Bannu than that of the Petitioner have been ignored while notifying the transfer of the Petitioner. Therefore, the impugned transfer order, being prejudicial to the existing transfer policy is null and void ab-initio and is required to be set aside.
- (C). That the impugned transfer order dated 23-1-2015 has been issued as a result of personal malice of the Respondents No. 2&4, which is prima facie aimed at victimizing the Petitioner for refraining him

- (F). That counsel for the Petitioner carves leave of this Hon'ble Court to urge more grounds at the time of hearing of this petition.



Admittedly, the petitioner is serving as Medical Officer in Health Department Under Section 10 of the KPK Civil Servants Act, 1973, a civil servant can be transferred during period of his service, which is one of the incident of service, squarely falling under the terms and conditions of service, as such, comes within the domain of Service Tribunal. Your Excellency;

It is respectfully submitted that after selection by the Public Service Commission I was appointed as Medical Officer (BPS-17) and posted in Tehsil HQ Hospital, Kalaya Orakzai Agency wef 16-2-2005, from where I was transferred to DHQ Hospital Bannu and joined duties wef 2-7-2005. After establishment of the institution of Bannu Medical College and Group of Teaching Hospitals Bannu (during December 2006 in terms of Section: 2(1)(a) of the NWFP (now KP) Medical and Health Institutions and Regulation of Health Care Services Ordinance-2002) my services were absorbed (by operation of law contained in Sub-Section: (2) of Section: 11 of the in NWFP (now KP) Medical and Health Institutions and Regulation of Health Care Services Ordinance-2002 read with Rule: 10 of The NWFP (now KP) Medical Institutions Rules-2001) in the service of the institution of Bannu Medical College and Group of Teaching Hospitals Bannu, for all purposes and intents and as such I am required to serve the institution on the existing terms and condition till my retirement from service, as has been held by the Hon'ble Peshawar High Court Abbottabad Bench and upheld by the August Supreme Court of Pakistan in a case reported as 2007 SCMR 1442.

- 2. It is further pertinent to submit that I have been serving the institution from the core of my heart and rendering professional services to the ailing humanity enthusiastically because of which there is no public or private complaint on record against me till November 2014 but unfortunately with the advent of my election as President Young Doctors Association (Southern Region KP), it was my professional obligation to bring into the notice of the administration collective problems of the Doctors serving in the region and in case the local administration did not solve the collective problems of the Doctors then I was obliged (being President of the Association) to bring the matter into the notice of the high-up's and try to get every possible legal solution of the problem.
- in wake of the above background, when Dr. Muhammad Jehangir Khan, Assistant Professor (Paeds Surg) in BPS-18 took over as Chief Executive Group of Teaching Hospitals Bannu during October 2013 and started victimizing Doctors as well staff of the Institution then I had to talk to him for amicable solution of the problem but when the said Dr. Muhammad Jehangir Khan did not mend his behavior then (being President of the Association) I had to bring the matter into the notice of the Hon'ble Secretary Health as well as into Your Excellency's notice but when the collective grievances of the members of the Association remained unresolved through departmental channels then I had to file a writ of quo warranto in the Hon'ble Peshawar High Court Bannu Bench on 15-12-2014, for removing the said Dr. Muhammad Jehangir Khan from the illegally usurped post of the Chief Executive Group of Teaching Hospitals (Conf.)

Bannu, which was registered as Writ Petition No. 507–B/2014. Next date of hearing in the matter has been fixed by the court for 04-3-2015.

- In these circumstance, the said Dr. Muhammad Jehangir Khan has tried his best to keep me quit for letting him play illegally with the dignity and respect of Doctors and Para-medical staff but when I did not bow before his illegal demands then he attacked my service interest firstly by placing my services at the disposal of the DG Health Service Peshawar and directing illegal stoppage of my pay for the month of December 2014 through the District Accounts Office Bannu and then through his political supporters; consisting of the sitting Speaker Provincial Assembly Mr. Asad Qaisar and Mr. Shah Farman, Provincial Minister for Information; who pressurized the Hon'ble Secretary Health Department to issue Notification No. SO(H)E-11/4-1/2014 dated 23-1-2015, for placing my services at the disposal of Director Health Services FATA for further posting without least considering the provisions of Rule: 10 of the NWFP (now KP) Medical Institutions Rules-2001 and the principle of law laid down by the August Supreme Court of Pakistan in a case reported as 2007 SCMR 599, wherein it has been stressed upon the politicians and the bureaucracy to abstain from exercising and accepting political or external pressure while dealing with terms and conditions of the services of employees.
- Moreover, the ibid transfer order also violate the Provincial Govt's instructions on transfer of Office Bearers of a Service Association contained in the then Govt of NWFP (now KP) S&GAD's letter No. SO–IV(S&GAD)B(167)/92–Vol.VII dated 07-7-1992, which prohibits the transfer of an office bearer of a service association during the tenure of his office.
- 6. In view of the above humble submissions, it is earnestly requested that Your Excellency may kindly be pleased to direct the Secretary Health Department (Govt of KP) to cancel/withdraw my illegal transfer orders of placing my services at the disposal of the DHS(FATA) Peshawar, contained in the Notification dated 23-1-2015 and direct the Medical Superintendent DHQ Teaching Hospital Bannu as well as District Accounts Officer Bannu to release my pay for the months of December 2014 and January 2015 forthwith.

This appeal is preferred in the interest of rule of law, justice, equity and fair play.

Section 10 of the NWFP Civil Servants Act,1973.

Posting and Transfer. Every civil servant shall be liable to serve anywhere within or outside the Province, in any post under the Federal Government, or any Provincial Government or Local authority, or a Corporation or body set up or established by any such Government:-

Provided that nothing contained in this section shall apply to a civil servant recruited specifically to serve in a particular area or region;

Provided further that, where a civil servant is required to serve in a post outside a service or cadre, his terms and conditions of service as to his pay shall not be less favourable than those to which he would have been entitled if he had not been so required to serve.

Posting/transfer policy of the Provincial Government.

- All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
 - iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
 - iv) Existing tenure of posting/transfer of three (03) years for settled areas and two (02) years for unattractive/hard areas shall be reduced to two (02) years for settled areas, 01½ years for unattractive areas and one year for hard areas.

Para-1(v) regarding months of March and July for posting/transfer and authorities for relaxation of ban deleted vide letter. No: SOR-VI (E&AD) 1-4/2008/Vol-VI, dated 3-6-2008. Consequently authorities competent under the NWFP Government Rule of Business, 1985, District Government Rules of Business 2001, Posting/Transfer Policy and other rules for the time being in force, allowed to make Posting/Transfer subject to observance of the policy and rules.



⁸⁰While making posting/transfers of officers/officials up to BS-17 from settled areas to FATA and vice versa approval of the Chief Secretary, NWFP needs to be obtained. - viii) No posting/transfers of the officers/officials on detailment basis shall be made.
- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
- x) All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.
- xi) Officers/officials except DCOs and DPOs/SPs who are due to retire within one year may be posted on their option on posts in the Districts of their domicile and be allowed to serve there till the retirement

- xiv) Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.
 - i) Pre-mature posting/transfer or posting transfer in violation of the provisions of this policy.
 - ii) Serious and grave personal (humanitarian) grounds.
- 2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule IV thereof is referred. - 4. I am further directed to request that the above noted policy may be strictly observed/implemented.
- 5. All concerned are requested to ensure that tenures of the concerned officers/officials are invariably mentioned in summaries submitted to the Competent Authorities for Posting/Transfer.

1. That the appeal is hit by res judicata.

- 2. That the appeal is vexatious, frivolous and mala fide.
- That the appellant has no cause of action to file the appeal.
- 4. That the appellant has no locus standi to file the instant appeal.
- 5. That the appeal is not maintainable in its present form.
- 6. That the appellant cannot approbate or reprobate.
- 7. The appeal is barred by law.
- 8. That the appellant has concealed material facts.
- 9. That the appellant is guilty of perjury and is liable to be prosecuted, inter alia, for contempt of court.
- 10. That the impugned order is in accordance with section 10 of Khyber Pakhtunkhwa Civil Servants Act, 1973.
- 11. That Departmental Appeal has been filed under section 4 of Khyber Pakhtunkhwa Service Tribunal Act, 1974.

FACTS

- 1. Not correct. Needs valid documentary evidence
- 2. <u>Not correct.</u> The appellant, inter-alia, was transferred from DHQ Teaching Hospital Bannu to KGN Teaching Hospital Bannu by respondent No.4, in the interest of the public that is why the appellant joined the new assignment without any protest.
- 3. Not correct. The Young Doctors' Association (Southern Region) is working without approval of the Competent Authority, therefore, the alleged election of the appellant is without any legal sanctity and authority. The rest of the para is misconceived, malicious, mal fide and not based on facts. Moreover the respondent No.4 always discharged his duties in the interest of the puboic, doctors and other employees.
- 4. Not correct. The respondent No.4 has been appointed by the Competent Authority under the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules 1989. Moreover the appellant was relieved from his duties as Medical Officer and directed to report to Director General Health Services Khyber Pakhtunkhea Peshawar for further posting out of Group of Teaching Hospitals, Bannu to FATA which is his domicile, vide office order dated 28/11/2014 (Annex-A). The appellant had completed more than three tenure in Group of Teaching Hospitals Bannu
- 5. Correct.
- 6. Not Correct. The departmental representation referred to in para-6 of the Service Appeal has never been filed in the office of the Respondent No1 as the same is not a part of the official record of the office, of appellate





authority. Hence not maintainable as Section 4 of Khyber Pakhtunkhwa! Service Tribunal Act, 1974 has not been complied with and the appeal is liable to be dismissed.

GROUNDS

- Not correct. The appellant has been treated in accordance with the law, rules, policy, and the provisions of the Constitution. therefore, the impugned notification has been issued lawfully.
- Not correct. В The appellant is not office bearer of a legally constituted Service Association, therefore, the letter dated 07/07/1992 (Annex-B) is not applicable to his case. Moreover the appellant has been transferred for administrative reasons and after completion of more than normal tenure of three years, therefore, his transfer is not ordinary transfer. Any instructions which violate Section- 10 of the Khyber Pakhtunkhwa Civil Servants Act, 1973, are nullity in the eyes of law.
- Ċ Not correct. The transfer orders issued by Respondent No.2 & 4 are in the public interest and exigency of service but not: otherwise.
- D. Not correct. As replied in para-A to C of the grounds of appeal. Furthermore, the appellant was relieved by Respondent No.4 on 28/11/2014 well before the Writ Petition No.124-B/2014 filed by the appellant on 10/03/2015, therefore, the allegations that transfer order has been issued to pressurize the appellant to withdraw the writ petition is false and misleading.
- E. Not correct As Civil Servant the appellant is liable to serve anywhere including FATA (North Waziristan Agency).
- The Respondents would also like to offer additional grounds at the F.

PRAYER

It is, therefore, most humbly prayed that the appeal may please be dismissed with special costs.







Respectfully Sheweth,

Preliminary Objections:

Preliminary objections raised by answering respondents are erroneous and frivolous. Resjudicata has no application to the case. The appeal is based on bonafide intention for enforcement of fundamental rights. Appellant has got a strong cause of action and for that matter locus standi to file the instant case. The appeal is maintainable in its present form and shape. The appeal is within time and all the facts have been brought fairly and clearly into the notice of the Hon'ble Tribunal and nothing has been concealed.

Facts:

- 1. Incorrect.
- 2. Misrepresented. The appellant was detailed from DHQ Hospital, Bannu to KGN Teaching Hospital, Bannu on political considerations as copies of the order have been transmitted to the political authorities, upon which proper objection was brought into the notice of Respondent No.2/Secretary Health, who vide letter dated 08.07.2013 (*Annex:-Rj/1*) called for the

comments of Respondent No.4/Chief Executive followed by a Reminder (*Annex:-Rj/2*) but the same was not responded back.

- Also misrepresented. As a matter of fact the Young Doctors Association is a registered body vide Certificate of Registration (Annex:-Rj/3) issued by the Registration Authority/Competent Authority under the Voluntary Social Welfare Agencies (Registration and Control) Ordinance-1961. On 08.01.2014 a Convention was held of the same Organization vide Invitation Card/letter (Annex:-Rj/4) at KGN Teaching Hospital, Bannu which was attended by all the office bearers of the Association and all the doctors wherein Respondent No.4 also delivered his speech vide Photographs (Annex:-Rj/5) and Press-Clipping (Annex:-Rj/6).
- Incorrect hence denied. The appointment of Respondent No.4 4. as Chief Executive is in utter disregard of the Rules and therefore, the same has been called in question before the Hon'ble Peshawar High Court, Peshawar. Respondent No.4 is not the competent authority in the case of transfer and posting of the appellant as is evident from vide circular letter dated 26.07.2013 (Annex:-Rj/7). A similar posting of one Medical Officer of DHQ Hospital, D.I. Khan was taken notice of by the Government vide letter dated 18.05.2015 (Annex:-Rj/8) and it has been directed to withdraw the same and explain as to why the disciplinary proceedings under the Government of Khyber Pakhtunkhwa (Efficiency & Discipline) Rules-2011 should not be initiated against the concerned. Inspite of the same, Respondent No.4, out of malice issued the order dated 28.11.2014. As far as the tenure of the appellant is concerned suffice it to say that during the office bearer-ship, transfer cannot be made as per the instructions of the Provincial Government.

- 5. Being admitted needs no reply.
- 6. Incorrect. The appeal has been preferred to Respondent No.1 through proper channel and forwarded by the Medical Superintendent. Interestingly, Respondent No.1 has not submitted the reply and Respondent No.2 has only submitted a reply on his behalf.

Grounds:

- Α. Incorrect hence denied. It is pertinent to submit here that a complaint on 11.11.2014 (Annex:-Ri/9) was submitted to Respondent No.1 against Respondent No.4 by the appellant in capacity of President Young Doctors Association. complaint was referred to the Commissioner, Bannu, who further, forwarded the same to Additional Commissioner for enquiry. The later conducted the enquiry, who recorded the statement (Annex:-Rj/10) of the appellant on 18.11.2014 and thus Respondent No.4 resorted to pressure tactics by issuing the relieving order of the appellant dated 28.11.2014 ibid out of sheer malice and malafide. The Inquiry Officer, thereafter submitted his Report to the Commissioner Bannu against Respondent No.4 which was remitted back to the worthy Chief Secretary for necessary action, however, so far no outcome of the same could be ascertained. The Hon'ble Tribunal may call for the result of the same Inquiry Report from Respondent No.1.
- B. Incorrect. The appellant is a valid office bearer of the Association. No transfer order can be issued on administrative grounds. The issue of tenure has already been explained. Section-10 of the Khyber Pakhtunkhwa Civil Servants Act has been further explained through policies and instructions by the Provincial Government.
- C. Incorrect. Respondent No.4 is not competent to issue the transfer order of the appellant while the impugned order is the

result of political and administrative influence.

- D. Misstated. The first complaint against Respondent No.4 was submitted on 11.11.2014. The appellant was revengefully relieved on 28.11.2014 while the Writ of Quo-Warranto No.507-B/2014 (*Annex:-Rj/11*) was filed on 15.12.2014 at Peshawar High Court, Bannu Bench and finally the impugned order was issued on 23.01.2015 which is still pending adjudication.
- E. Incorrect as stated. Moreover, as per the Notification dated 28.10.2014 (*Annex:-Rj/12*) ban was imposed on all kinds of the posting and transfers in the Health Department. There are other Doctors domiciled of FATA serving at Bannu having longer tenures as compared to the appellant and likewise numerous other Doctors of FATA domiciled are serving at various hospitals of the settled area.

F. Needs no reply.

It is, therefore, humbly prayed that the reply of answering Respondents No.1-5 may graciously be rejected and the appeal as prayed for may graciously be accepted with costs.



STATEMELT OF DR. MUHAMMAD ISMAIL KHAN MEDICAL OFFICER KGN TH, BANNU......PETITIONER

Stated on oath that Dr. Muhammad Jahangir Khan was appointed as Assistant Professor (Paeds Surgery) at Bannu Medical College on 16/03/2009. After taking a charge on 17/04/2009, he remained absent from duty willfully and deliberately for more than three years from 17/04/2009 to 10/07/2012. He was served with a number of explanations & show cause notices from time to time by Chief Executive KGN TH/ Principal BMC and Secretary Health, KPK to resume duty but he did not bother to either return to his duty or respond to a series of notices/explanations even to the wide-spread news papers advertisements issued by the Health Deptt; He enjoyed by drawing all his salaries and basic science incentives and allowances from BMC of his absence period thus causing having financial loss to treasury of Pakistan. All explanations/show Cause notices and press cutting are attached for ready reference. Dr. Jahangir was assigned the charge of Additional Chief Executive illegally by the Chief Executive Dr. Shafiullah and Dr. Shafiullah CE was served with explanation by the Health department in this regard.

Dr. Jahangir is basically a (BS-18) Assistant Professor of Paeds Surgery. He was a promoted (BS-19) as Associate Professor of Paeds Surgery on adhoc basis for the period of one year then he again promoted (BS-20) as Professor of Peads Surgery in 14 June 2013 on adhoc basis for the period of one year (Two time excelrated promotion in adhoc is illegal). On 28 October, 2013 the Health Department gave additional duties of Chief Executive Khalifa Gul Nawaz Teaching Hospital Bannu as for your kind information additional charge rules explained in DDO handbook CH-7 (143) and Govt. of KPK Finance Department letter No.FD(SR-I)3-19/92 dated 12.08.1997 and in the same case FD(SR-D)3-2/2000 dated 18.11.2013. The post of additional duty is not more then (Six) 6 months after that the post shall be treated and having been abolished and its duties mentioned becoming part of the normal duties of the original existing post.

<u>Prayer:</u>

Dr. Jahangir is no more CE according to law.

2. Recovery should be made of the salaries and incentives / allowances of his absentee period (He was not illegible to get basic-science incentives and allowances because he was on Assistant Professor Post on clinical side).

Retired Senior Civil Servants and army officer/personnel with experience in senior administrative position are also eligible. The maximum age shall be 65 years". Now when the Respondent No.4 admittedly belongs to teaching cadre and has nothing to do with Management Cadre and is still serving in a junior rank/pay scale of BPS-18 then how his appointments to the Senior Scale Management Post can be justified? 

There is no incumbent of the 20 x posts of Senior/Junior Registrars of the 10 x Departments of KGNTH, no Specialist of the regular rank of Professor and Associate Professor is available in Bannu and if available then his Ward/Department is not functioning, e.g. Surgical, urology and Paediatrics Wards/Departments in KGNTH and Private Rooms in DHQTH & W&CTH have been converted into House Officers' Hostels. While the Girls Hostel of Medical College is being shared with young and immature girls of 1st year MBBS by the said Respondent No.4 alongwith his three other accomplices for their residential purposes and the entire facilities of cooking electricity are being enjoyed free of cost by the along



monopolist i.e. the Respondent No. 4 and his three other close accomplices. This sharing of accommodation with young/immature girls is not free from apprehension of social problems about sexual harassment of the young girls of 1st year MBBS by their teachers/ doctors, who are not obliged to obey any law or morality. It is further pertinent to mention that the said Respondent No. 4 is a regular Assistant Professor (BPS-18) but is so powerful that none of the Medical Superintendents (BPS-20) of the Group of Teaching Hospitals Banny can take any independent administrative action without his sweet will and wish otherwise the wrong doer are forthwith booked and sent to the pavilion of the Respondents No. 2&3 under the orders of the Respondent No.4. It is for this very reason that during his tenure as Chief Executive Group of Teaching Hospitals Bannu since October 2013 to December 2014 eight (08) Medical Superintendents have been transferred out of Bannu. Round about 15 Specialists Doctors have arrange either their transfer to other stations or to Projects out of the control of the Chief Executive Group of Teaching Hospitals Bannu or resigned or got pre-mature retirement from service, whose replacement is still awaited and their duties have been entrusted to Junior Doctors. Such is the dilemma of Health Service provisions by the Respondent No.4. The high handedness of the Respondent No. 4 may further be appreciated from the fact that after relieving the Director Finance of KGN Teaching Hospital Bannu his duties were entrusted to the Accounts Officer BMC Project namely Mr. Liaquat Ali. During this period the hospital's cash chest/safe was stolen alongwith a cash amount of Rs. 3.5 Million but no one dare to ask as to who has stolen the amount. A sum of Rs. 8 Millions allocated during FY-2013/14 for accident emergency fund in KGNTH Bannu was left to lapse as its expenditure did not suit the personal wishes of the Respondent No.4. It is pertinent to mention that the Directorate General of Monitoring & Evaluation (Govt of KP) has also to some extent commented upon the performance of KGNTI Bannu, vide their letter dated 02-6-2014.

Young Doctors Association was bound to point out the irregularities firstly to the Respondent No. 4 personally but when he did not pay any heed to redress the common doctors—cum—public grievances then the Petitioner had to take up the same with the concerned officials including the Respondents No. 2&3 in a representative capacity through issue of press statements as well as through written complaint dated 11-11-2014 addressed to the Respondent No.1 then the Respondent No.4 firstly issued to the Petitioner a warning letter No. 2005/CE/KGN dated 26-11-2014 and then relieved the Petitioner of his duties at KGN TH Bannu and directed to report to the Respondent No.3, vide letter No. 2020/CE/ dated 28-11-2014.

Copies of the Petitioner's complaint dated 11-11-2014, Respondent No. 4's warning letter dated 26-11-2014 and Petitioner's relieving letter dated 28-11-2014 are filed herewith and marked as Annex "J/1 - 3", respectively.

8. That it is evident from records that the Respondent No.4 is not qualified to hold either the office of Professor (Paediatrics) even on Adhoc basis nor that of the Chief Executive KGN Teaching Hospital Bannu, as yet the Respondents No. 1 to 3 have turned their ears deaf and dum over the hue and cry being made by the Public at large as well the Doctors Association at Bannu and are not ready to rectify the illegality by removing the Respondent No. 4 from the usurped post of Chief Executive Group of Teaching Hospitals Bannu for managing the hospitals properly. Therefore, the Petitioner sees no remedy except to beseech before this Hon'ble Court for grant of remedy against the illegal usurpation of the post of Chief Executive Group of Teaching Hospitals Bannu by the Respondent No.4; inter alia; on the following grounds;-

GROUNDS

(A). That the Petitioner has no other alternate and efficacious remedy for bringing the law in action against illegal usurpation of the post of Chief Executive Group of Teaching Hospitals Bannu by the Respondent No.4, which has caused worst type of deterioration in delivery of health services to the ailing inhabitants of this backward part of the KPK and against wastage of the hardly earned national exchequer allocated for this backward area.

(B) That careful study of Rule: 3,13&21 of the KPK Medical Institution Rules-2001 suggests that the Chief Executive is the highest office who supervise the performance of medical and health care institutions because of being a reporting officer over the performance evaluation/annual confidential reports of the Principal/Dean of the concerned faculty of Medical College as well as Medical Superintendents of the Teaching Hospitals. Only this aspect of the duties and responsibilities of the Chief Executive suggest that the incumbent of this office should be senior and mature person, for it cannot be expected of a BPS-18 officer to supervise and report accurately upon the performance and conduct of a BPS-20 officer. Therefore, appointment of the Respondent No.4 to the office of the Chief Executive is not only against the principles of administrative and bureaucratic hierarchy but is creating the sense of deprivation and degradation amongst the senior, able, responsible Doctors which in turn result in deterioration of the required services. Therefore, removal of the Respondent No.1 from the ibid public offices becomes extremely essential in the best public interest.

- (C). That since the Respondent No. 1 to 3 have been instrumental in the illegal appointments of the Respondent No.4 to the public offices at Bannu as well as Swabi because of favouritism; therefore, they do not pay any heed to the hue and cry of the public. Therefore the instant Petition is lawfully maintainable for compelling the Respondents to do what the law requires them to do under Article: 4 of the Constitution of Pakistan–1973.

fully qualified person able to shoulder the heavy responsibilities of the ibid public offices appropriately.

- (E). That even otherwise the immature and irresponsible attitude of the Respondent No.4 in absenting himself from the performance of his duties without leave, harassing illegally even the Medical Superintendents of the Group of Teaching Hospital Bannu, Senior Doctors, Nursing and Paramedical staff of the Teaching Hospitals Bannu are sufficient for his removal from the ibid public offices.
- (F). That to favour the Respondent No. 4 in his appointment to the ibid public offices the relevant provisions of Health Department (Govt of KPK)'s Notification dated 05-4-2007 and Rule: 3 of the KPK Medical Institution Rules—2001 have fully been bulldozed. Therefore, the instant Petition is lawfully maintainable for directing the Respondents to do what the law requires them to do and to refrain from doing what the law does not allow them to do.
- (G). That even ad-hoc appointment of the Respondent No. 4 to the ibid public offices is violative of Section: 4 of the KPK (Appointment Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act-2011, firstly because he does not possess the required qualification and secondly because he is not domiciled of the Southern districts of KPK. Therefore, he is liable to be removed from the ibid public offices.
- (H) That counsel for the Petitioner carves leave of this Hon'ble Court to urge more grounds at the time of hearing of this petition.


- 9. In view of the above humble submissions, it is earnestly prayed that this Hon'ble High Court may graciously be pleased to:-
