

Prayer in Appeal:

On acceptance of this appeal, the impugned orders No. 2890-94 dated 03/06/2021 and 2899-2902 dated 03/06/2021 may kindly be set aside and directing the respondent to send the appellant for intermediate college course of Police Training College Hangu, as per letter/order dated 01/06/2021 commencing from 05/06/2023 and maintaining his seniority in District Police Mardan.

Respectfully Sheweth:

1. That the appellant is respectable and law abiding citizen of Pakistan has every legal and constitutional right duly protected under the law and constitution of Islamic Republic of Pakistan 1973.
2. That appellant was serving as Head Constable (BPS-07) in the respondent department and presently serving the department (Police Station Saddar, District Mardan) at his best of ability.
3. That the appellant was transferred along with lien to District Mardan by placing him at the bottom in seniority, and vide order dated 07/10/2015 and order dated 22/10/2015 who

soon after reported arrival in District Mardan.
(Copies of orders dated 07/10/2015, 22/10/2015 and Naqalmads are attached as Annexure-A & B respectively)

4. That consequently vide Order OB No. 2416 dated 31/12/2015, the appellant was promoted as officiating Head Constable w.e.f 21/12/2015 and was also confirmed as per law and rules. **(Copy of order dated 31/12/2015 is attached as Annexure-C)**
5. That the appellant along with others were selected for Intermediate College Course by the respondent issued vide letter dated 01/06/2021, directing the appellant to appear on 02/06/2021 for completion of Nominal Roll and Medical Checkup before sending them for course. Consequently vide letter dated 02/06/2021, the Medical Superintendent DHQ Hospital Mardan was requested for Medical Examination of the appellant, accordingly he was medically examined and his Nominal Roll was also completed. **(Copies of letter dated 01/02/2021, letter dated 02/06/2021, Medical Report and Course of Nominal Roll are enclosed as Annexure D, E, F & G respectively)**

6. That to utter shock of the appellant and for reasons best known to the respondent, vide order issued vide No. 2890-94 dated 03/06/2021, lien of appellant along with others was detached from District Mardan and attached to his parent District of domicile fixing his seniority in his parent District with his colleagues, thus depriving the appellant from the Inter College Course, in violation of law and rules on the subject and further vide letter/order of the even date issued vide No. 2899-2902. **(Copies of orders/letters dated 03/06/2021 are attached as Annexure-H & I respectively)**
7. That the appellant earlier approached the Hon'ble Peshawar High Court, Peshawar through Writ Petition No. 2321-P/2021 which disposed off vide order dated 16/02/2023 with the direction to the department to pass appropriate order. **(Copy of order dated 16/02/2023 is attached as Annexure-J)**
8. That the appellant approached to the respondent department by filling departmental appeal which is not decided till yet. **(Copy of the departmental appeal is attached as Annexure-K)**

9. That appellant is aggrieved from the impugned orders/letters issued vide No. 2890-94 and 2899-2902 dated 03/06/2021, with no other remedy hence approached this Honourable Tribunal on the following amongst other grounds:

GROUND S:

- A. That the act and omission of the respondent department is illegal, unconstitutional, without lawful authority and of no legal effect, therefore needs the interference of this Hon'ble Tribunal.
- B. That this Hon'ble Tribunal has already decided the same nature cases and vide judgment dated 01/02/2023 had accepted the appeals along with other connected appeals by setting aside impugned transfer orders.
- C. That the appellant has served the department at the best of his ability but even that respondent attached the lien of the appellant and transferred to his parent district, which is illegal and liable to be rectified.
- D. That the appellant was transferred to District Police Mardan and he was deprived of his seniority as he was placed at the bottom of

seniority in Mardan Police, while by now again when he was selected for Intermediate College Course, the impugned orders were issued whereby the appellant was deprived of his due right for no reason.

- E. That the appellant after transfer to District Mardan with his lien performed his duty with honesty and full devotion and after he was promoted in the year 2015, where after he was selected for Intermediate College Course, he underwent through the medical check up and also completed his nominal roll while there after for no reason the impugned orders were issued when valuable rights had accrued in his favour.
- F. That the appellant never requested for his transfer from District Charsadda to District Mardan, rather he was transferred under the orders of the respondent, thus he could not be punished without any omission and commission on his part.
- G. That the appellant is paid salaries from District Police Mardan, his GP Fund has also been transferred to District Mardan while for no good reason he is deprived of his right with a single stroke of pen.

- H. That even otherwise previously the Head Constables of other Districts were selected for such courses in District Mardan while only the appellant is discriminated.
- I. That the impugned orders are also without lawful authority and the respondent department is the competent to make selection for Intermediate College Course while in the instant case the impugned orders have been issued in total disregard of law and rules which are liable to be struck down.
- J. That the appellant was selected after due process of law by the competent authority on his turn for which he underwent through the entire process thus he could not be deprived of his due legal right.
- K. That the appellant is denied treatment in accordance with law and he is subjected to exploitation in violation of the Article 4, 25, 37 and 38 of the Constitution of Islamic Republic of Pakistan.
- L. That the appellant is perfectly fit, eligible and coming up to the criteria for selection to the subject course/training and he was selected according to the rules on the subject.

- M. That after section and completing the process, the appellant was legitimately expecting that he will undergo the subject course accordingly but he was subjected to sheer violation of law on the subject.
- N. That there is no omission and commission on part of the appellant, thus he cannot be deprived of his right of better livelihood being his fundamental right and respondent thus is required to act as per law and constitution of the land.
- O. That the appellant be allowed to add/rely upon other grounds at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of this appeal, the impugned orders No. 2890-94 dated 03/06/2021 and 2899-2902 dated 03/06/2021 may kindly be set aside and directing the respondent to sent the appellant for intermediate college course of Police Training College Hangu, as per letter/order dated 01/06/2021 commencing from 05/06/2023 and maintaining his seniority in District Police Mardan.

Any other remedy which deem fit appropriate may also be granted in favour of appellant.
