- That the appellant is not an aggrieved person under Article 212 of the Constitution of 1973.
- That the instant appeal is badly time barred.
- That the Appellant is not entitled for any relief from this Honorable Service Tribunal as being a contractual employee at the time of Joining of SST (M/P), hence was not entitled for grant of lien for the post of CT (BS-15).
- That the Appellant has got no cause of action, locus standi to file the instant appeal.
- That the Appellant has not come to this Honorable Tribunal with clean hands.
- That the Appellant has concealed material facts from the Honorable Tribunal.
- That the Appeal is not maintainable in the present form being devoid of merits.
- That the conduct of Appellant estopped him to bring the instant appeal before this Honorable Bench.
- That he act of the Respondent Department is legal as per Rules / Policy.

ON FACTS.

- **1.** That para-1 pertains to the record of the appellant.
- **2.** That para-2 is correct.
- 3. That para-3 is correct.
- **4.** That para-4 is subject to provision of record / proof of the appellant, hence needs no further comments.
- 5. That para-5, is incorrect and denied on the grounds that the Appellant is not entitled for any relief from this Honorable Service Tribunal as being

- F. Incorrect and denied, the respondent department has acted as per rules and policy, and liable to be maintained the act of Respondent Department.
- **G.** <u>Legal</u>, the respondent department also seek permission of this Honorable Tribunal to advance additional grounds at the time of arguments.

In light of the stated factual and legal position, it is humbly prayed that the case of the appellant may be dismissed in favor of the department.


