APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED OFFICE ORDER DATED 08.11.2022, WHEREBY THE RESPONDENT NO.04 HAS ALLOTTED QUARTER NO.03 AT SHAMI RODA PESHAWAR BY THE RESPONDENT NO.02 WITHOUT VACATING THE ALLOTMENT OF APPELLANT AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELANT WITH IN THE STATUTORY PERIOD OF 90 DAYS.

PRAYER:

ON THE ACCEPTANCE OF THIS SERVICE APPEAL, THE ORDER DATED 08.11.2022 MAY KINDLY BE SET ASIDE AND THE RESPONDENTS MAY KINDLY FURTHER BE DIRECTED TO ALLOW THE APPELLANT TO RESIDE IN QUARTER NO.03 AT SHAMI ROAD PESHAWAR. ANY OTHER REMEDY WHICH THIS

HON'BLE TRIBUNAL DEEMS FIT-AND PROPER MAY ALSO BE AWARDED IN THE FAVOR OF THE APPELLANT.

RESPECTFULLY SUBMITTED;

FACTS:

1. That Appellant is law abiding citizen of Pakistan and appointed as junior clerk BPS-11 back into the years 2018 in the Respondent Forest Department and performing their duties to the entire satisfaction of their superior.
2. That the father of the appellant was working as superintendent in the respondent department and was occupying residential quarter No.03 at Shami Road Peshawar, who will be retired on 30.04.2021 and the appellant being the employee of the same department filed an application dated 14.04.2021 to Respondent No.03 to allot him residential quarter No.03 at Shami Road Peshawar and the father of the appellant also filed an application dated 15.04.2021 to respondent No.04 and requested to allotted the quarter No.03 to his son. **(Copies of the Applications dated 14.04.2021 & 15.04.2021 is attached as Annexure-A&B).**
3. That previously for the allotment of quarter No.02 situated at Shami Road Peshawar, the respondent No.03 asked guidance/opinion regarding allotment of quarter No.02 on which the respondent No.02 through letter dated 24.05.2019 replied to respondent No.03 that "being custodian administrator of the quarters you are requested to process the case regarding allotment of the quarter No.02 as per rules" and response of letter dated 24.05.2019 of the quarter No.02 was retained and extended to Mst.JamilabibiNaibQasid NTFP through an order dated 25.06.2019, therefore on the basis of same analogy, respondents No.3 constitute a departmental committee on the application of the appellant for the purpose of allotment of residential quarter No.03 at Shami Road Peshawar and meeting of Departmental Allotment Committee was held on 20.05.2021 to discuss and finalized the allotment of quarter No.03 situated in premises of NTFP directorate Shami Road Peshawar, wherein the committee/forum anonymously agreed for allotment of the said quarter No.03 to the Appellant. **(Copies of the letter 24.05.2019, order dated 25.06.2019& minutes of the allotment committee meeting are attached as Annexure-C,D&E)**
4. That on recommendation of housing allotment committee quarter No.03 on Shami Road Peshawar was allotted to the Appellant through the order dated 27.05.2021. **(Copy of Order dated 27.05.2021 is attached as Annexure-F)**

5. That astonishingly and without vacating the allotment of the appellant, respondent No.02 issued an order dated 08.11.2022 where by respondent No.05 has allotted the quarter No.03 at Shami Road Peshawar in NTFP colony and mentioned in that order that Mr.Darwaish Khan Superintendent has vacated the said quarter on his retirement despite the fact that the appellant has already residing in the said quarter which was allotted to him on the retirement of Darwesh Khan Superintendent. **(Copy of the impugned Order Dated 08.11.2022 is attached as Annexure-G)**
6. That the appellant feeling aggrieved from the order dated 08.11.2022, filed a departmental Appeal dated 12.02.2022 which was not responded with in statutory period of 90 days. **(Copy of the Departmental Representation is attached as Annexure-H)**
7. That the appellant having no other remedy except to file the instant service appeal for redressal of their grievances on the following grounds amongst others.

GROUND:

- A. That the impugned order dated 08.11.2022 and not taking action of the departmental appeal of the appellant are against the Law, Rules, Fact, Norms of Justice, therefore not tenable and liable to be set aside.
- B. That the concern quarter No.03 which was allotted to the appellant comes into the domain of respondent No.03 i.e. Director NTFP which has also endorsed by the respondent No.02 in the letter dated 25.05.2019, but despite that respondent No.02 passed the impugned order having no authority which means the impugned order is void ab initio and has no legal effect.
- C. That the impugned order dated 08.11.2022 cannot be operated, because without vacating the appellant from concern quarter No.03, private respondent No.05 has allotted the same quarter through the impugned order dated 08.11.2022 and in that impugned order it was also mentioned that concern quarter is allotted to private respondent No.05 by the vacation of Mr.Darwesh Khan on his retirement despite the fact appellant has allotted the quarter No.3 on the retirement of Mr.Darwesh Khan in which he is still residing over there.
- D. That the quarter No.03 was allotted to the appellant after proper recommendation of departmental allotment committee and that the departmental allotment committee was constituted by the competent authority respondent No.03 i.e. Director NTFP Peshawar.
- E. That in the similar nature case of allotment of quarter No.02 to


Mst. Jamila bibi, the respondent No.03 sought guidance from respondent No.02 about the allotment which respondent No.2 responded to respondent No.3 that "being custodian administrator of the quarter and process the case as per rule" and on the same analogy the quarter No.03 has also been allotted to the appellant by the respondent No.03.

- F. That in the impugned order dated 08.11.2022 it was mentioned that quarter No.03 as vacated by Mr. Darwesh Superintendent on his retirement was allotted to respondent No.05, despite the fact that the appellant is still residing in concern quarter No.03 and in this respect respondent No.03 also wrote a letter dated 22.11.2022 to respondent No.02 that the concern quarter has already been allotted to the appellant vide letter dated 27.05.2021 and requested to revisit the order (impugned order) issue in this regard. **(Copy of the letter dated 22.11.2022 is attached as Annexure-K)**
- G. That the appellant has not been treated in accordance with law and rules by issuing the impugned order dated 08.11.2022 by the respondent No.02, which is liable to be set aside.
- H. That the appellant seeks permission of this Hon'ble Tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of instant service appeal.

It is therefore most humbly prayed that the appeal of the appellant may be kindly accepted as prayed for.
