


17<sup>th</sup> April, 2023 1. Learned counsel for the appellant present. Mr. Fazal Shah, Addl: AG for the respondents present.

2. This matter was lastly fixed for ~~06.04.2022~~<sup>7 9</sup> but that was not brought on the cause list nor placed before the Tribunal on the said date. Through this application, the applicant seeks restoration of the Execution Petition filed vide order dated 08.07.2021.
