Respectfully Sheweth:-

1. That the Appellant was appointed as "**Junior Clerk BPS-05**" on 01/10/1995 in the Directorate of Sports NWFP Peshawar. Copy of appointment order is enclosed as Annexure "A".
2. That thereafter the colleagues of appellant were promoted to the post of Senior Clerk BPS-14 on 28/08/2017 and thereafter the colleagues of the appellant was promoted to the Office Assistant BPS-16 on 21/05/2019. Copy of one of the office order is enclosed as Annexure "B".
3. That the appellant was promoted to the post of Senior Clerk on 26/05/2022. Copy of promotion order is enclosed as Annexure "C".
4. That it is also pertinent to mention here that the appellant along with colleagues appointed on the same date which was granted selection grade from BPS-05 to BPS-07 on 17/10/2002. Copy of order dated 17/10/2002 is enclosed as Annexure "D". *The copy of seniority list is enclosed as D/2.*
5. That in the attendance circumstances, the appellant feeling aggrieved, the appellant submitted department appeal on 05/12/2022 which was properly processed vide dairy No. 1197 dated 03/01/2023, file No. 17 (Promotion). Copy of the department appeal is enclosed as Annexure "E".
6. That the department appeal of the appellant was not decided within stipulated period of three months, hence, the appellant feeling aggrieved and the Appellant has been left with no other remedy but to

invoke jurisdiction of this Honourable Tribunal Court, inter alia, the following grounds:

GROUND:

- i. That the act and omissions of the respondents authority by not considering the appellant for seniority is against law, facts and circumstances.
- ii. That the act and commissions of the respondents authority by passing the seniority is against the principal of law and service rules as well as policy.
- iii. That the appellant had been appointed with their colleagues on the same date and selection grade was also given on the same date and thus in attendance circumstances the appellant is entitled for promotion / seniority on the same pedestal as their colleagues have been promoted / seniority given.
- iv. That counsel of the Appellant may very graciously be allowed to add further grounds during the course

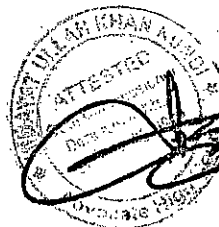
