SERVICE APPEAL U/S 4 OF THE KP SERVICES TRIBUNAL ACT, 1974 READ WITH ALL PROVISIONS OF LAW/RULES, GOVERNING THE SUBJECT, AGAINST THE FINAL SENIORITY LIST (AS IT STANDS ON 30.12.2021) ISSUED VIDE ORDER NO.AD/LG&RDD/NSR/2022/74, DATED: 22.02.2022 ALONGWITH SUBSEQUENT PROCEEDINGS THERETO, INCLUDING PROMOTION ORDERS DATED: 18.01.2022 & 26.09.2022 OF THE PRIVATE RESPONDENTS.

Prayer-in-Appeal:

On acceptance of instant Service Appeal, impugned Final Seniority List (As stood on 30.12.2021) Issued, vide order NO.AD/LG&RDD/NSR/2022/74, dated: 22.02.2022 alongwith subsequent proceedings thereto, including promotion orders dated: 18.01.2022 & 26.09.2022 of the private respondents may be declared as illegal, unlawful, without lawful authority, void ab-initio and of no legal, hence be set at naught and appropriate directions may be issued to the concerned quarters to issue final seniority list in order of merit, in line with Section 8(3) of the KP Civil Servants Act, 1973 read with Rule 17(1)(a) of the KP Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 and appellant may be promoted against the substantive vacant posts of Senior Village Secretary, from the date of eligibility, alongwith all consequential benefits.

Respectfully Sheweth:

1. That Respondent Department invited applications from eligible candidates for filling up numerous vacant posts of Junior Village Secretary, through advertisement dated: 27.06.2015, circulated in the Daily Mashriq.
(Copy of advertisement dated: 27.06.2015 is attached as Annexure "A")
2. That appellant being qualified, applied for the posts of Junior Village Secretary and gone through the entire process of selection successfully, conducted by the Respondent Department through National Testing Service-Pakistan, evident from merit list issued/prepared by NTS. It is worth to mention that final merit list prepared by the Respondent Department after conducting interviews, has not been issued so far, reasons best known to it, however, its extract therefrom was prepared by the appellant, being essential for just decision of the case and proper assistance of this Hon'ble Tribunal.
(Copies of merit list and extract from the final merit list are attached as Annexures "B & C" respectively)
3. That, on the recommendations of the District Selection / Recruitment Committee at its meeting held on 21.01.2016, the Competent Authority appointed appellant as Secretary BPS-7 (now upgraded to BPS-9), in Village Council Alibaig District Nowshera, vide Office Order No.141-50/AD(LG&RDD)/NSR/2016, dated: 29.01.2016.
(Copy of appointment order dated: 29.01.2016 is attached as Annexure "D").
4. That Respondent Department issued impugned office orders dated: 18.01.2022 & 26.09.2022, vide which private respondents were promoted to the substantive vacant posts of Senior Village Secretaries, in violation of merit list and in absence of proper seniority list, within the meaning of Section 8(3) of the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 17(1)(a) of the Khyber Pakhtunkhwa Civil Servants (Promotion, Transfer and Appointment) Rules, 1989, rather it will not be out of place to mention herein that the Respondent Department prepared final seniority list of Junior Village Secretaries (BPS-9), on the strength of date of birth, that too, was kept concealed, reasons best known to the concerned quarters.
(Copies of office orders dated: 18.01.2022 & 26.09.2022 alongwith the minutes of departmental promotion committees and final seniority list (As it stood on 30.12.2021)/order dated: 22.02.2022 are attached as Annexures "E, F & G" respectively).
5. That appellant approached Respondent No.2/Appellate Authority, through application/departmental appeal dated: 15.12.2022, for cancellation of promotion orders dated: 18.01.2022 & 26.09.2022 supra, issuing of proper seniority list and his promotion as Senior Village Secretary against the substantive vacant post, from the date of his eligibility, however, to no avail so far.
(Copy of Departmental Appeal dated: 15.12.2022 is attached as Annexure "H")
6. That appellant, being aggrieved of final seniority list (as it stood on 30.12.2021), issued vide order dated: 22.02.2022, promotion orders dated: 18.01.2022 & 26.09.2022 of the private respondents alongwith subsequent proceedings thereto and depriving him from his due right of promotion against the substantive vacant post of Senior Village Secretary, approaches this Hon'ble Tribunal, inter-alia, on the following grounds:

GROUNDS:

- A. That impugned final seniority list (as it stood on 30.12.2021), issued vide order dated: 22.02.2022, promotion orders dated: 18.01.2022 & 26.09.2022 of the private respondents alongwith subsequent proceedings thereto, are against the law/rules governing the subject, hence liable to be set at naught.
- B. That, admittedly, appellant was appointed in the Respondent Department on the basis of merit list prepared by National Testing Service Pakistan (NTS), **(ALREADY ANNEXED AS-B)**. It is worth to mention that after conducting interviews by the Respondent Department, appellant stood 4th on aggregate merit list, evident from extract from the merit list **(ALREADY ANNEXED AS-C)**, but astonishingly the private respondents, much low on merit list from appellant, were promoted on the strength of their respective date of birth, instead to consider the order of merit, which speaks volumes of malafide on part of the respondent department.
- C. That comprehensive mechanism for determination of seniority of civil servants has been given under Section 8(3) of the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 17(1)(a) of the Khyber Pakhtunkhwa Civil Servants (Promotion, Transfer and Appointment) Rules, 1989, but astonishing the Respondent Department had very conveniently departed therefrom and issued the impugned seniority list alongwith impugned promotion orders, which is illegal, unlawful, without lawful authority, void ab-initio and of no legal effect, hence be set at naught.
- D. That impugned seniority list and subsequent impugned promotion orders of the private respondents have been issued in utter disregard to law/rules governing the subject, hence carry no legal weight.
- E. That Respondent Department is duty bound to issue seniority list in order of merit not only because all the appointments of junior secretaries were made on the basis of proper merit list prepared by the National Testing Service Pakistan but also because Respondent No.2 directed the concerned quarters through circular No.Director(LG)3-1/Establishment/2022/2343-49, dated: 24.10.2022 to prepare seniority lists in order of merit instead of the date of birth of the Village Secretaries. However, Respondent Department has deliberately continued practice of issuing seniority list on the basis of date of birth instead of the order of merit, which attracts jurisdiction of this Hon'ble Tribunal in order to ensure fair play and justice.
(Copy of circular dated: 24.10.2022 is attached as Annexure "I")
- F. That the appellate authority had annulled such like practice of issuing merit list on the basis of the date of birth and subsequent promotions, evident from order No.Director(LG)3-1/Establishment/2022/1988-94, dated: 15.11.2022, operative part whereof is reproduced as under:
"After examination of the record, personal hearing of the appellants, the appeal of the appellant is dismissed and the Assistant Director Local Government and Rural Development Department Haripur shall issue the seniority list of Village / Neighbourhood Council Secretaries on the order of merit as per Rule-17(1)(a) of the (Appointment, Promollon and Transfer) Rules, 1989."
Needless to add that order dated: 15.11.2022 ibid of the appellate authority was implemented by the concerned quarters, vide office order dated: 16.12.2022 but reluctant to treat appellant with the same yard stick, having case at par, thus discriminated within the meaning of Article 25 of the Constitution of Islamic Republic of Pakistan, 1973.
(Copies of orders dated: 15.11.2022 & 16.12.2022 are attached as Annexures "J & K" respectively).

- G. That appellant has legal vested right to be treated in accordance with law and to be extended equal protection of law, enshrined in Articles 4 & 10-A of the Constitution of Islamic Republic of Pakistan, 1973.
- H. That, admittedly, impugned seniority list was issued, vide order dated: 22.02.2022, while the impugned promotion order dated: 18.01.2022 was issued much prior therefrom, which further strengthen stance of the appellant that all the impugned proceedings were carried out unilaterally and kept the appellant in dark, for ulterior motives and malafide intentions, therefore, it can safely be concluded that he has been condemned unheard, which the doctrine of audi alteram partem.
- I. That any other, with the permission of this Honourable Tribunal will be taken at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of instant Service Appeal, impugned Final Seniority List (As stood on 30.12.2021) issued, vide order NO.AD/LG&RDD/NSR/2022/74, dated: 22.02.2022 alongwith subsequent proceedings thereto, including promotion orders dated: 18.01.2022 & 26.09.2022 of the private respondents may be declared as illegal, unlawful, without lawful authority, void ab-initio and of no legal, hence be set at naught and appropriate directions may be issued to the concerned quarters to issue final seniority list in order of merit, in line with Section 8(3) of the KP Civil Servants Act, 1973 read with Rule 17(1)(a) of the KP Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 and appellant may be promoted against the substantive vacant posts of Senior Village Secretary, from the date of eligibility, alongwith all consequential benefits.

Any other relief, not specifically prayed for and deemed appropriate to this Hon'ble Tribunal in circumstances of the case may also be granted to the appellant.

2. In the appeal the appellants have stated that:
- They were appointed as Village Council Secretaries in BPS-07 on 21.09.2015 and at that time there was no service structure of Senior/Junior Village Council Secretaries and their seniority at that time was according to date of birth and date of charge assumption and which was intact for four years and there were no objection of any VC/NC Secretary on the seniority list.
 - They have objection over the final seniority list of village/Neighborhood Council Secretaries issued vide letter No. AD(LG-HYI-15/VCs-NCs/2018/3928-32 dated 30-08-2019 which has been made as per the aggregate marks assigned by the District Selection and Recruitment Committee.
 - Junior Village/Neighborhood Council Secretaries have been promoted on fake Seniority list in December, 2019.
 - They have requested that the Seniority list may be revised and the promotion order of Junior VC/NC Secretaries made in December 2019 may be cancelled.

3. According to Section 17-1 (a) of the Appointment, Promotion & Transfer Rules 1989:

17. Seniority: (1) The seniority inter se of civil servants (appointed to a service, cadre or post) shall be determined:-
(a) In the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission, for as the case may be, the Departmental Selection Committee; provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection.

4. After examination of the record, personal hearing of the appellants, the appeal of the appellant is dismissed and the Assistant Director LG&RDD Haripur shall issue the seniority list of Village/Neighborhood Council Secretaries on the order of merit as per section 17 (1) (a) of the Appointment, Promotion & Transfer Rules 1989.
