

- 1- That the appellant was initially appointed as junior clerk (BPS-5) in the Department of LG&RDD vide order dated 24.12.1975. That after appointment as junior clerk the appellant started performing his duty quite efficiently and up to the entire satisfaction of his superiors.
- 2- That appellant after serving the Department for more than fifteen years as junior clerk (BPS-5) was promoted as Senior Clerk (BPS-7) on seniority cum fitness basis and on the proper recommendation of Departmental Selection Committee vide Notification dated 21.5.1991.
- 3- That it is very pertinent to mentioned that appellant has also served the LG&RD Department as Assistant on acting charge basis for period of three years with effect from 1.9.1998 to 31.3.2001.
- 4- That before devolution the appellant time and again requested the concerned authority for regular promotion to the post of Assistant BPS-11 but no heed was paid to the said requests of the appellant for regular promotion to the post of Assistant (BPS-11).
