

ORDER

In pursuance with the directions of Inspector General of Police, Khyber Pakhtunkhwa, Peshawar issued vide CPO memo No. 2119/Legal, dated 22.04.2022 & vide memo No. 8834-40/E-IV, dated 22.09.2022, the judgment of Honorable Service Tribunal dated 25.11.2021, in Service Appeal No. 1090/2016 is hereby implemented. A Selection Board comprising on the following officers under Standing Order No. 06/2014 read with Police Rules 13-8 amended in the year 2017 is hereby constituted to consider all those constables concerned to FRP Kohat, Bannu & DI Khan Ranges for promotion, who have not passed the lower school course and have exceeded upper age limit for the lower school course and otherwise considered suitable for promotion shall be placed on list C-II in their respective regions.
