PST at Government Girls Primary School Dhert Shohai District Mansehra was dismissed from service by the DEO (Female) Mansehra vide Order No. 1986-95 dated 03/03/2015 after serving Show Cause Notice and giving her an opportunity of personal hearing on charge of irregular/fake/bogus appointment.

WHEREAS, consequently the above aggrieved teacher lodged/preferred an appeal to the Director E&SE Khyber Pakhtunkhwa, Peshawar (appellant authority) against her dismissal from service with the pray to set aside her dismissal order issued by the DEO concerned followed by her reinstatement.

AND WHEREAS, the Director E&SE Khyber Pakhtunkhwa, Peshawar constituted a committee vide Notification No. 5500-09 dated 23-04-2015 for the scrutiny of appeals of above dismissed teacher.

AND WHEREAS, the committee having scrutinized appeal of above affected teacher on the basis of available record and merit of the case submitted its report to the Director E&SE Khyber Pakhtunkhwa, Peshawar with the findings and recommendations reproduced briefly below:-

- 1. She belongs to U/C Pairan where no post was lying vacant and her name was at S. No. 02 of the merit list under ETEA R.No.1701380. She was appointed at GGPS Dheri Sohai U/C Karnol against one of the two posts lying vacant there vide Endst.No.5360-84 dated 18/5/2012 at Sr.No.20 U/C Karnol is adjacent to her own U/C according to the list provided by DEO(F) Mansehra.
- 2. Appeal may be accepted as she was on merit and eligible for appointment in her own U/C but there was no vacancy in her own U/C and she was required to be consider for appointed in adjacent U/C according to the policy.

PRAYER:

THAT ON ACCEPTANCE OF THIS APPEAL, THE ORDER DATED 03.03.2015 MAY BE SET ASIDE BEING ILLEGAL AND AGAINST THE LAW AND RULES AND THE APPELLANT MAY BE RE-INSTATED IN SERVICE WITH ALL BACK AND CONSEQUENTIAL BENEFITS. ANY OTHER TRIBUNAL REMEDY WHICH THIS **AUGUST** DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH:

- 1. That the respondent department advertised some posts of different categories in the daily News-paper "Aaj". Copy of Advertisement is attached as Annexure-A.
- 2. That the appellant appeared in test and qualified the test and interview got first position in the merit list for Union Council Pairan. Copy of Merit list attached as Annexure-B.
- 3. That at the time of appointment there were 2 vacancies available at UC Karnol i.e. at GGPS Bhoraj and GGPS Dheri Shohai. As in the UC Karnol only one candidate qualified the test and interview, therefore, against the second post the appellant was appointed being top in merit for adjacent UC in accordance with Section 3(4) of the Teachers Appointment 7 regulatory Act of 2011.
- 4. That according to the Section-3(4) of the Act-2011, "In case of non availability of candidates in a Union Council where the school is situated such appointment should be made on merit from amongst the eligible candidates belonging to the adjacent union council.

That, since the appellant belongs to UC Pairan. At that time there was no vacant post in UC Pairan and the UC Karnol is adjacent the appellant's UC. There were two posts available and only one candidate namely Farah Naz qualified for ETEA test and obtained score in merit list 46.00 and the appellant obtained score in merit list 62.67 amongst all the candidates. Copies of Merit List are attached as Annexure-C & D.

15.

- 6. That due to non availability of post in UC Pairan and got first positions amongst all the candidates, the competent authority appointed/adjusted the appellant in the adjacent UC Karnol at GGPS Dheri Shohai as per rules and regulations vide Notification dated 18.05.2012. Copy of Appointment Order is attached as Annexure-E.
- 7. That appellant submitted her charge report on 24.05.2012 at GGPS Dheri Shohai and served the department for about 3 years honestly and with full devotion to the entire satisfaction of the department and there is no complaint against the appellant from the public and the department. Copy of Charge Report is attached as Annexure-F.
- 8. That after a passage of about 3 years the DEO (F) Mansehra issued an illegal, unlawful show cause notice on 29.09.2014 with the allegation of illegal appointment in other Union Council at GGPS Dheri Shohai on the part of appellant. The appellant responded against the said illegal and unlawful show cause notice with full justifications and comprehensive detail reply submitted properly to the competent authority. Copies of Show Cause Notice and Reply are attached as Annexure-G &H.
- 9. That the DEO (F) Mansehra without considering the lawful and comprehensive reply of the appellant, imposed the major penalty upon the appellant and issued Notification regarding "Dismissal" from service of the

appellant. Copy of Notification dated 03.03.2015 is attached as Annexure-I.

That against the Illegal and Unlawful Dismissal from service Notification dated 03.03.2015, the appellant submitted her Departmental Appeal to the competent appellate authority on 19.03.2015 but despite of that the respondent department failed to reply within the statutory period of ninety days. The appellant having no other remedy, hence the present appeal on the following grounds amongst the others: Copy of Departmental Appeal is attached as Annexure-J.

GROUNDS:

- A) That the impugned order dated 03.03.2015 is against the law, rules, norms of justice and material on record, therefore, not tenable in the eyes of law.
- B) That the appellant has not been treated according to law and rules and has been punished for nothing.
- C) That no charge sheet, statement of allegations has been served on the appellant by the respondent department and as such mandatory provisions of law are violated.
- D) That neither any regular inquiry has been conducted against the appellant nor any statement has been recorded in the presence of appellant or any statements of the others colleagues have been given by the inquiry committee in the instant case which is the total violation of law and rules.
- E) That the appellant has not been associated with the inquiry committee nor chance of cross examination was provided to the appellant by the committee in fact no inquiry was ever conducted against the appellant.

- F) That the impugned order is politically motivated and has been passed to accommodate the blue eyed persons.
- G) That even no chance of personal hearing was provided before issuing the penalty order and as such golden principles of Audi Altram Partem was violated by the respondent No.3.
- H) That the impugned order has been passed after 3 years and as such valuable rights under the principle of Locus Poenetentiae were created in favour of appellant. Therefore the appellant cannot be removed from service in a slipshod manner.
- I) That even the authority has not passed dispensing with regular inquiry order and despite that a slipshod manner was adopted while dismissing the appellant from service which is the violation of mandatory provisions of law and rules. Therefore the impugned order is not sustainable in eyes of law.
- J) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant maybe accepted as prayed for.







Acceptance of your appeal & subsequently your appointment order was the result of misuse of authority by the then EDO according to his sweet well& wishes against the recruitment rules, as per inquiry report received through Government of Khyber Pakhtunkhwa, Elementary & Secondary Education Department letter No SO(S/M)E&SED/4-17/2013 Umar Khan EDO BS-19 dated 25/08/2014 More over the then EDO(E&SE) has been removed from Government Service in connection with all such bogus appointment including yours made by him.
- 2) Going through the finding and recommendation of the inquiry committee, the material on record & other connected papers including your defiance before the inquiry committee:-

I am satisfied that you have committed the following acts/omissions specified in rules.

- a) Misconduct and dishonesty in getting bogus/faked appointment without due process of recruitment.
- b) Inflected huge financial losses to the Govt: Treasury receiving pay as result of bogus appointment.
- c) By snatching established rights of the deserving candidates due for appointment on merit. Cheating/canceling the facts for unlawful appointment with collusion of then EDO.
- 3) As a result thereof, I as competent authority have tentatively decided to impose upon you the major penalty of dismissal from services under rule 4 of the said rules.

4) You, are hereby, required to Show Cause as to why the aforesaid penalty should not be imposed upon you & also intimate where you desire to be heard in person.

5) If no reply to this notice is received within seven days or not more than fifteen days of its delivery, it shall be presumed that you have no defiance to put in and in that case an ex-party action shall be taken against you.

With the utmost respect the appellant submits as under: -

- 1. That, the appellant is M.A Islamiyaat with PTC, CT, B.Ed and has approximately 3 years regular service. Copies of the documents are annexed as annexure "A, A1, A2, A3, A4, A5, A6".
- 2. That the E.D.O (E&SE) Mansehra advertised vacancies of different cadre including PST (F) in the daily "AAJ" Newspaper dated 20.05.2011 Copy of the advertisement is annexed as annexure "B".
- That the appellant applied for PST post and deposited Rs.300/- on account of Director ETEA for test fee.
- That the appellant appeared in the ETEA Exams under Roll
 No.1701380 and obtained 188 marks out of 300.

 Consequently the appellant qualified in interview to have conducted by the department at GGHS No.2 Mansehra.

 Copy of ETEA result is annexed as annexure "C".





- 5. That at the time of appointment, two vacancies were lying vacant in the union council Karnol i.e at GGPS Bhoraj and GGPS Dheri Shohai.
- 6. That according to section 3(4) of the act 2011;

"In case of non-availability of candidates in a union council where the school is situated such appointment should be made on merit from amongst the eligible candidates belonging to the adjacent union council".

Pairan. At that time there is no vacant post in union council.

Pairan and union council Karnol is appellant's adjacent union council. In union council Karnol only one candidate namely Earah Naz qualified for ETEA test as well as interview having a score in a merit list 46.00.

Table of the list of vacant posts in union council of District Mansehra clearly shows that at the time of appointment there were two posts in union council Karnol at GGPS Bhuraj.

According to the law, rules policies of the Khbyer Pakhtunkhwa Government;





"That by initial recruitment on merit at union council level provided that if no suitable candidate is within the union council is available then from the adjacent union councils on merit".

Copy of Merit List union council Karnol, list of vacancies and copy of rules & policy are annexed as annexure D, E & F.

- 7. That the candidates examined by the respondents belonging to union council Pairan, the appellant stood first amongst all the candidates. Copy of merit list of union Council Pairan is annexed as annexure "G".
- 8. That the competent authority appointed/adjusted the candidate qualified from union council Karnol adjacent to the union council Pairan, in GGPS Bhuraj, therefore, the appellant to have appointed at the vacancy at GGPS Dheri Shohai in union council Karnol as per rules and regulations dealing with the matter. Copies of adjacent union council certificate and appointment order are annexed as annexure "H & I".
- 9. That after the passage of two and half years, the DEO (F)

 Mansehra issued an illegal and unlawful show cause notice

 No.7767 dated 29.09.2014 with the allegation of illegal





appointment. Copy of the show cause notice is annexed as annexure "J".

- 10. That the appellant submitted detail reply to the show cause notice issued by the competent authority. Copy of reply to show cause notice is annexed as annexure "K".
- 11. That the DEO (F) without consider the reply of the appellant without personal hearing and without giving opportunity of defense dismissed the appellant unlawfully and unjustly. Copy of dismissal notification is annexed as annexure "L".
- 12. That the copies of certificate of union council Pairan, health and age certificate, domicile certificate, transfer orders, arrival reports, first and last pay rolls are annexed as annexure "M, M1, M2, M3, M4, M5, M6".

GROUNDS

- A. That the impugned order is illegal, unjust and being unlawful is out rightly liable to be cancelled and the appellant may be reinstated.
- B. That, the committee conducted the so called inquiry not to have constituted as per requirement of law, it was comprised of the hostile and biased members, thus the





entire process of so called inquiry were in contravention of law, thus order passed by so called committee is not sustainable under the law.

- C. That, so called inquiry was allegedly conducted without observing the relevant provisions of law and the procedure prescribed there for.
- D. That the above said inquiry committee neither to have issued any notice nor any charge sheet given to the appellant nor the statement of appellant recorded nor of any witness in presence of appellant, thus the appellant deprived of her precious right of cross-examination.
- E. That, it was incumbent upon the said inquiry committee, to provide the entire material used against the appellant, before conducting the inquiry, so as to enable the appellant to make her proper defense against the allegations leveled against the appellant.
- F. That, above all the same, the so called committee did not have provided the opportunity of hearing and chance to defend herself before the committee, thus order being of major penalty passed in contravention of the principle of natural justice, thus the entire edifice built there upon is in utter violation of law, justice and also against the rules and regulations laid down under the KPK Civil Servants Act.





S. That, the appellant to have sustained the huge loss to her service career of two and half years and also deprived of her right of public service to have guaranteed under the Constitution of Islamic Republic of Pakistan, 1973, in as much as the provision of Article 10A of the Constitution has also been not adhered to while passing the unlawful order, therefore, it amounts to violation of the Constitution provisions whereby the impugned order is void against the law and passed in violation of principle of natural justice and the command to have ordained by the constitution.

It is therefore, most humbly prayed that on acceptance of this appeal, the impugned order may be declared as against the law, justice and derogatory to the Constitution as such may be cancelled and the appellant may be reinstated to her service with back benefits.
