Preliminary objections

- 1. That the appellant has got no cause of action.
- 2. That appeal is bad for Mis-joinder and Non-Joinder of necessary parties.
- 3. That appellant has been estopped by his own conduct to file the appeal.
- 4. That appeal is badly time barred.
- 5. That appeal is not maintainable in its present form.
- 6. That a civil servant had no vested right to claim posting transfer to any particular post at particular place of his choice, nor did he has any right to continue to hold a particular post at particular place.
- 7. That the competent authority transfers the appellant in public interest and for administrative reasons. Government servant holding a transferable post had no vested right to remain posted at one place of his choice for unlimited period.

- 8. That transfer of an employ/public servant fell within the ambit of terms and conditions of service which include transfer and posting and the same is the part of service. It was for the authority to determine where services of any staff member was required.
- 9. That appellant neither agitated any element of Malafide on the part of competent nor any right has been infringed.
- 10. That proper sanction has been obtained from the KP election commission in the case of replying respondent by the senior member board of revenue.

ON FACTS

- 1. **Para No. 01** of the appeal Pertains to record
- Para No. 02 is Correct to the extent of posting of 2. appellant as a Tehsildar Tangi of District Charsadda dated 17-10-2022 and he was transferred through general order and report to commissioner office on dated 03-03-2023. Similarly replying respondent assumed the charge of the post of Tehsildar Tangi on dated 07-03-2023 and performing his official duties till date. It is pertinent mentioned here that replying respondent attested various mutations. Rest of the Para of the appeal is incorrect. It is pertinent to mentioned here that on dated 18-01-2023, Khyber Pakhtunkhwa Assembly was dissolved and care-taker set up was installed. As per article 218 of constitution of Pakistan read with 224 of constitution, it is the constitutional requirement of election commission conduct to free. fair transparent elections and for this purpose care-taker

Govt has the mandate to done necessary posting transfers with prior permission of election commission and the same is done in the instant case so the plea of appellant that he was pre-maturely transferred is imprudent and not seem genuine to appealable mind. Appellant was transferred on administrative reasons by the competent authority in public interest. (Copy of NOC for posting transfer order, assumption of charge and relevant documents are annexed as A, B & C respectively)

- 3. **Para No. 03** needs no reply
- 4. Para No. 04 is legal.

GROUNDS:-

- A. **Para No. A** of the ground is incorrect. Posting/transfer order has been issued in accordance with the rules by the competent authority in public interest on administrative reasons. Civil servant had no vested right to be posted to any particular place to any length of time.
- B. Para No. B of the ground is incorrect, election commission of Pakistan vide letter dated 28-02-2023 empowered the care taker Government Of Khyber Pakhtunkhwa to done postings/transfer up to BPS-16 and competent authority after receiving permission order postings transfers as per its mandate. (Copy of letter dated 28-02-2023 is annexed as D).
- C. **Para No. C** of the ground is Incorrect. Posting transfers are included in the terms and conditions of service and the competent authority has power to transfer any civil



servant to any place and instant posting transfer was made in public interest.

- D. **Para No. D, E & F** of the ground are not related to replying respondent.
- E. **Para No. G** of the ground is Incorrect. Replying respondent is regular Naib Tehsildar and the same is evident from the posting transfer order.
- F. **Para No. H** of the ground is Incorrect. Replying respondent has been performing duty as a Regular Naib Tehsildar for the last one and half years.
- G. **Para No I & J** of the ground are incorrect. Facts and circumstances of the said judgments i. e 2018 SCMR 1411 is altogether different from instant case.
- H. Para No K of the ground is legal.

In view of the above, appeal of appellant having no legal ground may kindly be dismissed with heavy cost.






