**PARA-WISE COMMENTS ON BEHALF ON**  
**RESPONDENTS NO 1 TO 4**

**PRELIMINARY OBJECTIONS :**

1. That the appeal in hand is not maintainable and incompetent in the eyes of law.
2. That the appellant has got no cause of action and locus standi to file the instant appeal.
3. That the appellant has not come to the tribunal with clean hands.
4. That the appellant has suppressed all the relevant and material facts.

5. That the appeal is mis-constructed and mistakenly drawn, hence liable to be rejected.

**On Facts**

1. Pertains to record, needs no comments.
2. Incorrect, hence denied. The service length of appellant is completed for promotion as Inspector but he has not passed the departmental exam held, which is pre-requisite for promotion from Sub-Inspector to Inspector according to Departmental Examination rules 1950. (Seniority list is attached as annexure-I)
3. Pertains to record.
4. That as per rule 7(2) of Departmental Examination rules 1950, Notification No 1136-46 /XIX-1-140 dated 3/08/1950, Excise Inspectors and Sub-Inspectors will normally be required to qualify subject IV only and Taxation Inspectors and Sub-Inspectors may qualify in all subjects. It is brought into kind notice that the appellant has appeared in Departmental Examination conducted by the department and as per result declared dated 27-09-18 appellant passed only two papers while he failed in remaining two papers i-e paper II (Excise Law) and paper IV (Excise Law). The appellant has availed/ exhausted four chances of his examination. (Departmental Examination result dated 27-09-18 and 07-05-21 are attached as annexure II and III)
5. Pertains to record.
6. Needs no comments.
7. Incorrect, each and every person is dealt in accordance with law. The discretion has been exercised by the government under rule 7(3) of Departmental Rule, 1950 vide its notification dated 13.08.12. It is pertinent to mention here that, one time relaxation has been granted to eligible candidates against the vacant positions, subject to the condition that they will have to pass subsequent examination for next promotion while appellant despite availing four (04) chances of departmental

exam is still failed. It is further added that the applicant has been retired from service on 28.02.23 on the age of superannuation i.e. 60 years. Hence, it's not possible for him to appear in next Departmental examination. (Copy of order dated 13.08.12 is attached as annexure IV)


8. That appellant has availed four (04) chances of Departmental exam and has not pass in a single attempt. Moreover, as per rule 10-A of Departmental Rules 1950, if any officer fails to pass departmental examination within the period of two years, he shall be liable for removal from service. (Copy of Departmental Rules, 1950 attached as annexure V)
9. Incorrect, criteria for promotion does not only mean seniority but it also depends upon fitness for the promotion as well as passing of Departmental Examination and to be determined by Departmental Promotion Committee. The rest pertains to record and every case is decided on merits and none is above the law.
10. Every person is dealt in accordance with law and rules.
11. Incorrect, hence denied.


### GROUNDS


- A. Ground A is devoid of facts. Even though the appellant/petitioner does not meet eligibility criteria for his promotion to the next higher grade and had already been explained in Para 4 and 8.
- B. Ground B is already explained in para 7.
- C. Everyone is dealt in accordance with law under Article 4 of Constitution of Islamic Republic of Pakistan 1973.
- D. Already explained.
- E. Pertains to record.

No. F 136-46-Taxi/XIX-C-140. The Governor, North West Frontier Province is pleased to make the following rules for the Departmental Examination of Officers of the North West Frontier Province Excise & Taxation Department.

- 1- A Departmental Examination for Officers of the North West Frontier Province Excise & Taxation Department will be held at Peshawar/Abbottabad twice a year about the 3<sup>rd</sup> week of December at Peshawar and the first week of August at Abbottabad or on such other dates and places as are notified by the Excise & Taxation Commissioner, N.W.F.P. The exact dates and place of Examination will be notified before hand in the N.W.F.P. Gazette.
- 2- The Assistant Excise & Taxation Officers of circles should forward to the Excise & Taxation Commissioner, N.W.F.P. before 15<sup>th</sup> September of each year and 15<sup>th</sup> May next year or within one month after the publication of the result of the last examination whichever is later, the names of Officers who intend to set for the examination together with the subject in which they wish to be examined.
- 3- The examination will be conducted by the Excise & Taxation Commissioner N.W.F.P.
- 4- The paper will be set, answer examined and marks awarded by the Examiner nominated by the Excise & Taxation Commissioner with the approval of the N.W.F.P. Government.
- 5- The answer books of the Candidates will be forwarded by the Excise & Taxation Commissioner, N.W.F.P., to the examiners appointed under rule (4). The examiners will submit under sealed cover their award of marks, along with answer books in original to the Excise & Taxation Commissioner, who will fill in the names of the examinees in the award statement.
- 6- After each examination the names of successful candidates will be published in the N.W.F.P. Government Gazette.
- 7- 1) The following Offices will be required to pass the examination :
  - a) Assistant Excise & Taxation Officers.
  - b) Excise & Taxation Inspectors.
  - c) Excise & Taxation Sub Inspectors.

- 3) The requirements of sub rules (1) may be waived, in the case of Officers falling in clause (a) by the Provincial Government & in the case of clause (b) and (c) by the Excise & Taxation Commissioner, N.W.F.P.

8. The Excise & Taxation Commissioner may permit the following persons to in the examination :-

- a) All accepted candidates for executive posts in the Excise & Taxation Department.
- b) Any person whose name has been forwarded by the chief authority acceding State or Agency in the Tribal Areas.

9. To pass the examination it will be necessary for a candidate to secure the following minimum marks in each subject :

<u>Designation of Officers:</u>	<u>Minimum Marks:</u>
Assistant Excise and Taxation Officers.	60 per cent (High Standard)
Excise & Taxation Inspectors and Sub-Inspectors.	50 per cent (Lower Standard)

10. An Officer of the N.W.F.P. Excise and Taxation Department must pass a departmental examination in the prescribed subjects within a period of 2 years from the date of appointment to the post, or the date of publication of these rules whichever is later. This condition will be deemed not to have been complied with if an officer fails to pass in any subject at his fourth attempt thereat.

Amendment: Vide Notification No.8072/T, dated 7-3-1953.

10-A. If any officer fails to pass the departmental examination within the prescribed period of two years he shall be liable for removal from service.

11. The subjects and text-books prescribed for the examination are given in Schedule A appended; a three hours paper will be set in each subject carrying 100 marks. The Schedule is subject to amendment from time to time.

12. Candidates will be provided with the bare text of the various Acts for use in the examination. These are detailed in Schedule B appended to these rules.
