

RESPONDENTS

SECTION-4 OF THE APPEAL UNDER KHYBER PAKHTUNKHWA, SERVICE TRIBUNAL ACT, 1974 AGAINST IMPUGNED SENIORITY LIST DATED. WHEREBY THE SENIORITY OF APPELLANT HAS BEEN DISTURBED IN VIOLATION OF LAW AND RULES AND ANY NOT **TAKING** ACTION ON THE **AGAINST** OF **DEPARTMENTAL** APPEAL **APPELLANT WITHIN** STATUTORY PERIOD.

#### **PRAYER:**

THAT ON ACCEPTANCE OF THIS APPEAL, THE IMPUGNED SENIORITY LIST DATED. 8.01.2015 MAY BE SET ASIDE AND THE RESPONDENTS MAY BE DIRECTED TO RESTORE THE SENIORITY POSITION OF THE APPELLANT AS IT WAS IN LIST DATED. 10.09.2014 WITH ALL CONSEQUENTIAL AND BACK BENEFITS OF SERVICES. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL MAY DEEM FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

#### **RESPECTFULLY SHEWETH:**

#### **FACTS:**

- 1. That the appellant joined the Police Force in the year \$\frac{15}{3}\$.10.1990 and with the passage of time the appellant was promoted as officiating Head Constable vide order dated 22.6.2005. The appellant passed Intermediate Course in the year 2007 and then promoted as officiating ASI in the year 2008 and subsequently confirmed as ASI vide order dated 27.9.2011. Copies of Orders are attached as A and B.
- 2. That the appellant was promoted to the rank of officiating S.I. in the year 2013. The appellant name was also recommended for upper course vide order dated 10.9.2014. Copies of Orders are attached as Annexure-C and D.
- 3. That The appellant was confirmed in the year 2011 whereas the private respondents have been confirmed in the year 2014 but despite that in violation of Police rules the private respondent have been shown senior to appellant in List-E. Copy of List-E of 2014 is attached as Annexure-E.



- 4. That it is worth to mention here that before the promulgation of Police Order 2001, Nowshera, Charsadda and Peshawar Districts were considered in a single bench i.e. Peshawar Range but after the promulgation of police order, the Peshawar district was separated from Districts Nowshera and Charsadda and formed as CCPO Peshawar and other two districts Nowshera and Charsadda have been separate from Peshawar.
- 5. That the respondents have been issued revised Seniority List on 8.1.2015 in violation of law and rules. The appellant referred appeal against that impugned seniority list on 10.2.2015. The CCPO, Peshawar also filed comments on the departmental appeal of the appellant but despite that the appeal was remained undisposed till the lapse of statutory period of 90 days. Copies of Impugned List, Appeal and Comments are attached as Annexure-F, G and H respectively.
- 6. That now the appellant comes to this Honourable Tribunal on the following grounds amongst the others inter-alia:

#### **GROUNDS:**

- A) That respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973. The appellant had legitimate right of promotion to the rank of SI on the score that they have differed on account of shortage of available vacancies as well as on the basis of original seniority list, but are going to be deprived the appellant which is illegal, unlawful and without lawful authority, and unlawfully which is unjust, unfair and hence not sustainable in the eyes of law.
- B) That the respondents are duty bound that in case of any alteration in the seniority list, they should circulate the same to all officer concerned, but they have failed to observe their legal obligation and have kept the seniority list as secret document and more so are going to promote juniors to the appellant against the available vacancies.
- C) That every government employee has legitimating expectation of rising up in government hierarchy by means of promotion, but in this case the appellant already accrued right have bulldozed, which act is not only illegal but also highly undesirable and unwarranted.

- That as the appellant was already senior in the seniority list dated 22.1.2014 which created valuable right in favour of the appellant, therefore, the respondents were legally bound to issue notice for changing of his seniority position but in the instant case no prior notice or chance of haring was given to the appellant while changing his seniority position and as such the appellant has been condemned unheard.
- E) That no reasons what-so-ever, neither circulated or endorsed to the appellant while changing seniority position of the appellant, which is the violation of Section-24(A) of the General Clauses Act and also the Judgment of the Supreme Court of Pakistan reported as 1991 SCMR 2330.
- F) That even otherwise under the Principle of *Locus Ponetentiae* the seniority of the appellant can not be altered / relegated in an arbitrary and fanciful manner and as such the whole action of the respondents are against the law and norms of justice.
- G) That according to the Supreme Court of Pakistan's Judgment, the department has no authority to alter and modify the seniority list already issued by its own, thus the respondents have also violated the law laid down of the Supreme Court of Pakistan.
- H) That modification of seniority is against the principle of law governing the issue of seniority list has initiated in the Civil Servant Act 1973 and other related law.
- I) That even the respondent Deptt: has violated the Police Rules 13:11 of 1934, therefore the impugned seniority list is liable to be set-aside on this score alone.
- J) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.



DEPARTMENTAL APPEAL AGAINST THE REVISED SENIORITY LIST NO. 452 DATED 8-1-2015 NOTIFIED BY THE CAPITAL CITY POLICE OFFICER, PESHAWAR WHEREBY THE SUB-INSPECTORS OF DISTRICTS CHARSADIA AND NOWSHERA WERE INCLUDED IN IT AND THAT THEY WERE ALSO MADE RANK SENIOR THAN APPELLANT ILLEGALLY.

#### Prayer in Departmental Appeal

By accepting this appeal, the revised seniority list No. 452 dated 8-1-2015 may graciously be rectified by declaring the appellant rank senior than the Sub-Inspectors of Districts Charsadda and Nowshera and that he may also be selected for upper college course instead of the above employees.

## Respected Sir,

That the appellant files this departmental appeal before Appellate Authority inter-alia on the following grounds:-

- 1. That the appellant joined the service of Police Department as Constable on 13-10-1990. He was then allowed to participate in "Lower School Course". After qualifying the said course, he was promoted to the rank of Head Constable on 22-6-2005. (Copies of appointment letter & promotion order are appended as Annex-A & B).
- 2. That the appellant was also recommended for "Intermediate School Course", who successfully qualified the same. He was then granted promotion as Assistant Sub-Inspector on 31-8-2009 (Copy of promotion order is appended as Annex-C).
- 3. That thereafter, the appellant was also elevated as Sub-inspector w.e.f 13-11-2013 on account of his dedication, devotion and commitment to his job (Copy of promotion order is appended as Annex-D).
- 4. That the Competent Authority vide letter No.1198-97 dated 10-9-2014 directed the Additional Inspector General of Police, Investigation KPK Peshawar and other officers to send clearance as well as no departmental

inquiry certificate/willingness within 3 days so as to send the appellant and other eligible officials for "Upper College Course". After receiving the said information, the Competent Authority deputed the Sub-Inspectors mentioned at serial No. 1 to 26 in the above list/letter (Copy letter is appended as Arnex-E).

- That as the appellant was placed at serial No. 61, therefore, he had also legal expectancy, to be recommended and sent for the above course in near future. But strangely, the Competent Authority vide order No. 452 dated 8-1-2015 straightaway no ified a revised seniority list of Sub-Inspectors through which the Sub-Inspectors of District Charsadda and Nowshera were included in it and that they were made rank senior than appellant illegally. They were also selected and sent for "upper college course" in utter violation of law while the appellant was deprived of his due right of his seniority as well as said course (Copies of revised seniority list and letter are appended as Annex-F & G).
- That the Competent Authority was under statutory obligation to first notify the tentative seniority list in respect of Sub-Inspectors and then to provide an opportunity to the aggrieved employees by filing "objection petitions" if any against the said seniority list being the requirement of law. But he failed to do so. Similarly, the said Authority was also legally bound to have provided an opportunity of personal hearing before determining their seniority and notifying the impugned revised seniority list. But he did not bother for the same. Thus, the appellant has been condemned / penalized without being heard, contrary to the basic principle of Natural Justice known as "Audi Alteran Partem". Reliance in this respect can be placed on the judgment of august Supreme Court of Pakistan reported in PLD-2008-SC-412 (a). The relevant citation is as under:-

## (a) Administration of justice---

Opportunity of hearing---Scope---Order adverse to interest of a person cannot be passed without providing him an opportunity of hearing---Departure from such rule may render such order illegal.

It is pertinent to mention here that the right of personal hearing is also proved from Holy Quran "that when Almighty Allah directed the Angels to bow down before Adam (P.B.U.H). All obeyed except Iblis (Satan) who was then provided an opportunity to explain as to why he should not be expelled from the place of



mercy. He after improper justification, was expelled from Heaven for ever (vide Surah Al-Bagarah Chapter No.2 Verse No. 34 Al-Quran).

It is well settled law that the decision of the August Supreme Court of Pakistan is binding on each and every organ of the State by virtue of Article 189 and 190 of the Constitution of Islamic Republic of Pakistan, 1973. Reliance can be placed on the judgment reported in 1996-SCMR-Page-284 (Citation-C). The relevant citation is as under:-

Arts. 189 & 190--- Decision of Supreme Court—Binding, effect of---- Extent—Law declared by Supreme Court would bind all clourts, Tribunals and bureaueratic set-up in Pakistan.

Thus, the Competent Authority has acted in derogation of law by not giving any opportunity of personal hearing to the appellant before determining the disputed seniority and notifying the impugned revised seniority list. Therefore, the above list is bad in law.

- 7. That the appellant has not been treated in accordance with law, rules and policy on the subject. Thus, the Competent Authority has acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan 1973.

  Hence, the impugned list is against the spirit of administration of justice.
- 8. That the Competent Authority has notified the impugned list in mechanical manner and the same is perfunctory as well as non-speaking and also against the basic principle of legal norms of justice. Thus, the same is not sustainable in the eye of law.
- 9. That it was inclumbent upon the Competent Authority to have placed the Sub-Inspectors of District Charsadda and Nowshera at the bottom of the said list so as to secure the ends of justice. But he failed to do so and made the said officials rank senior than the appellant. Therefore, a great injustice has been caused to the appellant by notifying jointed seniority list of "two separate wings". Hence, the impugned list is not warranted under the law.
- 10. That the impugned list is the result of misreading and non-reading of relevant documents. Thus, it is liable to be set aside.
- 11. That the impugned list is suffering from legal infirmities and as such it has, no sanctity under the law.



That the revised list in question is based on surmises and conjectures. Thus, the same is not tenable under the law.

In view of the above narrated facts and grounds, it is humbly prayed that the revised seniority list No. 452 dated 8-1-2015 may graciously be rectified by declaring the appellant rank senior than the Sub-Inspectors of Districts Charsadda and Nowshera and that he may also be selected for upper college course instead of the above employees.

## **RESPECTFULLY SHEWETH:**

## **Preliminary Objections:**

(1-6) All objections raised by the respondents are incorrect and baseless. Rather the respondents are estopped to raise any objection due to their own conduct.

## **FACTS:**

- Incorrect, the respondents are duty bound that in case of any alteration in the seniority list, they should circulate the same to all concerned officials, but they have failed to observe their legal obligation and have kept the seniority list as secret documents and more so are going to promote juniors to the appellant against the available vacancies.
- 4 Admitted correct by the respondents as the service record of the appellant is in the custody of

- the concerned department. Moreover the appellant did not raise the issue of discrimination.
- 5 Incorrect. While para 5 of the appeal is correct.
- Incorrect. The appellant has good cause of action to file the instant appeal.

## **GROUNDS:**

- A. Incorrect. The appellant has not treated according to law as respondents have violated the law rules and policy on the subject.
- B. Incorrect. While para B of the appeal is correct.
- C. Incorrect. While para C of the appeal is correct.
- D. Incorrect. they appellant did not concealing the real facts as the appellant was confirmed in the year 2011 whereas the private respondents have been confirmed in the year 2014 but despite that in violation of Police rules the private respondents have been shown senior to the appellant in List-E.
- E. Incorrect. Acts of the respondents is not in accordance with law.
- F. Incorrect. Acts of the respondents is not in accordance with law.
- G. Incorrect. The respondents have violated the law as according to Supreme Court of Pakistan's judgment the department has no authority to alter and modify the seniority list already issued by its own, thus the respondents have violated the law laid down of the Supreme Court of Pakistan.
- H. Incorrect. As already explained above in detail.
- I. While para I of the appeal is correct.
- J. Legal.

It is, therefore, most humbly prayed that the appeal of appellant may kindly be accepted as prayed for.
