The appellant has preferred the present appeal against order dated 27.4.2010 vide which his services were terminated where-after he preferred departmental appeal which was dismissed on 15.6.2015 and hence the instant service appeal on 7.7.2015.

Brief facts of the case of the appellant are that the appellant was appointed as Computer Operator (BPS-12) in the Court of learned Civil Judge/Illaqa Qazi Behrain Swat. His services were terminated during probation period vide impugned order dated 27.4.2010 regarding which departmental appeal of the appellant was dismissed by respondent No. 1 Hon'ble Administrative Judge, Peshawar High Court, Peshawar vide order dated 15.6.2015.

APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNAL ACT-1974 AGAINST THE IMPUGNED JUDGMENT & ORDER DATED 15-06-2015 OF THE HON'BLE RESPONDENT NO. 1 WHEREBY DEPARTMENTAL APPEAL AGAINST THE IMPUGNED ORDER DATED 27-04-2010 OF THE LEARNED RESPONDENT NO. 3 WAS DISMISSED IN A CLASSICALLY CURSORY MANNER



#### RESPECTFULLY SHEWETH,

1. That the appellant was duly appointed as Computer Operator (BPS-12) against a sanctioned & regular post at the court of the learned respondent no. 4, after going through the required criteria & prescribed manner. (Copy of appointment letter is annexed as Annexure "A").

- 2. That as usual appellant was initially appointed on probation basis to be followed with regularization. It was just after few months of appointment that the appellant's service was abruptly terminated vide the impugned order dated 27-04-2010 of the District & Session Judge/Zilla Qazi Swat. (Copy of the termination order is annexed herewith as Annexure "B").
- 3. That being aggrieved from abrupt termination, the appellant preferred a departmental appeal to the worth Administrative Judge Peshawar High Court Peshawar, but the same was dismissed vide the impugned judgment & order dated 15-06-2015. (Copies of departmental appeal & impugned order dated 15-06-2015 are annexed herewith as Annexure "C & D", respectively).
- 4. That again feeling aggrieved the appellant prefers the instant appeal for setting aside the impugned orders dated 15-06-2015 & 27-04-2010, upon the following grounds, inter alia.

#### **GROUNDS:**

\$

- A. That the termination order as well as of the Worthy Appellate Authority is against facts of the case, material available & law governing the subject, hence not tenable at all.
- B. That both the impugned orders are based on conjunctures & surmises & do not hold any water in the eyes of law.
- C. That the Hon'ble Appellate Authority failed to appreciate the fact that appointment against a regular & sanctioned post, through prescribed manner can not be terminated such abruptly & in a slip shad manner & solely on caprices & whims of the competent authority, but as per Sec-24 (a) of the General Clauses Act, the same must be reasonable, fair, transparent and must be a speaking order.
- D. That the appellant was proceeded against under E&D Rules, but the same rules prescribed a mechanism & a thorough procedure for removal, dismissal etc of service, but has never

provided any provision for such termination & that too for such abrupt termination.

- E. That even the Hon'ble Appellate Authority failed to appreciate the fact that as far as the "Unsatisfactory" performance is concerned & report by the immediate officer of the appellant i.e respondent no. 4 is concerned, the same respondent No.4 had appreciated the performance & even issued a certificate to that effect, but certainly the alleged view was changed without any justification and the appellant was made and escape goat. (Copy of performance certificate is annexed as Annexure "E").
- F. That there then issued neither any mandatory instrument in the form of any notice, show cause notice etc, nor was even allowed to be heard in person & was thus condemned unheard.
- G. That the appellant was appointed after going through the prescribed mechanism & after getting on to the rolls of the District Courts Service, so definitely certain vested & fundamental rights have been accrued to the appellant which could not be taken away such abruptly & even without any notice or rather without affording any opportunity of being heard in person, to the appellant or without any due process of law.
- H. That the Hon'ble Appellate Authority also didn't take notice of the established position that probationer & his services are not solely dependent upon the caprices & whims of the Competent Authority, but in rather governed by the law and rules.
- I. That from all prospective the termination order as well as the order of the Hon'ble Appellant Authority are unwarranted, against the rules & laws governing the subject & are liable to be set aside.
- J. That any other ground not raised here, may graciously be allowed to be raised at the time of arguments.

It is, therefore, humbly prayed that on acceptance of the instant appeal the impugned judgment & order dated 15-06-2015 of the Worthy Administrative Judge/Appellate Authority Peshawar High Court Peshawar & impugned order dated 27-04-2010 of the Learned District & Session Judge/Zilla Qazi Swat may very graciously be set aside & by doing so the appellant may very graciously be re-instated into service with all back benefits.

Any other relief not specifically asked for may also graciously be extended in favour of the appellant in the circumstances of the case.





YAHYA AFRIDI, J.- Through the instant
Departmental Appeal Akhtar Hussain, appellant herein,
has questioned the legality of the order dated 27-04-2010
whereby he has been terminated from service on the
ground of unsatisfactory performance during the
probationary period.

- In essence, the grievance of the appellant is that the impugned termination order, being without any prior notice may be declared as illegal, arbitrary and without lawful authority
- The worthy counsel along with appellant and the representative of the concerned Court of District and Sessions Judge were heard. Case-file perused.

Perusal of the record would reveal that the appellant was appointed as Computer Operator (BPS-12) with one of the conditions that his services shall be liable to be dispensed with at any time without any notice and assigning any reason before the expiry of the period of his probation vide order dated 21-01-2010. The appellant, while accepting the above condition, reported for his duty with effect from 22-01-2010.

Vide order dated 27-04-2010 the services of the appellant were terminated because his official performance was found by the competent authority not satisfactory as provided under sub-rules (2) and (3) of Rule 15 of the N.W.F.P. Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 ("Rules"), which reads as under:-

"15. Probation.- (1) A person appointed to a post on regular basis shall remain on probation for a period of two years, if appointed by initial recruitment, and for a period one one year, if appointed otherwise, provided that if his work or conduct during the period of probation has, in the appointing the of apinion found not heen authority, appointing the satisfactory, authority may, notwithstanding that the period of probation has not expired.-

(a) dispense with his service, if he has been appointed by initial recruitment; or

WELL SALES

- (b) revert him to his former post, if he has been appointed otherwise, or if there be no such post, dispense with his service; or
- (c) extend the period of probation for a period not exceeding one year in all and may, during or on the expiry of such extended period, pass such orders as it could have passed during or on the expiry of the initial probationary period."

In view of the above legal position, no case has been made out warranting interference by this Court in the impugned order, which is based on proper appreciation of record and the law cited above.

Accordingly, for the reasons stated hereinabove, this appeal, being bereft of any merit, is hereby dismissed.






