"Mian Shakirullah Jan, J:- Learned counsel for the petitioners contents, inter alia, that the rules have not been properly interpreted by the Service Tribunal and resulted in the wrong conclusion.

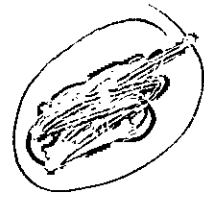

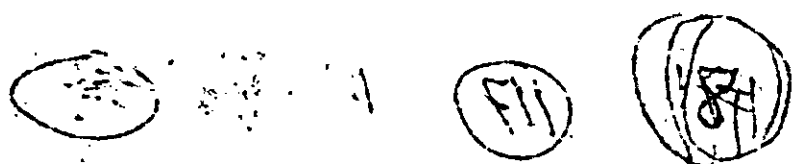
In-continuation of this Directorate letter No.1523/Personnel dated 06.03.2009, I have the honour to pin point further anomalies in the management cadre notified vide Govt. of NWFP Health Department Notification No. SOH(EV)4-20/08 dated 11.12.2008 as under: -

In the Directorate General Health Services NWFP Peshawar there are only 11 sanctioned posts of Assistant Directors in BPS-18 but the number shown in the schedule 1 (member of service in BPS-18) at Sl. No. 14 is 13 which is in correct rather misconceived. Similarly the post of Health educator in DGHS having separate service rules has also been included in the schedule (member of service in BPS-17) at Sl. No. 1 which is to tally in correct as the post is occupied by a qualified Health educator namely Mr. Shatiullah. Same is the case of Secretary Medical faculty. At Sl. No. 2(2) for post of Assistant Director (Hoem: and Tibb BPS-17) which are project posts and have no concern with the doctors having MPH or diploma in admission have been included in the management cadre which is again an irregular act as the post of Assistant Director (Hoemeo) is occupied by Homemo doctor Dr. Asadullah on contract basis till the project life. The post of Assistant Director Tibb has recently become vacant due to resignation from service of Mr. Abdul Waheed.

As already mentioned in this Directorate letter referred to above two posts of Deputy Directors and 4 posts of Assistant Directors reserved for promotion of the ministerial cadre have also been included in the management cadre with malafide intention which need to be deleted from the schedule -1 of the management cadre.

You will be astonished to note that out of (35) posts in BPS-20, (25) posts that is too, the top level lucrative administrative jobs have been reserved for a small chunk of doctors of about 350 in number, most of them obtained diplomas from private institutions by paying fees of the institutions without taking classis and applying for study leave.

(In the other hand 10 posts of BPS-20 Post have been reserved for a very large number of thousands of GDMOs who had been serving the state primarily in far-hand areas and although they are very competent, qualified and experienced but unfortunately they have not been able to obtain diplomas in public health from private institutions situated in Rajasthan. Most of them have got diplomas in clinical medicine.

Interestingly the MPH is the abbreviation of master in Public Health and holders of the posts have no right / capacity to run the administrative job like DGHs. Deputy Director, Assistant Director, Medical Superintendent etc.

The courses as prescribed for the doctor of management cadre if reported to the other doctors they will run the same positions in a very better way than those who will form part of the management cadre. About 24 posts of DMO have also been shifted from the (M) cadre to management cadre in the last Doctor with specialization in chest diseases are required to be posted against these posts.

It is established it is beyond any doubt that the management cadre has been trained by law doctors who have been posted in the Directorate and Secretariat having no knowledge of medical treatment and they are not expected to become consultants on the basis of obtaining simple a diploma in PHA.

With a view to avoid any further to thousands of GDMOs in terms of promotion it is high time to cancel the notification for management cadre otherwise I am afraid we may face litigation and an awkward position in the court of law. This is worth while to mention that the management cadre was also notified in 2005 vide Govt. of Rajasthan Health Department Notification No. 20 (MHPH-VI-3-2005 dated 29.01.2005 but the same could not be implemented due to gross irregularities.

On the other hand (10) posts of BPS-20 Post have been reserved for a very large number of thousand of GDMOS who had been serving the ailing humanity in far-flung areas and although they are very competent, qualified and experienced but unfortunately they have not been able to obtain diplomas in public health from private institution situated at Peshawar, albeit most of them have got diplomas/digress on clinical side


Interestingly the MPH is the abbreviation of master in Public Health and holders of the posts have no right / capacity to run the administrative job like DGHS Deputy Director Assistant Directors, Medical Superintendent etc.

The trainings as prescribed for the doctors of management cadre, if imparted to the other Doctors, they will run the same positions in a very better way than those who will form party of the management cadre. About 24 posts of DTOs have also been shifted from the GDMO cadre to management cadre inspite of the fact, Doctors with specialization in chest Diseases are required to be posted against these posts.

In nutshell it is beyond any doubt that the management cadre has been framed by few Doctors, who have been posted in the Directorate and Secretariate having no knowledge of medical treatment and they just want to become bureaucrats on the basis of obtaining simple a diploma in PH/Admn:

With a view to avoid un justice to thousand of GDMOS in term of promotion it is high time to cancel the notification for management cadre otherwise I am afraid we may face litigations and an awkward position in the court of law. This is worth while to mention that the management cadre was also notified in 2002 vide Govt. of NWFP Health Department Notification No. SO (ME)/H-IV/6-3/2007 dated 29.01.2002, but the same could not be implemented due to gross anomalies.

### THE NORTH-WEST FRONTIER PROVINCE HEALTH (MANAGEMENT) SERVICE RULES, 2001

#### PART - I GENERAL

1. *Short Title and commencement* - (1) These rules may be called the North West Frontier Province Health (Management) Service Rules, 2001.

(2) They shall come into force at once.

2. *Definitions.* -- In these rules, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say-

- (a) "Appendix" means the Appendix of these rules;
- (b) "appointing authority" in relation to a post, means the respective authority specified in para 4 of the NWFP Civil Servants (Appointment, Promotion and Transfer) Rules, 1989;
- (c) "Commission" means the NWFP Public Service Commission;
- (d) "Government" means the Government of NWFP;
- (e) "Governor" means the Governor of NWFP;
- (f) "initial recruitment" means appointment made otherwise than by promotion or transfer;
- (g) "post" means a post specified in the Appendix and such other posts as may, from time to time, be determined by the Government;
- (h) "recognized university" means any University incorporated by law in Pakistan or any other University declared by Government to be a recognized University for the purpose of these rules;
- (i) "Service" means the North-West Frontier Province Health (Management) Service.

PART - II RECRUITMENT

3. *Number and nature of posts* - The Service shall comprise the posts specified in the Appendix and such other posts as may be determined by Government from time to time.

4. *Method Of Appointment:* (1) Appointment to posts in Basic Scale 17 shall be made by permanent transfer from amongst Medical Officers of Medical Officer cadre in (BS-17) having the qualification of Masters in Public Health/Health Management Planning and Policy/Hospital Administration/Health Information Systems or equivalent qualification from a recognized University as determined by the Government, with three years service as Medical Officer; provided that the seniority for the purpose of permanent transfer shall be reckoned with reference to the date of appointment or acquiring relevant qualification, whichever is later.

(2) Appointment to posts in (BS-18) shall be made in the following manner:

(a) Seventy percent by promotion, on the basis of seniority-cum-fitness; from amongst officers holding posts in (BS-17); and

(b) Thirty per cent by initial recruitment, on the recommendation of the Commission, from candidates having the qualification of MBBS and Master's degree in Public Health Systems or equivalent from a recognized University, with three years experience in the relevant field.

(3) Appointment to posts in (BS-19) shall be made as follows:

(a) ninety percent by promotion, on the basis of seniority-cum-fitness, from amongst officers holding posts in (BS-18); and

(b) ten percent by initial recruitment, on the recommendation of the Commission, from amongst the candidates having the qualifications of MBBS and Doctorate in Public Health related field or equivalent qualification as determined by government, from a recognized university, with at least five years experience in the relevant field, or having the qualification of MBBS and M.Phil in Public Health related fields from a recognized

university, with at least ten years experience in the relevant field.

(4) Appointment to posts in (BS-20) shall be made by promotion, on the basis of seniority-cum-fitness, from amongst officers holding post in (BS-19).

(5) Age.—No person shall be appointed to the Service by initial recruitment who;

- a) in the case of appointment to a post in (BS-18), is less than 30 years or more than 45 years of age; or
- b) In the case of appointment to a post in (BS-19), is less than 35 years or more than 50 years of age; or
- i. Where recruitment is to be made on the basis of a written examination, on the 1<sup>st</sup> of January of the year in which the examination is held; and
- ii. in all other cases, on the last date fixed for submission of application;

Provided that in the case of persons whose services under government have been terminated for want of a vacancy, the period of service already rendered by them shall, for the purpose of upper age limit under this rule, be excluded from their age.

PART - III CONDITIONS OF SERVICE

6. Probation.—(1) A person appointed to a post against a substantive vacancy shall remain on probation for a period of two years, if appointed by initial recruitment, and for a period of one year, if appointed otherwise.

Explanation.-- (1) Officiating service and any period of service spent on deputation to a corresponding or a higher post may be allowed to count towards the period of probation.

(2) If the work or conduct of an officer during the period of probation has, in the opinion of the appointing authority, not been satisfactory, the appointing authority may, notwithstanding that the period of probation has not expired, dispense with his services, if he has been appointed by initial recruitment or if he has been appointed otherwise, revert him to his former post, or if there be no such post, dispense with his services.

(3) On completion of the period of probation of an officer, the appointing authority may, subject to the provisions of rule 7, either confirm him in his appointment, or if his work or conduct has, in the opinion of the appointing authority, not been satisfactory,

- (a) in case he has been appointed by initial recruitment, dispense with his services; or
- (b) in case he has been appointed otherwise, revert him to his former post, and if there be no such posts, dispense with his services; or
- (c) extend the period of his probation by a period not exceeding two years in all, and during or on the expiry of such period pass such orders as it could have passed during or on the expiry of the initial probationary period.

Explanation I.-- If no orders have been made by the day following the completion of the initial probationary period, the period of probation shall be deemed to have been extended.

Explanation II.-- If no orders have been made by the day on which the maximum period of probation expires, the probationer shall, subject to rule 7, be deemed to have been confirmed in his appointment from the date on which the period of probation was last extended or may be deemed to have been so extended.

7. Training & Departmental Examinations.-- (1) No person shall be confirmed in the Service unless he successfully completes such training and passes such departmental examinations as may be prescribed by Government.

(2) If an officer fails to complete successfully any training or pass any examination as prescribed under sub-rule (1), within such period or in such number of attempts as may be prescribed by Government the appointing authority may,--

- (a) in case he has been appointed by initial recruitment, dispense with his services; or
- (b) in case he has been appointed otherwise, revert him to his former post, and if there be no such post, dispense with his services.

8. Seniority.-- (1) The seniority inter se of the persons borne on the Service in various grades thereof shall be determined --

- (a) in case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission; provided that person selected for appointment to the Service in an earlier selection will rank senior to a person selected in a later selection; and
- (b) in case of persons appointed by promotion, with reference to the dates of their continuous regular appointment to the post; provided that persons selected for promotion to a higher post in one batch shall, on their

promotion to the higher post, retain their inter-se seniority as in the lower post.

(2) Seniority amongst various persons appointed to the service by initial recruitment vis-à-vis those appointed otherwise, not expressly provided for in this rule, shall be determined in accordance with the principle laid down in rule 17 of the North-West Frontier Province Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.

9. Liability to transfer and serve.--- Persons borne on the Service shall be liable to transfer anywhere in the North-West Frontier Province.

10. Private Practice.--- Persons borne on the Service shall not be allowed to undertake private practice and shall be entitled to non-practice allowance.

11. General rule.--- In all matters not expressly provided for in these rules, persons borne on the Service shall be governed by rules as have been or may hereafter be prescribed by Government and made applicable to them:

Provided that in case of a dispute the Government shall have the final authority to decide the matter in any manner it deems fit.

12. One-time exercise.--- (1) Notwithstanding any of the provisions of these rules, Government shall, as a one-time exercise, fill in posts in the Service by way of permanent transfer from amongst the officers of Medical Officer Cadre of equivalent grade who possess the prescribed qualification and who opt for it, provided that the option once exercised shall be final.

13. Deletion of posts.--- Posts reflected in the Appendix shall stand deleted from any other service rules for the time being in force and such rules shall be deemed to have been amended to this above extent:

Provided that the present incumbents of such posts shall continue to hold these posts till further orders by Government.

### THE NORTH-WEST FRONTIER PROVINCE PROVINCIAL MANAGEMENT SERVICE RULES, 2007

1. **Short title and commencement.**---(1) These rules may be called the North-West Frontier Province Provincial Management Service Rules, 2007.  
(2) These rules shall come into force at once.
2. **Definitions.**---In these rules, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say-
  - (a) "appointing authority" means the appointing authority as specified in rule 5 of these rules;
  - (b) "Commission" means the North-West Frontier Province Public Service Commission;
  - (c) "Department" means the Establishment and Administration Department;
  - (d) "Departmental Examination" means the prescribed examination to be conducted by the Department for confirmation within probationary period or for promotion to higher post, as the case may be;
  - (e) "Departmental Training" means any training prescribed by Government, the successful completion whereof is necessary for promotion to BS-18 and BS-19;
  - (f) "Schedule" means the Schedule appended to these rules;
  - (g) "Service" means the Provincial Management Service;
  - (h) "Secretariat" means the North-West Frontier Province Civil Secretariat as defined in rule 2(r) of the North-West Frontier Province Government Rules of Business, 1985; and
  - (i) "share" means the share specified for distribution between All Pakistan Unified Group and Provincial Officers as per Schedule-III.
3. **Nomenclature of the posts.**---The Service shall consist of the posts as specified in Schedule-I.

4. **Method of recruitment.**---(1) The method of recruitment, minimum qualification, age limit and other matters related thereto for the Service shall be as given in Schedule-I.

(2) Fifty per cent of posts in BPS-17 shall be filled in by initial recruitment to Commission and remaining by promotion. Ten percent of Secretariat posts in BPS-17 to 19 shall be reserved for officers of technical departments on reciprocal basis. Government may reserve twenty per cent posts for leave, deputation and training etc in each pay scale.

(3) Posts specified in Schedule-II shall be filled in by Officers borne on Provincial Management Service and All Pakistan Unified Group in the ratio prescribed in Schedule-III.

<sup>1</sup>**4-A. Training.**--- On appointment to the post borne on the service in BS-17, whether by initial recruitment or by promotion, every officer so appointed shall successfully complete one half year's mandatory training including one year training at the Provincial Services Academy Module specified in Schedule-IV and six months training attachment as specified in Schedule-V. After the training will be followed by Departmental Examination to be conducted by the Provincial Services Academy as specified in Schedule-VI.

5. **Appointing Authority.**---The Chief Minister, N.-W.F.P. shall be the appointing authority for posts borne on the Provincial Management Service specified in Schedule-I.]

6. **Saving.**---In all other matters not expressly provided for in these rules, the members of the Service shall be governed by the North-West Frontier Province Civil Service (Appointment, Promotion and Transfer) Rules, 1989, and any other rules pertaining to terms and conditions of service made or deemed to have been made under the North-West Frontier Provincial Servants Act, 1973 (N.-W.F.P. Act No. XVIII of 1973).

<sup>1</sup>**7. Transitional.** The condition of graduation as laid down in para 2(a) and column-5 against serial No. 1 of Schedule-I shall not apply for a period of seven years from the date coming into force of these rules to the existing incumbents for promotion against BS-17 posts.

8. **Repeal.**---The North-West Frontier Province Provincial Civil Service (Secretariat/Executive Group) Rules, 1997 shall stand repealed after the retirement of existing incumbents of both the cadres. Separate seniority list of both the cadres shall be maintained under the existing rules and they shall be promoted at the ratio of 50: 50:
