Prayer in Appeal:

On acceptance of the instant Appeal, the promotion order dated 21.10.2022 to the extent of Tariq Ali may be declared to be illegal, thus set aside and the Appellant may kindly be promoted to the post of Naib Tehsildar with all back benefits from the date when his juniors was promoted

The Appellant humbly submits as under:-

- 1. That the Appellant is peaceful and law abiding citizen of Pakistan and is entitled for all the rights guaranteed by the Constitution of Islamic Republic of Pakistan, 1973.
- 2. That in compliance with Judgment of service Tribunal and one the recommendations of the Departmental Selection Committee Appellant was appointed as Patwari vide Order dated 14.07.2007 by District Officer (R&E) Mardan. (Copy of the Appointment Order is attached as annexure A)
- 3. That since then the Appellant is performing his duty to the best of his ability and with dedication and has earned good reputation in revenue hierarchy in short span of time. He did his job with zeal and zest and left no stone unturned in discharge of his official duties.
- 4. That by dint of hard work and dedication to duty, the appellant on the recommendations of the Departmental Selection Committee was promoted as Kanungo (BPS-11) vide order dated 09.11.2016 by Deputy Commissioner Mardan. (Copy of the promotion order is attached as annexure B)
- **5.** That seniority list of the Kanungos was issued by Deputy Commissioner mardan on 19.01.2022

wherein the name of the Appellant appeared at Serial No 3 whereas the name of the Tariq Ali

Appeared at Serial No 4. (copy of the Seniority

List is attached as annexure C)

6. That afterwards Seniority list of the Kanungos was issued by Commissioner Mardan Division, Mardan on 24.03.2022 wherein the name of the Appellant Appeared at Serial No 5 whereas the name of the Tariq Ali appeared at Serial No 5. (Copy of the Seniority List is attached as annexure D)

- 7. That the Hon'ble Senior Member Board of Revenue ignoring the above quoted rules has promoted the Junior of the Appellant which is absolutely illegal and against the rights of the appellant. (Copy of the Promotion Order is attached as annexure E)
- 8. That the Appellant being aggrieved wherefrom has filed Departmental Appeal on 08.11.2022, which was no responded by the respondents and after passing of the statutory period of 90 days, the instant Appeal is hereby filed within next 30 days before this Hon'ble Court, inter alia on the following grounds: (Copy of Departmental Appeal is attached as annexure F)

GROUNDS:-

A) That the Appellant is peaceful and law abiding citizen of Islamic Republic of Pakistan and is fully entitled to all the basic and fundamental rights as

enshrined in the fundamental law of the state, interpreted and guaranteed by the law of the land.

- of B) That under Rule the Civil Servants (Appointment, Promotion and Transfer Rules, 1989) where the appointing authority considered it to be in public interest to fill a post reserved under the rules for departmental promotion and the most senior civil servant belonging to the cadre or service concerned, who is otherwise eligible for promotion, does not possess the specified length of service the authority may appoint him to that post on acting charge basis. (Copy of the Rule 9 of APT Rules 1989 is attached as annexure (3)
- C) That the acts of the Respondents of by not promoting the Appellant against the post of Naib Tehsildar may be declare by this Hon'ble Tribunal to be illegal, because the respondents has violated the Rule 9 of the Civil servants (APT Rules 1989).
- D) That the fundamental rights of the Appellant has blatantly violated by the Respondents and the Appellant has been discriminated and has been denied his due rights under the Constitution of Islamic Republic of Pakistan, 1973.
- E) That the Appellant is not treated in accordance with law, rules and Regulations.

F) That any other ground not raised here specifically may graciously be allowed to be raised at the time of arguments.

PRAYER:-

It is, therefore, most humbly prayed that, On acceptance of the instant Appeal, the prayer sought for in the heading of the Appeal may be allowed in favour of the Appellant.

Any other relief, not specifically asked for may also graciously be extended in favour of the Appellant in the circumstances of the case.







DEPARTMENTAL APPEAL AGAINST THE ORDER DATED 21.10.2022 PASSED BY SENIOR MEMBER BOARD OF REVENUE VIDE WHICH JUNIOR OF THE APPELLANT (TARIQ ALI) WAS PROMOTED FROM THE POST OF KANUNGO TO THE POST NAIB TEHSILDAR ON ACTING CHARGE BASIS AND APPELLANT WAS IGNORED.

PRAYER IN APPEAL:

ON ACCEPTANCE OF THIS APEEAL THE APPELLANT MAY KINDLY BE PROMOTED FROM THE DATE HIS JUNIOR WAS PROMOTED WITH ALL BACK BENEFITS AND ORDER OF PROMOTION DATED 21.10.2022 TO THE EXTENT OF TARIQ ALI MAY BE SET-ASIDE.

- 1. That in compliance with judgment of the Service Tribunal and on the recommendations of the Departmental Selection Committee appellant was appointed as Patwari vide order dated 14.07.2007 by District Officer (R&E) Mardan. Copy of the appointment order is attached as annexure-A
- 2. That since then the appellant is performing his duty to the best of his ability and with dedication and has earned good reputation in revenue hierarchy in short span of time. He did his job with zeal and zest and left no stone unturned in discharge of his official duties. There is not a single complaint against the appellant in whole of his career.
- 3. That by dint of hard work and dedication to duty, the appellant on the recommendations of the Departmental Selection Committee was promoted as Kanungo (BPS-11) vide order dated 09.11.2016 by Deputy Commissioner Mardan. Copy of the promotion order is attached as annexure-B.

Tariq Ali appeared at S.NO.6. Copy of the seniority list is attached as annexure-D

- 6. That under rule-9 of the Civil Servants (Appointment, Promotion and Transfer Rules, 1989) where the appointing authority considered it to be in public interest to fill a post reserved under the rules for departmental promotion and the most senior civil servant belonging to the cadre or service concerned, who is otherwise eligible for promotion, does not possess the specified length of service the authority may appoint him to that post on acting charge basis. Copy of the rue-9 of the APT Rules, 1989 is attached as annexure-E.
- 7. That the honorable Senior Member Board of Revenue ignoring the above quoted rules has promoted the junior of the appellant which is absolutely illegal and against the rights of the appellant. Copy of the promotion order is attached as annexure-F.

It is, therefore, requested that prayer sought for in the heading of the appeal may kindly be allowed in favor of the appellant and oblige.

CHAPER - II

Statutory provision regarding Appointment.

Section 5 of Civil Servants Act, 1973 - Appointment to a civil service of the Province or to a civil post in connection with the affairs of the Province shall be made in the prescribed manner by the Governor or by a person authorised by the Governor in that behalf.

Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989

No. SOR-I (S&GAD) 4-1/80, dated 31st January, 1989.---In exercise of the powers conferred by section 26 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act XVIII of 1973) the Governor of the Khyber Pakhtunkhwa is pleased to make the following rules, namely:-

PART-I GENERAL

1. Short title and commencement.---(1) These rules may be called the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules,1989.

¹[(5) If on an order of promotion or before promotion any civil servant declines in writing, to accept promotion, such civil servant shall not be considered for such promotion for the next four years following the order:

Provided that if he declines to avail the benefit of promotion for the second time, then he shall stand superseded permanently for such promotion.]

8. Inter-Provincial Transfer.---(1) Persons holding appointment in BPS 1 to 15 under Federal Government and other Provincial Government may, in deserving cases, be transferred to equivalent posts under these rules:--

Provided that:-

- the Federal Government or the Government of the Province concerned, as the case may be, has no objection to such a transfer;
- (ii) the person seeking transfer possesses the requisite qualification and experience and the post to which his transfer is intended can,' under the rules, be filled by transfer;
- (iii) the person concerned holds appointment to the post in his parent Department on regular basis;
- (iv) the person concerned is a bonafide resident of the Khyber Pakhtunkhwa;
- a vacancy exists to accommodate the request of such a transfer;
 and
- (vi) provided further that in most deserving cases, the merit of which shall be determined on case to case basis and the decision of the Competent Authority in that behalf shall be final, Government may allow transfer of a civil servant in BPS-16 and above, subject to the aforesaid conditions.
- (2) A person so transferred shall be placed at the bottom of the cadre strength which he joins for the purposes of determining his seniority vis-a-viz other members borne on the cadre.
- (3) It will be the sole discretion of the appointing authority to accept or refuse a request of transfer under this rule and any decision made in this behalf shall be final and shall not be quoted as precedence in any other case.
- 9. Appointment on Acting Charge or current Charge Basis.—
 (1) Where the appointing authority considered it to be in the public interest to fill a post reserved under the rules for departmental promotion and the most senior civil servant belonging to the cadre or service concerned, who is otherwise eligible for

promotion, does not possess the specified length of service the authority may appoint him to that post on acting charge basis ¹[:

Provided that no such appointment shall be made, if the prescribed length of service is short by more than ²{three years}.]

- (3) In the case of a post in Basic Pay Scale 17 and above, reserved under the rules to be filled in by initial recruitment, where the appointing authority is satisfied that no suitable officer drawing pay in the basic pay scale in which the post exists is available in that category to fill the post and it is expedient to fill the post, it may appoint to that post on acting charge basis the most senior officer otherwise eligible for promotion in the organisation, cadre or service, as the case may be, in excess of the promotion quota.
- (4) Acting charge appointment shall be made against posts which are likely to fall vacant for period of six months or more. Against vacancies occurring for less than six months, current charge appointment may be made according to the orders issued from time to time.
- (5) Appointment on acting charge basis shall be made on the recommendations of the Departmental Promotion Committee or the Provincial Selection Board, as the case may be.
- (6) Acting charge appointment shall not confer any vested right for regular promotion to the post held on acting charge basis.

PART-III INITIAL APPOINTMENT

- **10. Appointment by Initial Recruitment**——(1) Initial appointment to posts *[in various pay scales] shall be made—
 - (a) if the post falls within the purview of the Commission, on the basis of Examination or test to be conducted by the Commission; or
 - (b) if the post does not fall within the purview of the Commission, in the manner as may be determined by Government.
