JUDGMENT

NIAZ MUIHAMMAD KHAN, CHAIRMAN.- Arguments of the learned  
counsel for the parties heard and record perused.

FACTS

2. The appellant has approached this Tribunal through the present service  
appeal claiming that he is employee of the Education Department. In this respect he  
has relied upon his appointment letter and also copies of some attendance registers.

He has also alleged that he filed departmental appeal which was not replied to. His prayer is that his pay has been stopped by the department without any reason.

3. On the other hand the department in their comments has straight away denied the issuance of appointment letter of the appellant.

### ARGUMENTS.

4. The learned counsel for the appellant argued that the appellant is the employee of the department and that the appointment letter is genuine. He further argued that the copies of the attendance registers produced by the appellants are also genuine and he further added that the appellant did file departmental appeal before the departmental appellate authority but that was not responded to.

5. On the other hand, the learned District Attorney argued that this Tribunal lacks the jurisdiction for the reason that there is no original or appellate order. He further added that the appellant is not the employee of the department and this Tribunal cannot assume the jurisdiction.


### CONCLUSION.

6. This Tribunal in circumstances is not in a position to decide whether the appointment letter and attendance registers relied upon by the appellant are genuine or forged. It is not known whether the higher authority took some notice of alleged fake and forged appointment letter and attendance registers.

7. The arguments of the learned Addl. Advocate General that this Tribunal cannot pass any order due to lack of jurisdiction as no original or appellate order worth reliance is produced by the appellant. The arguments of the learned

Additional AG are in accordance with law but this Tribunal before deciding its jurisdiction is to see whether the documents produced by the appellants are genuine or not and if genuine then, of course, stoppage of salary of the appellant would be an original order though not in written form. This Tribunal therefore, deems it necessary in peculiar circumstances of appeal that before taking jurisdiction in the matter let the departmental appellate authority give its verdict regarding the whole affair including the genuineness or otherwise of the documents relied upon by the appellant. Since some factual controversies are involved before assuming jurisdiction, it would be in the fitness of things that the departmental appellate authority should be given a chance to probe into the matter through an enquiry and then to pass appropriate speaking order. The departmental appellate authority is directed to dispose of the departmental appeal within a period of 3 months from the date of receipt of this judgment. The result of the departmental appeal should also be communicated to the appellant.

8. In view of the above, this appeal is disposed of in the above terms. Parties are left to bear their own costs. File be consigned to the record room.

Consequent upon the recommendation of the District Departmental Selection Committee, (DDSC) **Mr. Munawar S/o** Bahadar Shah is hereby appointed as Chowkidar at GGHS Pabbi No. 3 Nowshera in BPS-01 plus usual allowances as admissible under the rule on regular basis with immediate effect in the interest of public service under the terms and conditions given below.

Terms & Conditions

1. The appointee will get initial scale including usual allowances as admissible under the rules. He/She is entitled for annual increment after completion of one year service; however will not eligible for pension and gratuity as per current policy of the Govt. of NWFP.
2. The Deputy District Officer Elem: & Secy: Edu: Nowshera must obtain surety bond as well as agreement bond executed by each Employee to obey policy of the govt. of NWFP Act 2005 and will not have the right to challenge the existing policy in any court of law.
3. His/Her service is liable to be terminated on one month's prior notice, from either side. In case of resignation without prior notice one month pay and allowances, if any shall be forfeited in favours of Govt. through challan.
4. Contribution of CP Fund will be made as per rules and regulations of Govt. of NWFP.
5. The appointee should join their post within 15 days of the issuance of this order positively otherwise the appointment shall stand cancelled.
6. His/Her service can be terminate at any time, in case his/her performance is found unsatisfactory and will be removed from service under (Special Powers) Ordinance, 2000 and the rules frame from time to time.

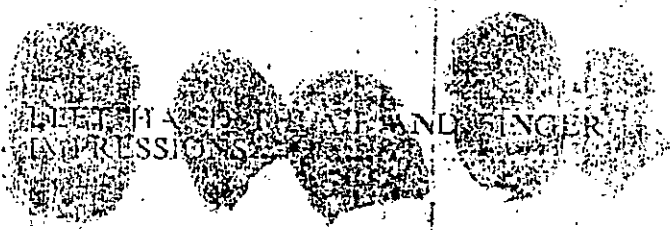



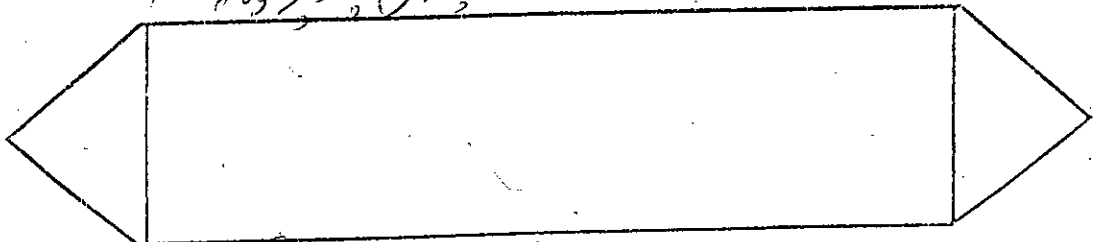

**Preliminary Objections**

1. That the appellant has no cause of action / locus standi to file the instant appeal.
2. That this Honorable Service Tribunal has got no jurisdiction to entertain the present appeal.
3. That the present Appeal is bad for non-joinder of necessary parties and mis joinder of un-necessary parties.
4. That the instant appeal is badly time barred.
5. That the appellant has concealed material facts from this Honorable Service Tribunal.
6. That the appellant is estopped by his own conduct, by deed and by law to file the instant appeal.
7. That the instant appeal is not maintainable in its present form.

**Factual objection**

1. Incorrect. The appellant was not appointed as Chowkidar in BPS-1 as GGHS No.3 Pabbi Nowshera. The appellant joined the Education Department through a fake / bogus order vide No.506-11, dated 9/8/2009 and take over the charge on 9/8/2010 at GGPS No.3 Pabbi.
2. Incorrect. The appellant was shown as appointed as Chowkidar on 9/8/2009 in GGHS No.3 Pabbi, but he took over charge at GGPS No.3 Pabbi on 9/8/2010 i-e almost one year after his appointment. In GGPS No.3 Pabbi the appellant was neither appointed nor was Chowkidar post exist there. Moreover, all the entries in the attendance register have been made with the same pen and on the same handwriting on the same day, thereby meaning that the said entries are after thought to show that he has taken over charge of his appointment because the Head Mistress of GGPS No.3 Pabbi was his real sister and also was Center Incharge of the Circle named Nusrat Shah (PST). (Enquiry Report is annexure-A).
3. Incorrect. The appellant was neither appointed in GGPS No.3 Pabbi nor assumed the charge of his post in the stipulated period. The appellant neither performed duty nor claimed salaries till 1/1/2015.
4. Incorrect. The appellant neither performed duty nor given application for release of salaries.

5. Incorrect. The appellant is not a Civil Servant therefore his departmental appeal was also not maintainable.

**Grounds**

- A. Incorrect. Without performing duty the appellant is not entitled for the salaries/pay.
- B. Incorrect. The appellant never performed duty.
- C. Incorrect. As replied above.
- D. Incorrect. As replied in ground A and B.
- E. The respondent may also be permitted to advance other arguments at the time of hearing.


It is therefore, requested before your honor that the present appeal is against facts and without force, may kindly be dismissed with cost.

INQUIRY REPORT REGARDING FAKE APPOINTMENT OF CLASS-IV OF  
GGPS PABBI NO. 3

MR MUNAWAR SHAH

**ALLEGATION: FAKE APPOINTMENT**

**FINDINGS**

1-The chowkidar Mr. Munawwar Shah was given a chance to orally explain the matter and he has also been given a Questionnaire referred to as (Annexure 01)

2-The Headmistress in chair was also given questionnaire and she responded for the same (in annexure 2) she has replied that Mr. Munawwar Shah was appointed on 09-08-2009 and the headmistress in chair says that his attendance started with her since 09-08-2010, the missing attendance does not exist.

3-The Ex head teacher was given Questionnaire .she was asked that Mr.Munawwar Shah's appointment order was issued 08-09-2009, but he had taken charge on 03-09-2009. what was the reason of taking charge too late.

Secondly she was asked that why his attendance was not marked in the attendance register

Thirdly the same ex headmistress was asked that why did she commit the blunder that Mr. Munawar Shah was appointed at GGHS. No-3 printed on appointment order which does not exist in Elementary & Secondary Education Department K.P.K at all. Above all why did she give him charge in GGPS No .3 Pabbi and even after the tenure of six years, no corrigendum was provided for rectifying the same blunder.

Her stunning answer was that she mistakenly did not take his attendance of one year which was very shocking, <sup>surprising</sup> and unnatural (Annexure 03)

4- The center incharge Miss Nusrat Shah ,the sister of Munawar Shah was also contacted to verify the ambiguous status of charge report of Mr Munawar Shah yet she also could not give any satisfactory answer.(Annexure 04)

5-I asked for the provision of August 2009 appointment order from the concerned clerk of SDEO Office .I was stunned to see that the same time period appointment order runs as office of the EDO while the appointment order of Mr.Munawar Shah follows as office of the DEO which creates contradiction (Annexure 05)

6-As the order was issued on the basis of GGHS Pabbi No-3, the claimant was not receiving any salary ,it is presumed that he would have gone to

Account office ,if so ,he should have been informed that he does not deserve any salary because the school did not exist at all.

The claimant /plaintiff possesses no written proof of his proceeding for the issue of his salary .It also seems a bit unnatural to carry on ones service without any incentive for round about seven years.

7-Besides ,the very controversial appointment order was sent for verification to the ex EDO Elementary and Secondary Education Department Mr. Inhanuddin who rejects any claim of the claimant and terms the appointment order as purely fake on the following ground.(Annexure 06)

S. Waiting for two days, Primary School head teacher failed to provide systematic attendance record of Mr. Munawar Shah chowkidar.

The root cause of the conduction of inquiry on behalf of chowkidar Munawar Shah was his alleged fake appointment order. The very statement of Mr. Inhanuddin (the copy attached here worth) negates all. Purity on the status of the concerned appointment order and terms it purely fake.


The ground reality provided by Mr.Inhanuddin Ex- EDO Elementary &Secondary Department are extremely solid which certifies that the appointment order was fake and thus winds up the inquiry procedure.

**Recommendation.**

So for Ex EDO statement is concerned negates the genuine status of the appointment order of Mr.Munawar Shah .

Therefore the rules and regulation regarding any fake appointment finding, may kindly be applied in the light of aforementioned statement of ex EDO Elementary and Secondary Education Department Mr.Inhanuddin.

Note: When the Ex-EDO Elementary and Secondary Education was referred for the verification of the alleged fake appointment order of Mr.Munwar Shah, he insisted that his provided verification statement (Annexure 06) must be included as written document to proceed the inquiry procedure

This is in reference with your office memo No. 1 dated 12-04-2016 on the subject cited above.

My Para-wise comments on the subjected letter/Inquiry regarding appointment of Mr. Munawar S/O Bahadar Shah Chowkidar are as under:-

The appointment order of Mr. Munawar Chowkidar s/o Bahadar Shah issued vide Endst No. 506-11 Dated 09-08-2009 is completely fake having the following grounds.

1. GGHS No.3 Pabbi doesn't exist in the Elementary & Secondary Education District Nowshera.
2. The appointee has been reported as Chowkidar at GGPS No.3 Pabbi, while the appointment order shows GGHS No.3 Pabbi.
3. The order in-question has not been referred for re-verification to the undersigned according to the format and terms conditions already under practice during my tenure.
4. The competency (Stick yard) for appointment 01-01-2013 pre & post are EDOs & DEOs respectively throughout the Province, while the order in-question showing the capacity of DEOs as the appointing authority which is not the part of the office at all. Hence, the order in-question itself reflects the fakeness all-round.
5. District Education Officer, (Male & Female) throughout Khyber Pakhtunkhwa have been declared as appointing authority (Competent) in the newly setup with effect from 01-01-2013 onward according to policy implemented.
6. The title of the office order District Education Officer, (Male) Nowshera did not exist during my tenure which also strengthen the fakeness of the said order.
7. The said fake order has been issued on 09-08-2009; while the calendar year shows 09-08-2009 as Sunday which is not the working day as the offices remain closed according to the policy.

The above mentioned facts are clearly visible proof that the order in-question is fake and in this regard I suggest and recommend that:-

- a) That the Head Mistress or Head Teacher concerned should be handed over to police for strict disciplinary action because why the Chowkidar has been handed over the charge blindly.
- b) The facilitator/middle man may also be traced out for further verification in order to discourage such like fake practices.
- c) The inquiry officer mistakenly has recorded GGPS No.3 Pabbi instead of GGHS No.3 Pabbi.
