
- i. The selected candidates shall undergo and successfully complete the training at the Pakistan Forest Institute leading to Master's Degree in Forestry. Those already-having Master's Degree in Forestry form PFI shall be exempted from such training.
- ii. The selected candidates shall produce certificate from the standing Medical Board at Peshawar regarding their physical and mental fitness for performing the duties required of them.
- iii. The selected candidates shall execute a bond with the Forest Department to the effect that on successful completion of the training they shall serve the Government for at least five years and in default shall refund all the expenses incurred in connection with their training and education.
