DISSENTING JUDGMENT.

AHMAD HASSAN, MEMBER.- I would like to record my dissent on the
following grounds:

1. It is not disputed that though the appellant figured low on the merit list firmed up by NTS was appointed as PST vide order dated 25.09.2014 and started performing duty. On finding discrepancies in the appointment order, it was unilaterally withdrawn on 29.09.2014. Attention is invited to para-6 of the terms and conditions of appointment that their services will be liable to be terminated on one month from either side. No such notice was given by the respondents before terminating her services. She deserved to be offered an opportunity of hearing/showing cause. In the given circumstances, the appellant was condemned

unheard. Article-10-A, right of fair trial is now a fundamental, constitutional right belonging to every citizen of Pakistan. On the strength of numerous judgments of the superior courts, ^{that} even before terminating of services of probationer opportunity of hearing should be provided.

2. The impugned order dated 29.9.2014 was not passed in accordance with law and rules, so the same was void and no limitation runs against a void order. As the appellant has a very strong case on merit, so it would be appropriate not to non-suit her on technicalities.

3. The departmental appeal was not decided by the respondents within the given time frame. In the interest of justice and fair play, it would be appropriate to remand this case back to the respondents to decide the departmental appeal within a period of sixty days.

DISSENTING JUDGMENT

MUHAMMAD AMIN KHAN KUNDI, MEMBER: - Counsel for the appellant present. Mr. Riaz Ahmad Paindakhel, Assistant Advocate General for official respondents No. 1, 2 & 4 present. Private respondent No. 3 has already been proceeded ex-parte vide order sheet dated 21.12.2015. Arguments heard and record perused.

2. Brief facts of the case as per present service appeal are that the appellant was appointed as Primary School Teacher in Education Department vide order dated 25.09.2014. Later on the aforesaid appointment order of the appellant was withdrawn and private respondent No. 3 namely Mst. Nabeela Murad name was

inserted/included by the competent authority on the ground that Mst. Nabeela Murad private respondent No. 3 having total scores of 109.01 while the appellant having total scores 107.65 for the PST post vide order dated 29.09.2014. Feeling aggrieved from the impugned order dated 29.09.2014 the appellant filed departmental appeal on 30.09.2014 which was not responded hence, the present service appeal on 19.02.2015.

3. Respondents were summoned who contested the appeal by filing of written reply/comments.

4. Learned counsel for the appellant contended that the appellant was appointed as Primary School Teacher in Education Department by the competent authority vide order dated 25.09.2014. It was further contended that just after four days the name of private respondent No. 3 Mst. Nabeela Murad was included in the appointment order instead of the name of the appellant for the reason that Mst. Nabeela Murad private respondent No. 3 having total scores of 109.01 while the appellant having total scores 107.65 for the PST post vide order dated 29.09.2014. It was further contended that feeling aggrieved from the aforesaid order dated 29.09.2014, the appellant filed departmental appeal on 30.09.2019 but the same was not decided. It was further contended that since in the appointment order it was mentioned that the appointment of the appellant was on temporary and contract basis initially for one year therefore, the appellant approached the worthy High Court through writ petition for setting-aside the impugned order dated 29.09.2014 but the worthy Peshawar High Court, Peshawar dismissed the writ petition of the petitioner/appellant and she was directed to approach the competent forum for redressal of her grievances vide order dated 23.12.2014 therefore, the appellant filed present service appeal on 19.02.2015. It was further contended that neither any show-cause notice was issued to the appellant nor proper inquiry was conducted and

the appellant was condemned unheard therefore, the impugned order is illegal and liable to be set-aside.

5. On the other hand, learned Assistant Advocate General for the respondents opposed the contention of learned counsel for the appellant and contended that initially the name of the appellant was mistakenly shown in the appointment order dated 25.09.2014 but later on, on examination of the merit list and other record it came to the notice of the respondent-department that private respondent No. 3 Mst. Nabeela Murad had obtained 109.1 score while the appellant had obtained 107.65 score in the merit list therefore, the respondent-department has rightly passed the impugned order dated 29.09.2014 regarding the inclusion/insertion of the name of private respondent No. 3 Mst. Nabeela Murad instead of the appellant. It was further contended that the appointment order dated 25.09.2014 of the appellant also reveals that he was appointed on contract basis therefore, this court has got no jurisdiction to entertain the present appeal. It was further contended that the appellant has filed departmental appeal on 30.09.2014 against the impugned order and the appellant was required to file service appeal within one month after waiting for statutory period of 90 days but the appellant has filed the present service appeal on 19.02.2015 after a delay of more than four months and fifteen days therefore, it was contended that the service appeal is badly time barred. It was further contended that the appellant has also not filed any application for condonation of delay therefore, prayed for dismissal of appeal.

6. Perusal of the record reveals that the appointment order of the appellant was issued on 25.09.2014 by the competent authority. However, later on after examining the relevant record, respondent-department issued order dated 29.09.2014 whereby the name of private respondent No. 3 Mst. Nabeela Murad having total score of 109.1 was included/replaced instead of the appellant Mst. Shaista Akhtar having total score of 107.65 Feeling aggrieved from the

aforesaid order the appellant filed departmental appeal on 30.09.2014 but the same was not responded therefore, the appellant was required to file service appeal within one month after waiting for 90 days for departmental authority decision but she has filed the present service appeal on 19.02.2015 after a delay of more than four months and fifteen days. Moreover, the appellant has also not filed any application for condonation of delay. As such, the present service appeal is badly time barred therefore, without touching the merit of the case the present service appeal is dismissed being time barred. Parties are left to bear their own costs. File be consigned to the record room.

PRAYER:- On acceptance of the instant appeal the corrigendum dated 29.9.2014 may very kindly be adjudicated null and void and of no legal effect and the appellant may very kindly be re-instated in service.

Respectfully Sheweth:

Brief facts of the case are as under :-

1. That applications for P.S.T teachers were sought by respondent No.1 through various advertisements in different Newspapers for female teachers, being a competent candidate for the aforesaid post the appellant also applied for the said post.
(Copy of advertisement is annexure A).
2. That the tests for the aforesaid vacant post was conducted by N.T.S Pakistan who issued Roll number slip to the appellant. (Copy of Roll slip is annexure B).
3. That after the test the N.T.S issued result of the test in which the appellant succeeded it, and achieved good marks. (Copy of result is annexure C).
4. That therefore the appellant was called for interview by the respondent No.1 and therefore list of successful candidate was issued in

which the appellant was placed on serial No.11.

(List of successful candidate is annexure D).

5. That on 25.9.2014 appointment letter was issued to the appellant whereafter the appellant assumed charge and started rendering her duties.

(Copy of appointment letter is annexure E).

6. That on 29.9.2014 a corrigendum was issued by the respondent No.1 according to which the appellant was removed from service and was replaced by respondent No.3. Copy of

(corrigendum is annexure F).

7. That aggrieved from the aforesaid corrigendum the appellant moved the departmental appeal ~~to~~ respondent No.1 who unfortunately did not played heed to the appeal.

(Copy of departmental appeal is annexure G).

8. That the appellant filed writ petition before the Peshawar High court, Peshawar which was also dismissed and direction to the appellant to approach the competent court for redressal of her grievance in accordance with law, if so advised.

(Copy of writ petition and order dated 23.12.2014 are annexure H).

9. That now the appellant approaches this Hon'able Tribunal on the following grounds amongst other inter-alia :-

GROUNDS:

- A. That the aforesaid corrigendum is illegal unlawful and of no legal effect.
- B. That application for the aforesaid post were sought on the basis of residence of Union councils, It is pertinent to mention here that the appellant is resident of Union council Sarki and the respondent No.3 has got married from Sarki to Rajar which is an different union council and respondent No.3 does not have concerned with Union council tetara, therefore she can not be appointed in Union council Tetara.
- C. That the appellant has neither been given any notice a head of issuance of corrigendum fax nor has been given opportunity of personal hearing.
- D. That in case in hand the appellant had assumed the charge and she was serving her duties properly therefore for her removal proper causes was supposed to have been adopted by respondent No.1 which she did not bother to do so.
- E. That malafide on the part of respondent No.3

come to the surface but she has tried to posed herself residences of both Union councils, and at the end the feasible one was preferred by her.

F. That additional grounds will be raised at the time of argument.

It is therefore most humbly prayed that on acceptance of the instant appeal, corrigendum dated 29.9.2014 may very kindly be adjudicated null and void and of no legal effect and the appellant may very kindly be re-instated in service.



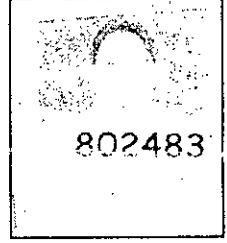

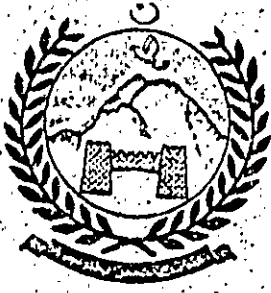

1. NO TA/DA etc is allowed.
2. Charge reports should be submitted to all concerned in duplicate.

9. Health and Age Certificate should be produced from the Medical Superintendent concerned before taking over charge.
10. They will be governed by such rules and regulations as may be issued from time to time by the Govt.
11. Their services shall be terminated at any time, in case their performance is found unsatisfactory during their contract period. In case of misconduct, they shall be proceeded under the rules framed from time to time.
12. Their appointments are made on School based, they will have to serve at the place of posting, and their service is not transferable to any other station.
13. Before handing over charge once again their documents may be checked if they have not the required relevant qualifications as per rules or they do not belong to the Union Council, in which they have been appointed, they may not be handed over charge of the post.

- 1.** Para-No.1 pertain to the record.
- 2.** Para-No.2 pertains to the record, but the appellant having low score before the selected candidates.
- 3.** Para No.3 as Para No.1.
- 4.** That as per merit list "Annexed with the appeal on page **No.13** the appellant at S.No.11 having score 107.65 while the respondent No.3 at S.No.7 on the merit list and having score 109.1 which is too low score as compared to the selected candidates.
- 5.** That the respondent department issued the appointment orders after considering rules regulation policy and merit, the appeal of Mst: Nabila Murad was accepted for U/Council Sarki Titara, earlier

she was dropped, she appealed that she belong to the U/Council Sarki Titara and had wrongly been shown as out U/Council, her particular were sent to AD Local Government for U/Council verification, Mst: Shaista Akhtar was at the bottom in U/Council Sarki Titara, Resultantly she was dropped (**read the Minutes of the appointment orders H**) (**Copy of domicile and statement of Secretary U/Council Annexed A**).

SUBJECT: MINUTES OF THE DEPARTMENTAL SELECTION COMMITTEE MEETING HELD ON 20-08-2014 IN THE OFFICE OF THE DISTRICT EDUCATION OFFICER (F) CHARASADA FOR THE SELECTION OF SUITABLE CANDIDATES FOR THE APPOINTMENT OF FEMALE PRIMARY SCHOOL TEACHERS (PSTs) IN GOVERNMENT GIRLS PRIMARY SCHOOLS OF DISTRICT CHARASADA ON ADHOC SCHOOL BASED POLICY

1: A meeting of the Departmental Selection Committee was held on 20-08-2014 at 10.00 AM in the Office of the DEO (Female) Charsada for the selection of Union Council wise suitable candidates who had passed the NTS test, for the appointment of female Primary School Teachers (PSTs) in Government Girls Primary Schools of District Charsada on Adhoc school based policy.

3. The meeting started with the recitation from the Holy Quran. The Chair welcomed the participants.

4. The Chairperson apprised the committee of the steps taken for transparent U.C. wise appointment of the PST candidates purely on merit. She told the committee that;

(a) When she took over the charge of the DEO (F) Charsada the appointment process of the PST candidates was already in progress. The Tentative merit lists had already been displayed. She immediately, constituted two committees of the SDEOs (F) and ASDEOs (F) of the Sub Divisions concerned for the scrutiny and checking of the merit lists prepared by the NTS authorities with the documents of the candidates. They were also asked to prepare UC wise merit lists and point out the Out UC candidates.

(b) Both the committees worked hard. Some mistakes were found in the NTS lists. Necessary corrections were made in the merit lists in this regard.

...the name of every candidate. A fair time of 15 days was provided to the candidates for the submission of appeals/objections on the final merit lists. The specified time for the submission of appeals/objections was also given out in the print media in the large public interest.

- (a) Total Twenty six (26) appeals were received to the office. She constituted the Appellate committee for the redressal of the grievances of the candidates. The committee held its meeting on 09-08-2014 and decided all the appeals on merit.
- (e) To ensure transparency in the appointments, the candidates were asked to provide residential certificates of their respective Union Councils from the secretaries concerned.
- (f) These U.C certificates were sent to the Assistant Director Local Government & Rural Development Charsada for verification vide this office letters Endst; No. 578 dated 05-08-2014 and 697-705 dated 15-08-2014.
- (g) The cooperation of the Assistant Director Local Government & Rural Development Charsada is praise worthy. He extended full cooperation and verified all the certificates within short time and returned to this office at the earliest vide his office letters No. AD/LGRD/(CHD)/Verification/2003 Dated Charsada the 11th Aug, 2014, No. AD/LGRD/(CHD)/Verification/2011-2013 Dated Charsada the 19th Aug, 2014 and No. AD/LGRD/(CHD)/Verification/2014-16 Dated Charsada the 19th Aug, 2014. The UC certificate of MstBibi Zainab D/O Fazle Akbar of UC Utmanzai had been sent verification to the office of the Assistant Director Local Govt & Rural Development.
- (h) The appeal of Mst Nabila Murad was accepted for UC Sarki Tetara. Earlier, she was dropped. Then she appealed that she belonged to UC Sarki Tetara and had wrongly been shown as out UC. Her particulars were sent to AD local government for UC verification. Mst Shaista Akhtar was at the bottom in UC Sarki Tetara, resultantly she was dropped.
- (i) Mst Sumaira Gulzar UC Turangzae was dropped after deduction of wrong entry of MA previous marks in NTS merit list. The appeal of Mst Deeba Gul was accepted for UC Turangzai after providing and verification of UC certificate and Mst Fouzia Zardad who was at the bottom in UC Turangzai was dropped.
- (j) The appeal of Mst Farzana Begum D/O Munir Gul CNIC No, 17102-3703278-2, R/O Naseer Khan Killi, Jandi Pull Hisara Nehri, P/O Tangi Tehs; Tangi, Distt Charsada was accepted for UC Gandheri as the Assistant Director Local Govt & Rural Development Charsada had verified her UC Certificate and hence Mst Sawera D/O Majid Ullah CNIC No 17102-3186225-6 was dropped due to lower position in the merit.
- (k) Total 65 PST (F) posts had been advertised in which, 35 posts were vacant in Sub Division Charsada and 30 posts in the Sub Division Tangi. The U.C wise and School wise number of vacant posts of both the Sub Divisions are as under;


