CALLED BASELESS ALLEGATIONS, ON BASELESS ADMINISTRATIVE GROUNDS VIDE IMPUGNED TRANSFERRED ORDERS DATED 26/05/2022 AND 17/11/2022 WHICH ARE PERVERSE, ILLEGAL, AGAINST THE LAW AND THE SAME ARE LIABLE TO BE SET ASIDE.

**PRAYER:** ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, IMPUGNED POSTING/ ADJUSTMENT ORDERS DATED 26/05/2022 AND 17/11/2022 MAY GRACIOUSLY BE SET ASIDE AND ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEM FIT AND PROPER IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE GRANTED TO THE APPELLANT.

Respectfully Sheweth,

That the facts forming the background of the instant service appeal are arrayed as under;-

1. That the appellant is disable person in got appointment against the disable quota in the

respondent department and presently serving as SST General.

That during the service period, the appellant was posted from GPS Bhutri to GPS Akhoon Bandi vide order dated 28/08/2014 in thereafter, another corrigendum order was issued and the appellant was posted from GPS Akhoon Bandi to Chak Mohri Haripur. Copy of relevant posting orders are attached as Annexure "A".

That appellant on promotion from SPST to PSHT was posted from GPS Chak Mohri to GPS Neelan Bhutto vide order dated 20/11/2014 as the post of PSHT was lying vacant and GPS Chak Mohri thereafter, the appellant was posted from GPS Neelan Bhutto to GPS Nikkah Pah vide order Endorsement No. 2426 dated 07/01/2015 which was again cancelled vide corrigendum of even number and date. Copy of posting order from GPS Neelan Bhutto to GPS Nikkah Pah and corrigendum cancellation order are attached as Annexure "B" & "C".

That the appellant challenged the order No. 2426 dated 07/01/2015 before the Honourable Tribunal which was accepted vide service appeal No. 354/2015 and during the pendency of service appeal, respondent department posted the petitioner from GPS Neclan Bhutto to GPS Nikkah Pah vide order No. 2915-18 dated 14/11/2015. Copy of order of service tribunal dated 20/05/2015 and order dated 14/11/2015 are attached as Annexure "D" & "I".

That thereafter, the appellant was appointed as SST General against 02% disable quota and was adjusted in GHS Dhartian vide order dated 15/02/2016. The appellant was transfer from GHS Dhartian to GMS Gharan Tehsil Ghazi vide order dated 06/09/2018 but again was posted without the completion of service tenure from GMS Gharan to GHSS Sarai Salah and the same order was cancelled and again posted from GMS Gharan to GMS Kalali vide order dated 21/05/2022. Copies of orders dated 06/09/2018, 13/11/2018 and 21/05/2019 are attached as Annexure "F", "G" &

That as usual, the appellant has once again been made escape goat and has been posted from Kalali to GHS Jhamra so called baseless allegation of socalled unlawful immoral activities SSC examination 2022 vide impugned adjustment order dated 26/05/2022 in first phase of transfer. Copy of order dated 26/05/2022 is annexed as Annexure "I".

That during the pendency of appellant's service appeal No. 1396 of 2022 the respondent department once again posted the appellant from GHSS Jhamra to GMS Kala Khata vide impugned adjustment order dated 17/11/2022, wherein, the service appeal of the petitioner was fixed for preliminary hearing therefore, vide order dated 18.11.2022 the service appeal was declared infractuous hence, impugned adjustment order dated 17.11.2022 is assailed before this tribunal because order is perverse, discriminatory, against the law and same is liable to be set-aside. Copy of impugned transfer order dated 17/11/2022 is attached as Annexure "J" and order of Service Appeal No.1396-A/2022 is annexed as Annexure "K".

Feeling aggrieved, appellant filed departmental appeal to respondent No. 2 on 27/05/2022 and 14/12/2022 but the said respondent did not bather to call the appellant. Copies of departmental appeals are attached as Annexure "L" & "M" respectively. Hence, the instant service appeal is filed inter-alia on the following grounds;-

#### **GROUNDS:-**

- That the appellant is permanent disable and has been declared as such by the medical authority, in this regard, disability certificate dated 24/07/2013 is attached as Annexure "N". It is further submitted that the appellant is unable to travel in the school situated in far flung area from the place of his aboard. Hence, the impugned transfer orders dated 26/05/2022 & 17.11,2022 are liable to be cancelled.
  - That the appellant has not committed any unlawful, immoral activity, BISE SSC Exam 2022. Besides, the impugned transferred

order dated 26/05/2022 of the appellant is political motivated and the appellant has illegally been transferred from GHS Kalali to GHS Jhamra Tehsil Ghazi District Haripur as the appellant has not completed his service tenure. It is evident from the conduct of the respondents that during the tenure of service, the appellant was frequently transferred from once to another prior to the completion of service tenure. Frequent transfer has been declared by the Apex Court as malafide on the part of the respondent department.

That the allegation leveled in the impugned posting/ adjusted order dated 26/05/2022 is illegal, against the norms of service rules. It is a sorrow state of affairs, that respondents department leveled allegation of immoral and unlawful activity against the appellant without any proof which has fully tarnished the character of the appellant as a Govt. Teacher. Interestingly no reason of transfer was mentioned in posting/adjustment order of dated 17.11.2022.

c)

That the appellant as mentioned above is a disable person and has been posted in far flung area which is hundred mile away from the place of his residence. It is further submitted that the appellant is suffering from mental as well as physical pain while traveling in the far flung area.

That the appellant has not committed any fault and committed no immoral are illegal activity BISE SSC Exam 2022. The allegation is so called is based on surmises, conjectures and hypothesis.

That the appellant is a poor disable employee of the department and in the past as well as now has been/ is made a rolling stone and is posted prematurely just to accommodate other blue eyed. That the administration of respondent No. 3 has personal grudges towards the appellant and is being posted/ adjusted illegally with malafide intentions and the impugned posting/ adjusted order dated 26/05/2022 and 17/11/2022 are liable to be set aside.


